### *Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Emmaus Homes 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

## NOTES TO FINANCIAL STATEMENTS

June 30, 2025 And 2024

### 1. Description Of The Plan

The following description of Emmaus Homes 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established July 1, 2005, by Emmaus Homes, Inc. (Employer), and most recently restated effective September 7, 2017. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan's recordkeeper and custodian is Principal Life Insurance Company and Principal Trust Company (collectively, Principal), respectively.

#### **Eligibility**

Employees are eligible to participate in the salary deferral portion of the Plan immediately upon hire. Employees are eligible for Employer contributions upon completion of one year of service, as defined by the Plan Document.

#### **Contributions**

Participants may make elective salary deferral contributions to the Plan subject to Internal Revenue Service (IRS) limitations. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows for participants to designate all or a portion of their elective salary deferral contributions as Roth elective contributions.

The Plan allows for discretionary Employer contributions to be determined by the Employer. The discretionary Employer contributions may be structured as matching contributions or non-elective contributions, as allowed by the Plan. The Employer made discretionary matching contributions equal to 100% of participant contributions not to exceed 3% of eligible compensation for the years ended June 30, 2025 and 2024.

### Notes To Financial Statements (*Continued*)

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer discretionary contributions, and an allocation of Plan earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Participant Vesting**

Participants are vested immediately in their contributions plus earnings thereon. Vesting in Employer contributions is based on years of credited service. The Plan uses a three-year cliff vesting schedule, in which participants are 100% vested after three years, with no partial vesting.

#### **Forfeitures**

Forfeitures of nonvested participant balances are used to pay reasonable administrative expenses and to reduce Employer contributions. Forfeitures available for future use amounted to \$5,879 and \$6,462 as of June 30, 2025 and 2024, respectively. Forfeitures used to pay administrative expenses and fund Employer contributions amounted to \$6,585 and \$10,125 for the years ended June 30, 2025 and 2024, respectively.

#### **Payment Of Benefits**

Upon termination of service, death, disability, or retirement, a participant may elect to receive an amount equal to the vested value of the participant's account in a lump-sum distribution or annuity. Distributions are subject to the applicable provisions of the Plan Document.

#### **In-Service Withdrawals**

Active participants who reach age 59-1/2 or experience a qualifying financial hardship may withdraw all or part of their vested account. Hardship withdrawals will be approved only if they conform to Plan provisions and established Internal Revenue Code (IRC) safe harbor withdrawal provisions.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct the investment of their account in various mutual funds or in a guaranteed investment contract offered through Principal.

#### **Administrative Expenses**

Significant administrative expenses of the Plan may be paid directly by the Employer, if sufficient forfeiture amounts are not available within the Plan. Expenses may also be paid by revenue sharing. Revenue sharing funds of \$5,710 and \$5,866 were used to fund expenses during 2025 and 2024, respectively. Revenue sharing income is included in interest and dividends on the statement of changes in net assets available for benefits.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments, other than the fully benefit-responsive investment contract, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The Plan's investment in the guaranteed investment contract is stated at contract value. Contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (See Note 4).

Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are reflected on a trade-date basis. The net change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized and unrealized gains and losses.

#### Payment Of Benefits

Benefits are recorded when paid.

#### Subsequent Events

Management has evaluated subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### 3. Certified Investment Information

The following is a summary of the Plan's asset information as of June 30, 2025 and 2024, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule of assets held at end of year, that was prepared by or derived from information certified by Principal Trust Company, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal Trust Company that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of June 30:

### **4. Fully Benefit-Responsive Investment Contract**

The Plan invests in the Fixed Income Guaranteed Option, a fully benefit-responsive investment contract (the Contract) with Principal Life Insurance Company, which maintains the contributions in a general account.

As described in Note 2, because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Interest income on the Contract is calculated and credited daily based on fixed interest rates. Interest rates are reset on a semiannual basis. The average crediting interest rate, net of expenses, was 1.58% and 1.62% during 2025 and 2024, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) the decision by the Plan Sponsor to withdraw all assets from the contract and reinvest in another investment vehicle, (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (4) the delivery of any communication to Plan participants designed to influence the participant not to invest in the fund, (5) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement applicable to the Plan. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### 5. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are actively traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invests in certain mutual funds and a guaranteed investment contract managed by Principal Financial Group, an affiliate of Principal. The Plan also pays fees to Principal for various administrative services. These transactions qualify as exempt party in interest transactions.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **8. Income Tax Status**

The Plan uses the Principal Financial Group Prototype Non-Standardized 403(b) Plan, for which a favorable opinion letter was issued to Principal Life Insurance Company by the IRS dated March 31, 2017. The Plan itself has not received a determination letter. The Plan has been amended since the date of this letter; however, the Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

### **9. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
