**Note 1 – Description of the Plan**

The following description of the SEI Group, LLC. 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by the SEI Group, LLC. (the “Plan Sponsor”). Participants should refer to the Summary Plan Description or other Plan documents for a more complete description of the Plan’s provisions.

*General* - The Plan was established on January 1, 2022, as amended from time to time, to cover substantially all employees of the Plan Sponsor. Employees are eligible to participate on monthly entry dates after completing three months of service; excluding employees covered by a collective bargaining agreement and nonresident aliens. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as well as all provisions of the federal income tax laws.

The Plan Administrator and Trustee of the Plan are responsible for oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

Effective February 1, 2024, the Plan was amended to waive the service requirement for employees from a certain division.

*Contributions* - Each year, participants may make tax-deferred contributions to the Plan not to exceed the amount deductible for federal income tax purposes. Participants may also make after-tax (Roth) contributions to the Plan, which are subject to the same rules applicable to tax-deferred contributions. After-tax contributions and tax-deferred contributions are added together to determine whether participants have reached the federal tax law limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor has the option to make flexible discretionary matching contributions to the Plan as determined by the Plan Sponsor. During the year ended December 31, 2024, the Plan Sponsor made a discretionary matching contribution to the Plan totaling \$7,899. Rollovers totaled \$1,093,712 at December 31, 2024. Contributions are subject to Internal Revenue Service (IRS) limitations.

*Participant Accounts* - Each participant’s account is credited with the participant’s tax-deferred contributions and employer contributions (if any), as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are immediately vested in their deferred salary contributions, rollover contributions from other plans and actual earnings thereon. Vesting in the Company’s matching contributions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested upon retirement, permanent disability, death or reaching age 65 while employed by the Company. If a participant separates from the employment of the Company for any other reason, a participant shall be vested based upon the following schedule:

Notes Receivable from Participants - Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Only one loan may be outstanding at any one time. The loans, in the form of promissory notes (Note 2), are secured by the balances in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest on notes receivable from participants are repaid through payroll deductions.

Payment of Benefits - Distributions from the Plan will be made in one lump-sum payment in cash equal to the value of the participant's vested interest in his or her account balance. If a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it may be made. If a participant's vested benefit is less than \$1,000, the participant's benefit is automatically rolled to an individual retirement account.

Forfeited Accounts - Forfeitures are to be used to reduce the employer's contribution to the Plan or to pay administrative expenses incurred by the Plan. During the year ended December 31, 2024, there were no forfeitures used to reduce employer contributions or to pay administrative expenses.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting - The financial statements of the Plan are presented on the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on the Plan's investments bought and sold as well as those held during the year.

**Note 2 – Summary of Significant Accounting Policies (continued)**

Notes Receivable from Participants - Notes receivable from participants (Note 1) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan Sponsor may correct this by distributing the excess contribution or by making a qualified nonelective contribution (QNEC). For the year ended December 31, 2023, the Plan opted to make a QNEC which distributed to the applicable participants in August 2024. For the year ended December 31, 2024, the Plan Sponsor is also required to make an excess contribution or QNEC. The Plan opted to make a QNEC for the year ended December 31, 2024. As of the issuance date of the financial statements, the Plan has made the deposit for 2024.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

During the year ended December 31, 2024, the Plan incurred administrative fees of \$29,306. These charges are reflected in the accompanying statement of changes in net assets available for benefits.

Recent accounting pronouncements - During the year ended December 31, 2024 and through February 13, 2026, there were no new accounting pronouncements issued by the Financial Accounting Standards Board that will need to be adopted by the Plan.

Subsequent events - In preparing the financial statements, the Plan's management has reviewed, as determined necessary by the Plan's management, events that have occurred after December 31, 2024, up until the issuance of the financial statements, which occurred on February 13, 2026.

**Note 3 – Fair Value Measurements**

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

**Level 1** - Valuations based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

**Level 2** - Valuations based on quoted prices in markets that are not active, or financial instruments for which all significant inputs are observable; either directly or indirectly; and

**Level 3** - Valuations based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable: thus, reflecting assumptions about the market participants.

**Note 3 – Fair Value Measurements (continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* consists of a pooled group of mutual funds which are valued daily at their net asset values (NAV). The NAV is used as a practical expedient to estimate fair value. The Plan and participants hold "units of participation" in the separate account.

*Noninterest-bearing cash:* valued at cost, which approximates fair value.

**Note 4 – Related-Party Transactions and Party-In-Interest Transactions**

Nova 401(k) Associates, Inc. was the Plan's third-party administrator and recordkeeper during the year and therefore any transactions with the Plan qualify as party-in-interest transactions.

John Hancock Life Insurance Company (U.S.A.) (JH), the Plan's custodian, provides certain administrative services to the Plan pursuant to a contract between the Plan Sponsor and JH. JH receives revenue from mutual fund service providers for services it provides to the funds. This revenue is used to offset certain amounts owed to JH for its administrative services to the Plan.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

**Note 6 – Federal Income Tax Status**

The Plan, as originally drafted, is a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA. The IRS has determined and informed the Company of the prototype plan by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). However, a determination letter from the Internal Revenue Service has not yet been requested by the Company to determine if the Plan as amended was designed in accordance with applicable sections of the IRC. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and ERISA and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

It is not possible at this time to reasonably estimate the possible loss or range of loss, if any. The Plan further cautions that it is not possible to list such factors, and one should not consider the identified factors as a complete list of all risks and uncertainties.

The delays were unintentional. As of report date, the Plan sponsor has not remitted the lost earnings calculated using the Department of Labor guidelines for late deposits, to the Plan.

**Note 10 – Information Prepared and Certified by Custodian (Unaudited)**

For the years ended December 31, 2024 and 2023, the Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the auditors to not perform any auditing procedures with respect to the information certified by the Custodian of the Plan in 2024, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedules.
