Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Notes 1 and 2 to the accompanying financial statements, those charged with governance of Eagle Engineering & Land Development, Inc. 401 (k) Plan approved a plan of liquidation on November 20, 2023 and management determined liquidation is imminent. As a result, Eagle Engineering & Land Development, Inc. 401 (k) Plan has used the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to this matter.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Eagle Engineering & Land Development, Inc. 401(k) Plan (the “Plan”) provides only general information. The Plan was sponsored by Eagle Engineering & Land Development, Inc. (the Company). Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Company’s corporate offices are located in Naples, Florida.

General - The Plan was established effective January 1, 2023, as a defined contribution plan available to all employees of the Participating employer, other than union and leased employees, non-resident aliens, and interns, who had attained age 18. Eligible employees were able to enter the Plan on the date eligibility criteria was met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Plan Termination – On November 20, 2023 a decision was made to terminate the Plan due to Administrative reasons.

Effective with the Plan’s termination, all participants with an account balance remaining in the Plan became fully vested in all contributions sources, regardless of status or years of vested service. The Plan’s termination also ceased employee and employer contributions into the Plan.

Contributions – Prior to the Plan’s termination, participants could contribute a percentage of their pretax compensation, as defined in the Plan document, as an elective deferral contribution, subject to limitations. Additionally, participants could contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. Eligible participants were able to make a rollover contribution to the Plan.

Participants who were eligible to make salary deferral contributions under the Plan and who had attained age 50 before the close of the year were able to make catch-up contributions in accordance with, and subject to, the limitations imposed by the IRC.

Prior to the Plan’s termination, employer safe harbor matching contributions were made at 100 percent of the participants salary deferrals up to the first 3 percent of the employees covered compensation per pay period subject to the annual salary deferral limitation imposed by the IRS.

All employee and employer contributions were invested in participant directed investments. Participants were able to elect to invest their account balance in any of the various offered mutual fund investments.

Participant Accounts – The Plan maintained a separate account for each participant to which contributions and investment performance were allocated. Each participant’s account was credited with the participant’s contributions and the Company’s matching contribution, as well as allocations of the Company’s profit sharing contribution, if any, and the Plan earnings. All contributions are allocated at the direction of the participant among selected investment funds. Each fund’s investment income or loss, less any investment management fee, is allocated to participants’ accounts based on their proportionate interest in the fund. The value of participant accounts fluctuated with the market value of the securities in which the accounts were invested. Transaction fees charged for participant distributions were allocated directly to that participant’s account. The benefit to which a participant was entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance and have a maximum of one loan outstanding against their account at one time. Interest rates were to be determined by the Plan Administrator. There were no loans outstanding at December 31, 2024 or 2023.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits – On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive or rollover a lump sum amount equal to the value of the participant's vested interest in his or her account. Partial withdrawals were permitted when participants reach the age of 59½, or in the event of financial hardship.

Forfeitures – Prior to the Plan's termination, forfeited balances of terminated participants' non-vested accounts may have been used to offset employer matching contributions and non-elective contributions for the year as well as to pay Plan administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the decision to terminate the Plan effective November 20, 2023, and in accordance with U.S. generally accepted accounting principles ("U.S. GAAP") the Plan's financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024 are presented using the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no material changes to the financial statements as a result of the change under the liquidation basis of accounting. All investments of the Plan are stated at fair value (the estimated net realizable cash value for investments as of December 31, 2024 and 2023 are equivalent to fair value.) Purchases and sales of investments were recorded on a trade-date basis.

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value measurements.

Investment gains and losses are accounted for using the average cost basis of the securities sold. Net appreciation of fair value of investments includes the Plan's gains and losses on investments sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/(depreciation) of the fair value of investments.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024

Mutual Funds - Valued at quoted market prices in an exchange and active market and are classified as Level 1 investments

NOTE 5 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Party in interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or relatives of such persons.

Plan investments are managed by the Trustee and are considered parties-in-interest as well as related parties. All investment transactions with such parties-in-interest qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 6 – TAX STATUS

The Plan adopted a volume submitter plan offered by Human Interest effective January 1, 2023. The volume submitter plan received an advisory letter dated June 30, 2020, that the Plan, and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken.

The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
