Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan Sponsor of Encore Oilfield Services 401(k) Plan approved a plan for liquidation on November 14, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting principles generally accepted in the United States of America to the liquidation basis of accounting used in preparing the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Encore Oilfield Services 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

GENERAL

The Plan was established on January 1, 2012. The Plan is a defined contribution retirement plan covering eligible employees of Encore Oilfield Services, LLC (the “Plan Sponsor” and “the Company”). Employees of the Company are eligible to participate in the Plan on the next entry date after completing six months of service and attainment of age twenty-one (21). Plan entry dates are the first day of each Plan quarter coinciding with or next following the date eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On November 10, 2024, the Company approved the termination of the Plan in favor of enrolling and participating in an established Pooled Employer Plan (“PEP Plan”). Pursuant to the approval of the new PEP Plan, the Company’s participant accounts were fully vested as of the Plan’s termination date. As of the termination date, no additional service benefits were accrued. The transition was finalized on November 14, 2024.

PLAN ADMINISTRATION

The Company appoints the Plan Administrator and Plan Trustees. The Plan Administrator and Plan Trustees are employees of the Company. The Plan’s third-party administrator, Quick(k) 401(k) ePlan Services (“Quick(k)”), performs the Plan’s administrative duties such as preparation of the Form 5500, participant recordkeeping, compliance testing and enrollment.

CONTRIBUTIONS

Prior to the transition to the PEP Plan, participants could elect to contribute pre-tax and Roth post-tax amounts from eligible compensation as defined by the Plan not to exceed the limits of Internal Revenue Service (“IRS”) Code Section 401(k). In addition, participants who had reached age 50 before the close of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company made a safe harbor matching contribution equal to 100% of participant deferrals up to 5% of Plan compensation, which amounted to \$368,698 for 2024. In addition, the Company could have made additional discretionary matching contributions or profit-sharing contributions; however, none were made in 2024.

PARTICIPANT ACCOUNTS

Prior to the transition to the PEP Plan, each participant’s account was credited with the participant’s contribution, the Company safe harbor matching contributions, the Company discretionary matching and profit-sharing contribution, and Plan earnings. Allocations of Plan earnings and administrative expenses were based on participant account balances as defined in the Plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

VESTING

Participants are immediately vested in their elective deferral contributions, rollover contributions, and safe harbor contributions plus actual earnings thereon. Vesting of Company discretionary matching and profit sharing contributions is as follows:

VESTING – CONTINUED

Upon termination of the Plan, participant accounts became fully vested.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Loans bear a reasonable rate of interest as determined by the Plan Document based on prevailing interest rates. Principal and interest is paid ratably through payroll deductions.

PAYMENT OF BENEFITS

Prior to the termination of the Plan, participants were entitled to the benefits that could be provided from their individual account balances, subject to vesting, upon retirement, death, hardship, or termination. If the value of the participant's vested account balance is less than \$5,000 upon termination, the participant will automatically receive a distribution election form and can elect to receive entire balance in the form of a lump sum distribution or qualified rollover; however, if not timely elected the participant account will be transferred to an individual retirement account as specified by the Plan. Should a participant's balance upon termination be below \$1,000, the participant will receive their funds in the form of a lump sum distribution. A participant must be age 59 ½ or have incurred a financial hardship, as defined in Plan provisions, to qualify for an in-service distribution.

FORFEITURES

Prior to the termination of the Plan, forfeitures could be used to reduce employer contributions or pay Plan expenses. For the period ended November 14, 2024, there were no forfeitures.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

Effective November 10, 2024, the Company, as Plan Sponsor, elected to terminate the Plan. Accordingly, the Plan changed its basis of accounting from the accrual basis of accounting for an ongoing plan used in preparing the 2023 financial statements to a liquidation basis of accounting used in preparing the 2024 financial statements, in conformity with accounting principles generally accepted in the United States of America ("GAAP"). This change in the basis of accounting had no material effect on the Plan's financial statements.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. As of November 14, 2024, the Plan had no assets or liabilities. As a result of the termination of the Plan, the Plan's investments were stated at liquidation value as of the termination date, which approximated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the Trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

CONTRIBUTIONS

Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments, and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on terms of the Plan document. No allowance for credit losses has been recorded as of November 14, 2024 and December 31, 2023.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

EXPENSES

The Company, at its sole discretion, may pay the administrative expenses (i.e., trustee fees, fund fees, loan fees, recordkeeping fees and other similar expenses) of the Plan and are excluded from these financial statements. If such expenses are not paid by the Plan Sponsor, they are paid out of plan assets. Investment related expenses are included in net investment appreciation from investments.

TRANSFER TO OTHER PLANS

Transfers to other plans represent participant account balances and outstanding participant loan balances as of the termination of the Plan. These account balances and loan balances were transferred to the new PEP plan on November 14, 2024.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 – FAIR VALUE MEASUREMENTS – CONTINUED

On November 14, 2024, the Plan had fully liquidated all Plan assets and no investments were held. The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2023:

Money market fund: Valued at the per unit price as quoted by the financial institution.

Mutual funds: The fair value of mutual funds are based on quoted net asset values of the shares as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Matrix Trust Company is the Trustee and Quick(k) 401(k) ePlan Services serves as the third-party administrator as defined by the Plan and they provide investment, administrative and record-keeping services to the Plan, which qualify as party-in-interest transactions. Fees related to the aforementioned services are included in Plan expenses and within net appreciation of investments.

NOTE 6 – TAX STATUS

The Plan Sponsor has adopted a volume submitter plan which received a favorable opinion letter from the IRS that the form of the Plan is acceptable under Section 401(a) of the Internal Revenue Code (“IRC”). The Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax period in progress.

NOTE 7 – OPERATIONAL COMPLIANCE

During 2024, instances were identified where participant elective deferrals and related employer safe harbor match contributions were not made in accordance with Plan provisions and participant elections, resulting in missed contributions. The Plan Sponsor has identified the systemic errors related to the Plan compensation, as well as some instances of input errors related to deferral elections, and is working with the Plan Sponsor’s new third-party administrator of the PEP Plan to calculate the missed contributions and related earnings in order to make a Qualified Nonelective Contribution to the affected participants. The contribution is not estimated to be material to the Plan and is not recorded in the accompanying financial statements on the liquidation basis; however the Plan sponsor intends to make the corrective contribution into the Company’s new PEP Plan.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets in liquidation.

NOTE 9 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 22, 2025, the date on which the financial statements were available to be issued.
