Note 1 - Plan Description

The following brief description of the Bison Transport (USA), Inc. (Company) Employees' 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution plan covering all full-time employees of the Company with no service or age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may defer up to 50% of their compensation as a pre-tax or Roth contribution each year not to exceed the thresholds set by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company elected to match \$.50 per \$1.00 up to the first 4% of employee contributions to the Plan. The Company matching contributions were \$525,692 and \$699,415 for the years ended June 30, 2025 and 2024, respectively. Additional amounts may be contributed at the option of the Company's board of directors. The Company made no additional contributions in 2025 or 2024.

Participant Accounts and Rollovers

Each participant's account is credited with the participant's contribution, an allocation of the Company's matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

Vesting

Participants were immediately vested in their elective and rollover contributions plus actual earnings thereon as well as matching and discretionary contributions through June 2023. Effective July 2023, participants are still fully vested in their elective and rollover contributions plus actual earnings thereon, and vesting in the Company's matching and discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service, with a 5-year graded vesting schedule.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$2,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1 percent. Principal and interest is repaid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant (or beneficiary in the case of death) may elect to receive an amount equal to the value of the participant's interest in his or her account as a lump-sum amount or in partial distribution amounts, if permitted at the discretion of the plan administrator, if the account is greater than \$5,000. However, if the value of the benefit is less than \$5,000, a lump-sum distribution will be made regardless of whether or not an election has been made. The Plan permits in-service distributions at age 59½.

Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary and matching contributions. These forfeitures are used to reduce Company matching contributions or plan expenses. There was \$125,796 and \$4,618 of forfeitures used during the years ended June 30, 2025 and 2024, respectively. There were unallocated forfeitures from nonvested accounts of \$23,910 and \$64,771 at June 30, 2025 and 2024, respectively.

Note 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to generally accepted accounting principles.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document and the loan policy.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Income Taxes

The Company restated the Plan, effective January 1, 2022, and adopted a prototype non-standard 401(k) profit sharing plan, described in Note 1. The prototype has received a favorable opinion letter from the Internal Revenue Service. As such, the Plan qualifies under Section 401(a) of the Internal Revenue Service Code and, therefore, is not subject to tax under present income tax laws. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated subsequent events through February 6, 2026, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Pooled Separate Accounts: Pooled separate account contracts with an insurance company are valued at the net asset value (NAV) readily determinable value since it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily, which is why the custodian values these as level 2 investments at a readily determinable fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Guaranteed Investment Contract

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company totaling \$4,879,414 and \$4,945,557 at June 30, 2025 and 2024, respectively. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 6 - Related Party Transactions

Certain Plan investments are shares of funds managed by Nationwide Life Insurance Company. Nationwide Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and recordkeeping services to Nationwide Life Insurance Company amounted to \$20,698 and \$18,126 for the years ended June 30, 2025 and 2024 respectively. The remaining expenses were paid to other parties who provide services to the Plan. Certain employees and officers of the Plan Sponsor, who are also participants in the Plan, perform administrative services to the plan at no cost to the Plan.

Note 6 - Related Party Transactions (Continued)

Nationwide Life Insurance Company provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Nationwide Life Insurance Company. Nationwide Life Insurance Company receives revenue from fund service providers for services Nationwide Life Insurance Company provides to the funds. This revenue is used to offset certain amounts owed to Nationwide Life Insurance Company for its administrative services to the Plan.

If the revenue received by Nationwide Life Insurance Company from such fund service providers exceeds the amount owed under the MSA, Nationwide Life Insurance Company remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2023-2024 and 2024-2025, there were no excess amounts. The Plan or Company may make a payment to Nationwide Life Insurance Company for administrative expenses not covered by revenue sharing.

Note 7 - Information Certified by Plan's Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying 2024 financial statements, including investments and notes receivable from participants held at June 30, 2024, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agree to or derived from information certified as complete and accurate by Nationwide Life Insurance Company (the custodian of the Plan).

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

Note 9 - Transfer of Assets from Another Plan

In July 2023, two other Plans, Hartt Transportation Systems, Inc. 401(k) Plan and Pottle's Transportation 401(k) Plan, merged in with Bison Transport (USA), Inc. Employees' 401(k) Plan due to company mergers. All investment funds along with notes receivable were transferred to the Plan as of July 7, 2023. The transfer amounts totaled \$14,210,688.

In October 2024, assets from Hartt Transportation Systems, Inc. 401(k) Plan for employer matching contributions were transferred into the Bison Transport (USA), Inc. Employees' 401(k) Plan. The transfer amounts totaled \$79,241.
