INDEPENDENT AUDITOR'S REPORT

To the Trustees of the
United Food and Commercial Workers
Unions and Employers Health and Welfare Fund - Atlanta

Opinion

We have audited the accompanying financial statements of United Food and Commercial Workers Unions and Employers Health and Welfare Fund - Atlanta (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of April 30, 2025 and 2024, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.





In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.


Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED APRIL 30, 2025 AND 2024

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the United Food and Commercial Workers Unions and Employers Health and Welfare Fund - Atlanta (the Plan) provides only general information. Participants should refer to the Summary Plan Description for more complete information.

General - The Plan was established October 1, 1964, pursuant to collective bargaining agreements between participating employers and certain United Food and Commercial Workers (UFCW) unions. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides health benefits (medical, prescription drug, vision care and dental care) as well a life insurance, accidental death and dismemberment benefits and weekly indemnity benefits. Medical and prescription drug benefits for all participants are self-insured by the Plan except for those who are covered under a health maintenance organization (HMO) option and the Carolina group participants whose prescription drug benefits are provided through another plan. Weekly indemnity benefits are also self-insured. Medical and prescription drug benefits for those participants covered under an HMO option are provided through the purchase of insurance contracts, as are vision care, dental care, life insurance and accidental death and dismemberment benefits.

Contributions - Participating employers contribute pursuant to collective bargaining agreements or other written agreements governing the Plan. Employees may contribute specific amounts determined periodically by the Plan's consultant in accordance with the collective bargaining agreements or other written agreements.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Contributions Receivable - Contributions due and unpaid at year end are recorded as contributions receivable. All amounts are deemed collectible, and, accordingly, no allowance for uncollectible accounts has been recorded.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investments - Investments are reported at fair value. Security transactions are accounted for on the trade date. Dividend income is reported on the ex-dividend date. Interest and income from other investments is reported as earned.

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

UFCW Unions and Employers Benefits Administration, LLC. - The UFCW Unions and Employers Benefits Administration, LLC. provides administrative services to the Plan, the UFCW Consolidated Pension Fund, UFCW Unions and Employers Legal Assistance Fund and the UFCW Local No. 1995 Employers Health and Welfare Fund. The costs of these administrative services are allocated to the various funds and reimbursed monthly.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Benefits Currently Payable and Incurred but not Reported - Amounts currently payable to or for participants, beneficiaries and dependents represent actual and estimated amounts paid or payable after year end for all reported claims for benefits occurring during the respective accounting periods, days lost due to disabilities that began during those periods, payment to benefit providers for benefits in those respective periods, and other miscellaneous benefits related to services performed in those respective periods.

NOTE 3. TAX STATUS

The Plan obtained its most recent determination letter on October 1, 1964, stating that the Plan was in compliance with the applicable requirements under Section 501(c)(9) of the Internal Revenue Code (IRC) and was, therefore, exempt from federal income taxes under the provisions of Section 501(c)(9). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan has performed an evaluation of its tax positions and, as of April 30, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. As of April 30, 2025, the statute of limitations for tax years 2022 through 2024 remains open with the U.S. federal jurisdiction in which the Plan files tax returns.

NOTE 4. PRIORITIES UPON TERMINATION

In the event of the termination of the Agreement and Declaration of Trust, the Trustees shall apply the Plan to pay, or to provide for the payment of, any and all obligations of the Plan, and shall distribute and apply any remaining surplus in such manner as will, in their opinion be consistent with the Trust's tax-exempt status; provided, however, that



NOTE 4. PRIORITIES UPON TERMINATION (CONTINUED)

no part of the corpus or income of said Plan shall be used for, or diverted to purposes other than for, the exclusive benefit of the employees of the employers or their eligible dependents, or the administrative expenses of the Plan or for other payments in accordance with the provisions of the Plan. Under no circumstances shall any portion of the corpus or income of the Plan, directly or indirectly, revert or accrue to the benefit of any contributing employer or the Union.

NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Short-term investments are primarily cash and cash equivalents which are valued at cost which approximates fair value.

U.S. Government obligations and corporate debt instruments are valued based on quoted market prices or on estimated values if they are not actively traded. Independent pricing services are used for prices that are not actively traded. In some

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

cases where a market or independent pricing service price is not readily available, the custodian will make use of acceptable sources, such as most recent bid price, broker supplied valuations, yield curves, maturities, call features, ratings and developments relating to specific securities to estimate fair value.

Mutual funds are valued based on closing prices on national exchanges.

NOTE 6. MAJOR PARTICIPATING EMPLOYER CONTRIBUTORS

During the years ended April 30, 2025 and 2024, the Plan received approximately ninety eight percent (98%) and ninety seven percent (97%), respectively, of its employer contributions from one (1) employer.

NOTE 7. RISKS AND UNCERTAINTIES

Investment Risk - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Significant Uncertainties: Plan Benefits - The actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to



NOTE 7. RISKS AND UNCERTAINTIES (CONTINUED)

uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 8. PARTY-IN-INTEREST TRANSACTIONS

The Plan pays certain investment and administrative fees directly to service providers. These transactions were party-in-interest transactions, for which an exemption applies under ERISA's prohibited transaction requirements.

NOTE 9. UNINSURED CASH

The Plan maintains its cash in two deposit accounts. The cash balances in the United States are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per bank. At April 30, 2025, the Plan had cash of approximately \$9,300,000 in excess of FDIC insurance limits.

The Plan has not experienced any losses in its cash balances and believes it is not subject to any significant credit risks.

NOTE 11. PLAN MERGER AND ASSET TRANSFERS

During the year ended April 30, 2025, the Fund entered into asset transfer agreements with the South Central UFCW Unions and Employers Health and Welfare Fund. These transfers were executed so that assets attributable to specific groups could be used to provide continued benefits for participants in that group, as follows:

- UFCW Local 2008 Group: In September 2024, the Fund received a transfer of \$2,601,000.
- UFCW Local 455 Group: In December 2024, the Fund received a transfer of \$5,333,000.
- An additional \$1,380,640 was received in February 2025 for both groups.



NOTE 11. PLAN MERGER AND ASSET TRANSFERS (CONTINUED)

The total assets received of \$9,314,640 are restricted for use in providing benefits to the participants of the respective groups. The management and disbursement of these funds are strictly governed by the specific terms and conditions outlined in the asset transfer agreements signed between the two funds. These transactions are recorded as a merger income within the statement of changes in net assets available for benefits for the year ended April 30, 2025.

NOTE 12. SUBSEQUENT EVENTS

Subsequent events have been evaluated through February 11, 2026, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.


