Opinion

Notes to the Financial Statements

1. Description of Plan

The following description of the GT Distributors, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a leveraged employee stock ownership plan (ESOP) established effective May 1, 2016. The Plan covers all employees, excluding non-resident aliens, union employees, of GT Distributors, Inc. (the Company) who have completed one year of service (1,000 hours) and are age 18 or older. All employees who were employed by the Company on May 1, 2016 who were 18 years old or older automatically became participants effective May 1, 2016. Employees begin participating in the Plan on the next May 1st, or November 1st following the date eligibility requirements are met. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the ESOP Committee appointed by the Board of Directors. An independent individual is the Plan's trustee.

Contributions - The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted. Additional discretionary amounts may be contributed by the Company at the option of the ESOP Committee. For the year ended April 30, 2025, the Company approved a \$181,500 discretionary contribution to the Plan.

Participant Accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of the Company's preferred stock shares released from the unallocated account, as well as forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are made under a point system whereby 50% of such amount be allocated based on the ratio that the eligible compensation of each participant bears to the total eligible compensation of all such participants, and the remaining 50% shall be based on a point system whereby each eligible participant received 5 points per year of credited service with the allocation based on the ratio that the points of each such participant bears to the total points of all such participants. Plan earnings are allocated, as defined in the plan agreement, to each participant's account based on the ratio of the participant's account balance to all participants' account balances.

Vesting - If a participant's employment with the Company terminates for any reason other than retirement, vesting in their participant account is based on the total years of service with the Company. A participant is 20 percent vested after two years of credited service and continues to vest in increments of 20 percent until 100 percent vested after six years of credited service.

Voting Rights - Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee, prior to the time that such rights are to be exercised. Any allocated shares of Company preferred stock with respect to which voting instructions are not received from participants or beneficiaries and any shares of Company preferred stock held by the Trust which are not then allocated to participant or beneficiary accounts shall be voted in the manner determined by the Trustee on behalf of the collective interest of Plan participants and beneficiaries.

Payment of Benefits – The distribution of benefits under the Plan may be made in cash, Company preferred stock or both. The amount of such distribution is equal to the vested balance in the participant's account as of the valuation date coincident with or next following the date of termination. Generally, a participant's vested account balance will be paid in equal annual installments over a period not exceeding five years. A participant's vested account balance in their non-stock account may be paid in the form of a lump sum.

Forfeitures – Plan forfeitures are allocated to each participant's account in the same manner in which the Company contributions are allocated. At April 30, 2025 and 2024, forfeited nonvested accounts totaled \$0 and \$0, respectively. These accounts will be allocated to participant accounts of those employed on the last day of the plan year. During 2025, forfeited nonvested shares totaling 2,194.2250 were allocated to participant accounts from forfeited nonvested accounts, in accordance with plan provisions.

Put Option - Under federal income tax regulations, the Company preferred stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its preferred stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the preferred stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification - Diversification is offered to participants who at least 55 years of age and have participated in the Plan for at least 10 years (a Qualified Participant). During each of the first five years of eligible diversification, a Qualified Participant may withdrawal up to 25% of the value of their investment in the Company preferred stock, less any shares previously diversified, and transfer the amount as a rollover into another qualified plan or as a cash withdrawal. In the sixth year, the percentage amount that can be withdrawn increases to 50%. The election to diversify is made subsequent to year-end based upon the shares of Company preferred stock in the participant's account at year-end. For the year ended April 30, 2025, \$0 was transferred from the Plan to another qualified contribution plan sponsored by the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations - The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition – The shares of the Company preferred stock are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is accrued on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid. Amounts allocated to withdrawing participants and approved for payment prior to year-end, but not yet paid as of that date, totaled \$39,241.

Administrative Expenses - As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. Expense paid by the Company are excluded from these financial statements.

Subsequent Events - Subsequent events were evaluated through February 12, 2026, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted process in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under

Accounting Standards Codification Topic 820, “Fair Value Measurements and Disclosures”, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Company preferred stock – Valued at estimated fair value based on an independent third-party appraisal using a combination of widely used valuation approaches, including market and income valuation techniques. The appraiser considered inputs such as historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities, along with a discount for lack of marketability where appropriate.

The proceeding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Loan Payable

In 2018, the Plan entered into a \$12,500,000 term loan agreement. The proceeds of the loan were used to purchase Company preferred stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 55,865 shares being released and allocated for the plan year ended April 30, 2025. The agreement provides for the loan to be repaid over 10 years and the loan bears a fixed annual interest rate of 5.0%.

6. Company Advances

During the plan year ended April 30, 2025, the Company advanced \$141,673 in cash to the Trust to cover the Plan's distribution obligations. This advance was an interest-free loan to the Plan. No collateral has been taken for this loan. Plan Management believes that the loan complies with the requirements of Department of Labor Prohibited Transaction Class Exemption 80-26.

The proceeds of the loan were used to fund cash distributions to participants. The advance was converted to a contribution as of April 30, 2025.

7. Related Party and Party in Interest Transactions

The Plan's assets, which consist primarily of Company preferred stock, are held by the trustee of the Plan. The Plan is administered by the Company and certain administrative functions are outsourced to a third-party administrator. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan invests in Company preferred stock and has indebtedness guaranteed by the Company. These are related party and party in interest transactions. As described in Note 2, the Plan or Company pays all plan expenses. The plan has a number of service providers. Such providers are parties in interest under ERISA.

8. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the ESOP Committee directs the Trustee to pay all liabilities and expenses of the Plan and to sell shares of financed preferred stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. In the event of Plan termination, participants would become 100 percent vested.

9. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a determination letter dated August 1, 2018 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan investments consist primarily of Company's preferred stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the preferred stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the preferred stock will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
