Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Treyton Oak Towers 401(k) Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Treyton Oak Towers 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Treyton Oak Towers 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Third and Oak Corporation d/b/a Treyton Oak Towers (the “Company”). An employee's initial eligibility period in order to make contributions to the Plan is the consecutive six-month period from date of hire. Employees who have completed their eligibility period and attained age 18 may become a participant immediately following their completion date of the eligibility requirements. The entry dates to the Plan are quarterly: January 1st, April 1st, July 1st, and October 1st. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee is responsible for oversight of the Plan. The trustee and investment advisor determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the plan administrator.

Contributions:

The Plan is funded by participant contributions, Company safe harbor matching contributions and discretionary Company profit-sharing contribution. Each year, participants may contribute up to 100% of pre-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution to each eligible participant in an amount equal to 100% of the first 3% and 50% of the next 2% of participant deferrals contributed to the Plan. Company contributions may also include a discretionary profit sharing contribution as determined annually by the Company. The Company made no discretionary profit-sharing contribution for the years ended June 30, 2025 and 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant's accounts:

Each participant's account is credited with the participant's voluntary contributions, the Company's safe harbor matching and discretionary profit-sharing contributions, as well as allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

Vesting:

Participants are immediately vested in their salary deferral contributions and Company safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions are subject to the following schedule:

Forfeited accounts:

Forfeitures from Company discretionary contributions may be used to reduce the Company-paid plan expenses, reduce the Company's matching contribution, or reallocate the amounts to plan participants. No forfeitures were utilized for the year ended June 30, 2025. Forfeitures totaling \$548 were used to offset fees during the year ended June 30, 2024. As of June 30, 2025 and 2024, there were no forfeited non-vested accounts.

Payments of benefits:

A participant is eligible for payment of benefits upon termination of service due to death, disability, retirement or other reasons as stated in the Plan document. Under these circumstances a participant will be eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of accounting:

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

NOTES TO FINANCIAL STATEMENTS

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisor and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions:

Contributions from Plan participants and the contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payments of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through February 13, 2026, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 30, 2025 and 2024, and net appreciation in fair value of investments for the years ended June 30, 2025 and 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution.

NOTES TO FINANCIAL STATEMENTS

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All investments have been valued using a market approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at June 30, 2025 and 2024.

Pooled separate accounts – valued at the net asset value (NAV) of units held. The NAV is based on the fair value of the account's underlying investments as based on quoted market prices or value as determined by the insurance company. The NAV is used as a practical expedient to estimate fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held no assets required to be leveled within the fair value hierarchy as of June 30, 2025 and 2024. The following table sets forth the Plan's assets measured at net asset value as of June 30, 2025 and 2024:

Investments Measured Using Net Asset Value per Share Practical Expedient:

All pooled separate accounts have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' net asset value (NAV). The NAV is updated daily.

A description of the investment strategies for all pooled separate accounts whose value is derived using NAV is as follows:

Mid cap – seeks long-term growth of capital by investing majority of assets in common stocks of companies with medium market capitalizations,

Small cap – seeks long-term growth of capital by investing majority of assets in common stocks of companies with small market capitalizations,

International – seeks long-term growth of capital by investing majority of assets in a diversified portfolio of equity securities issued by companies domiciled outside the United States,

Growth – seeks long-term growth of capital by investing majority of assets in common stocks of companies that are diversified,

Target – seeks long-term growth of capital by investing majority of assets in underlying funds that invest primarily in equity securities.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive synthetic investment contract with Voya Retirement Insurance and Annuity Company with a contract value of \$185,556 and \$174,677 at June 30, 2025 and 2024, respectively. Voya Retirement Insurance and Annuity Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on a quarterly basis for resetting.

NOTES TO FINANCIAL STATEMENTS

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Voya Retirement Insurance and Annuity Company may terminate the contract with a minimum of 30 days' advance written notice to the contract owner, if the Plan fails to maintain qualified retirement plan status for any reason.

Note 6. Income Tax Status

The Plan operates under a standardized volume submitter plan designed to be in compliance with the applicable requirements of the Internal Revenue Code. The IRS has determined and informed the prototype plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the trustee believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

Note 8. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are units of pooled separate accounts managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the insurance company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative expenses amounted to \$5,900 and \$6,948 for the years ended June 30, 2025 and 2024, respectively. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. The Company pays directly any other fees related to the Plan's operations.

Certain administrative functions are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan.

NOTES TO FINANCIAL STATEMENTS

Note 9. Risk and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 10. Reconciliation to Form 5500

The Plan holds investments in pooled separate accounts, which are not direct filing entities. As such, per Form 5500 instructions, the Plan's interest in the underlying assets of the pooled separate accounts must be allocated and reported in the appropriate categories on Schedule H. Therefore, these investments are reflected as mutual funds on Form 5500, but as pooled separate accounts for financial statement purposes.
