### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of Milwaukee Hotel Industry Health and Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of April 30, 2025, and the related statement of changes in net assets available for benefits for the year then, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Milwaukee Hotel Industry Health and Welfare Fund as of April 30, 2025, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

#### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Milwaukee Hotel Industry Health and Welfare Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. 

**NOTE 1 DESCRIPTION OF PLAN**

The following brief description of the Milwaukee Hotel Industry Health and Welfare Fund (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a multiemployer welfare benefit plan covering members who are represented by Chicago Midwest Regional Joint Board Workers United, #122 (the Union) for collective bargaining purposes

The Plan is administered by a Board of Trustees (the Trustees) consisting of a union group and an employer group of representatives, each having equal voting power.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Fund Administration**

The Trustees oversee governance of the Plan, determine the appropriateness of the Plan's investments, and monitor investment performance. The Trustees have engaged Benefit Services Group Analytics, LLC as the third-party administrator to handle the daily administration of the Plan.

**Contributions**

The Plan is financed by employer contributions in accordance with the terms of the collective bargaining agreements between the Union and participating employers. Under certain conditions, the Plan also allows for self-payment contributions from individuals in order to continue coverage.

Employer and participants' contributions are received from employers and participants for the operation of the Plan. Employer contributions are recognized as additions in the period that coincides with the completion of the related work hours. Participant contributions are recognized as additions in the period of benefit coverage.

**Eligibility**

Participants in the Plan are granted eligibility in accordance with their respective collectively bargained agreements. At minimum, a newly hired employee must average at least 30 paid hours per week of work to be eligible for the Plan (full time employee). With the exception of certain tenured participants, once an employee falls below full time status, they will need to exit the Plan by a specified date.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Benefits**

The Plan provides fully-insured accident, health, dental, vision care, prescription drug, and death benefits, and self-funded loss-of-time benefits. These benefits are provided for eligible employees of participating employers and their dependents. The Plan does not provide benefits to retirees.

**Funding**

The Plan is funded by (a) contributions from employers on behalf of participating employees, (b) additional contributions from eligible self-contributors, and (c) earnings on investments.

Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of Credit Risk**

The Plan maintains its cash balances in high credit quality financial institutions. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, such cash balances may be in excess of the insurance limit.

**Cash**

Cash is defined as currency on hand, in demand deposits.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions Receivable**

As of April 30, 2025 and 2024, all outstanding contributions receivable amounts are reported net of contributions considered uncollectible by the Plan. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of April 30, 2025 and 2024, the allowance for credit losses was insignificant.

**Cost of Benefits**

Benefit insurance premiums and loss-of time benefits are recorded when paid by the Plan.

**Administrative Expense**

Administrative expenses are paid by the Plan.

**Benefit Obligations**

U.S. GAAP requires defined benefit health and welfare plans to include information regarding the plan's benefit obligations as of the end of the plan year and information regarding the effects, if significant, of certain factors affecting the year-to-year change in the plan's benefit obligations. The Plan is primarily fully-insured. There are no retiree or postemployment benefits. Based on how premiums are billed by the insurer and paid by the Plan, there were no premiums due to insurers as of April 30, 2025 and 2024. Any obligations related to loss-of-time benefits are insignificant. Consequently, the statements of benefit obligations and statements of changes in benefit obligations as of and for the year ended April 30, 2025 and 2024 are not included in these financial statements.

**Reclassifications**

Certain amounts in the 2024 financial statements have been reclassified to conform with the 2025 presentation. These reclassifications do not affect net assets available for benefits as previously reported.

**NOTE 3 FAIR VALUE OF INVESTMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2025 and 2024.

*Cash Equivalent* - Valued based on cost, which approximates fair value in a non-inflationary economy and is protected by the FDIC.

*Certificates of Deposit* - Valued based on fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer

**NOTE 4 TAX STATUS**

The VEBA trust funding benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated June 13, 1963, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2025 and 2024 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

**NOTE 5 PLAN TERMINATION**

Although they have not expressed any intention to do so, the Trustees reserve the right to terminate the Fund at any time. In the event of termination of the Fund, assets remaining after expenses must be used for the exclusive benefit of participants.
