Opinion

We have audited the accompanying financial statements of **IBA Group Insurance Trust** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of **IBA Group Insurance Trust** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was originally established on May 1, 1957 to hold insurance policies and enter into agreements associated with providing a group insurance program intended to provide health and other benefits to eligible employees and covered dependents of employers enrolled as regular or associate members of the Indiana Bankers Association, Inc. (Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees of the IBA Group Insurance Trust oversees governance of the Plan.

Contributions - Participating employers contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Employers may elect to withhold amounts from each participating employee's compensation based on applicable monthly premiums for their respective benefit elections to share in the cost of coverage. Contribution rates are determined annually by the Board of Trustees.

Benefits - The Plan provides health benefits (medical and prescription drugs) for eligible employees of the Employers and their covered dependents, which are self-insured. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). In addition, the Plan also provides dental, vision, life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits which are not self-insured.

Stop Loss Coverage - The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop loss insurance are included in the accompanying statements of changes in net assets available for benefits and benefit obligations. The Plan recognized \$431,262 and \$1,301,499 of stop loss reimbursements during the years ended April 30, 2025 and 2024 which have been netted against benefit expenses on the statements of changes in net assets available for benefits and benefit obligations.

Self-insured Benefits - The claims for self-insured benefits are processed by the Plan's third-party claims processors. The claims processor for medical coverage pays claims directly on behalf of participants from the Plan's medical claims fund. The prescription claims processor pays claims directly on behalf of participants and is then reimbursed by the Plan. Despite the Plan's utilization of third-party processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan utilizes a pharmacy benefit manager which periodically makes refunds to the Plan based on the Plan's actual utilization of specific prescription drugs.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Financial Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Concentrations - Financial instruments that potentially subject the Plan to credit risk consist principally of cash. At April 30, 2025 and 2024, the recorded amount of the Plan's supplemental contribution fund was \$4,931,600 and \$4,959,058. At April 30, 2025 and 2024, the bank balance of this account was \$5,026,599 and \$5,410,097. At April 30, 2025 and 2024, only \$250,000 of the Plan's bank balances were insured by the FDIC. Uninsured amounts were \$4,776,599 and \$5,160,097 at April 30, 2025 and 2024.

The Plan's investments in other securities are not insured by the FDIC and are subject to custodial risk.

Medical Claims Fund - As part of its agreement with its third-party claims processor for medical claims, the Plan is required to maintain a specified level in its claims fund. The bank account for the claims fund is held in the name of the third-party administrator for the benefit of the Plan and was established with Plan funds.

Stop Loss and Rebates Receivable - Stop loss receivables represent amounts due to the Plan from its reinsurance carrier for reimbursement of claims paid that exceed the stop loss limit. Rebate receivables represent prescription rebates for prior claims paid.

Payment of Benefits - Claim payments are recorded when paid and are reflected in the accompanying statements of changes in net assets available for benefits and benefit obligations. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of net assets available for benefits and benefit obligations.

Administrative Expenses - Plan expenses are paid by the Plan, as provided by the Plan document. Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits and benefit obligations.

Actuarial Present Value of Benefit Obligations - Plan obligations at year end for medical and prescription claims incurred by active participants, but not reported at year end, are estimated by the Plan's actuary in accordance with accepted actuarial principles. The actuarial present value of claims incurred but not reported (IBNR) is based on past paid claims data in order to develop an estimate of the percentage unpaid. Such estimated amounts are recorded as claims incurred but not yet reported in the accompanying statements of net assets available for benefits and benefit obligations.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the benefit obligation.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 6, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to observable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025.

Cash and cash equivalents and supplemental contribution fund cash - interest bearing: Valued based on cost, which approximates fair value in a noninflationary economy and is subject to FDIC limits.

U.S Government securities, municipal bonds, and corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

Exchange-Traded funds: Valued at the daily closing price as reported by the fund. Exchange-traded funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) throughout the day and to transact at that price. The exchanged-traded funds held by the Plan are deemed to be actively traded.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded. Securities traded in markets that are not considered active are valued based on quoted market prices, broker or dealer quotations, or alternative pricing sources with reasonable levels of transparency.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The supplemental contribution fund assets are held at a participating Employer financial institution.

As described in Note 2, the Plan paid certain expenses related to Plan operations to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 5 - TRUST TERMINATION

Although the Employers have not expressed any intention to do so, they have the right to discontinue participation in the Trust subject to provisions set forth in the Trust agreement. In the event the Trust is terminated, the assets of the Trust will be used to pay any and all obligations of the Trust, and the Trust shall distribute and apply any remaining surplus in the manner as will best effectuate the purposes of the Trust and preserve the tax-exempt status of the Trust.

NOTE 6 - TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code ("IRS"). The Trust has obtained a favorable tax determination letter from the IRS, and the Plan Sponsor believes that the Trust continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code. As a result of the Plan's funding level or investment income, from time to time, the Trust may be subject to income taxes. For the years April 30, 2025 and 2024, the Trust was not subject to federal or state income taxes for unrelated business taxable income (UBTI).

UBTI is generated as a result of Trust assets which exceed the amount reasonably necessary to cover unpaid accrued claims and premiums to insurance carriers, resulting in the excess accumulations being subject to UBTI. The tax is assessed on the lesser of the Trust's income or excess assets in the qualified asset account. For UBTI purposes, the Trust's income is equal to investment earnings less investment management fees associated with those earnings.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. Based on the results of the Plan administrator's evaluation, no liability has been recognized in the accompanying statements of net assets available for benefits and benefit obligations for uncertain income tax positions. The Trust is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Trust received a private letter ruling from the IRS on July 16, 2018 indicating that the Trust may consider insurance premiums paid as qualified direct costs for purposes of determining the qualified asset account limit. As such, the Trust filed amended tax filings for the years ended April 30, 2017 and 2016, in order to recoup the full amount of income taxes paid to federal and state taxing authorities. Such amounts receivable were initially recorded as income tax refunds receivable as of April 30, 2018, and remaining income tax refunds receivable pending receipt from taxing authorities were included on the statements of net assets available for benefits and benefit obligations as of April 30, 2023. The Trust was notified by the IRS that the pending claim was denied. The reversal of the April 30, 2023 income tax refunds receivable was recorded as administrative expenses in the year ended April 30, 2024.

NOTE 7 - RISKS AND UNCERTAINTIES

The liability for claims incurred but not yet reported was estimated using Plan provisions, the number of eligible participants and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements. In addition, the Plan invests in various investment securities which are exposed to risks such as interest rate, market, and credit risks. Due to uncertainties inherent in the estimations and assumptions process as well as the level of risk associated with certain investment securities, it is at least reasonably possible that changes in these estimates, assumptions, and risks in the near term would be material to the financial statements.

NOTE 9 - SUPPLEMENTAL CONTRIBUTION FUND

At April 30, 2025 and 2024, the balance in the Plan's supplemental contribution fund was \$4,931,600 and \$4,959,058. The projected premium income for 2026, plus the Plan's supplemental contribution fund balance at April 30, 2025 is not sufficient to cover the projected claims liability plus expenses for the Plan for 2026. An additional transfer of \$2,326,206 to the supplemental contribution fund will be required in 2026.
