

NOTE 1 – DESCRIPTION OF PLAN

Helena Laboratories Corporation 401(k) Profit Sharing Plan (the Plan) is a qualified retirement plan adopted by Helena Laboratories Corporation (the Company), originally effective on July 1, 1973, to enable eligible employees to save for retirement. The Plan was most recently amended and restated effective June 27, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Company.

The following description of the Plan provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the Plan's provisions.

Eligibility: All nonexcluded employees of the Company are eligible to participate in the Plan. The Plan's entry date is the first day of each month.

Contributions: Participants may elect to defer a percentage of their eligible compensation into the Plan. Deferral contributions will be withheld from a participant's pay on a pre-tax basis. Participants are eligible to designate some or all of their deferral contribution as a Roth deferral contribution. The total amount withheld shall not exceed an annual limit set by law. Participants who are projected to be age 50 or older by the end of the year may also make catch-up contributions. Participants may increase, decrease, or suspend their deferral contributions at any time.

The Company may make discretionary matching contributions to the Plan. The Company may also make discretionary nonelective contributions in an amount to be determined by the Plan administrator. For the fiscal year ended June 30, 2025, the Company did not make any discretionary matching or nonelective contributions.

Participants can also rollover part or all of an eligible rollover distribution they receive from an eligible retirement plan into this Plan as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings or losses, and (c) forfeitures of any employer profit sharing contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their deferral contributions, including catch-up and rollover contributions, and qualified matching and nonelective contributions, plus any earnings thereon. Vesting in discretionary matching and nonelective contributions, and any earnings thereon, is based on a vesting schedule. Participants will become 100% vested on such contributions after 6 years of service.

Payment of Benefits: Participants may receive a distribution if they request one due to their disability, retirement, or termination of employment from the Company and any related employer. If a participant's vested account balance exceeds \$5,000, they may delay their distribution until they are required by law to receive minimum required distributions. However, a participant cannot postpone their distribution if their vested account balance is \$5,000 or less, in which case the Company will direct Fidelity Management Trust Company, the trustee, to distribute it to an IRA for the participant's benefit. If a participant's balance is \$1,000 or less, the Company will direct the trustee to distribute it to the participant as a lump sum distribution without their consent. Prior to such distribution, participants still have the right to request that the amount be distributed directly to them in the form of a lump sum payment or to request that it be rolled over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

Participants may make withdrawals prior to termination of employment under various circumstances. If a participant has reached age 59½, 65, or 70½, they may elect to withdraw all or a portion of their entire vested account.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of one-half of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the balance in a participant's account. All loans bear a reasonable rate of interest. Principal and interest is paid ratably through after-tax payroll deductions on at least a quarterly basis over a 5-year period unless it is for the purchase of a participant's principal residence, in which case the loan repayment period may not exceed beyond 10 years from the date of the loan. Participants may only have one loan outstanding at any given time.

Forfeitures: If a participant terminates employment with the Company and is less than 100% vested in the Company account, they may forfeit the non-vested portion of the Company account. A forfeiture will occur in the Plan year that they receive a distribution of their entire vested account. Forfeitures are retained in the Plan and may be used to pay administrative expenses or reduce future Company contributions payable under the Plan. As of June 30, 2025 and 2024, the forfeiture account balance was \$849 and \$682, respectively.

Plan Termination: The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time by taking appropriate action as circumstances may dictate. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%. The Company will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with Plan provisions.

Administration Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through February 10, 2026, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the fiscal year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Money Market Fund: Fair value is estimated to approximate the cost basis of the deposit account balance, based upon the liquidity of the account and the credit quality of the issuer (Level 1 inputs).

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds shares of a money market fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to the service provider qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
