INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
United Teamster Fund

Opinion

We have audited the accompanying financial statements of United Teamster Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of April 30, 2025 and 2024, and the changes in its net assets available for benefits and benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion


We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED APRIL 30, 2025 AND 2024

NOTE 1. DESCRIPTION OF PLAN

The following description of the United Teamster Fund (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a multiemployer defined benefit health fund established under an Agreement and Declaration of Trust dated April 13, 1949, and amended thereafter between the Teamsters Local 202 (the Union), affiliated with the International Brotherhood of Teamsters, Chauffeurs, Warehousemen, and Helpers of America and participating employers primarily in the produce purveyors, fresh and frozen fruit and vegetable industries inside and outside the Hunts Point Terminal Market in the Bronx, NY who are parties to collective bargaining agreements with the Union requiring contributions to the Plan. The Union and the employers agreed to participate in the operation of a trust fund for the purpose of providing health and welfare benefits to eligible employees of contributing employers who are members of the sponsoring Union. The Plan is administered by a Board of Trustees (Trustees) consisting of Union and employer representatives and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Funding Policy - Funding to provide the benefits are made through monthly contributions by participating employers on behalf of each covered employee as provided for in the applicable prevailing collective bargaining agreements with the Union. Contributions are made by the Union and the Plan in their capacities as employers and participants who have left covered employment and who elect to continue coverage with the Plan through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Benefits - The Plan provides self-insured medical, hospitalization, surgical, prescription drug, dental, optical, and death benefits to eligible employees of participating employers and their eligible dependents, who are covered by collective bargaining agreements with the Union. These benefits are self-insured and paid out of the general assets of the Plan. In addition, the Plan purchases stop loss insurance to actively manage catastrophic medical claims. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting. Under this basis, revenue is recorded when earned and expenses are recorded when incurred, regardless of when cash is exchanged.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, including estimated amounts for claims incurred but not reported and disclosure of contingent assets and liabilities, if any, at the date of financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by the investment manager.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contribution Receivables - Contribution receivables are stated at the amount management expects to collect from balances outstanding at year end. Management assumes that current conditions as of the financial statement date do not change for the remaining life of the asset. When estimating expected credit losses, management considers subsequent collection activity after year end but before the Plan's financial statements are available to be issued. An allowance for expected credit losses is estimated on any uncollected balances using an adjusted historical loss rate and known contributing employer facts. The Plan has concluded that any expected credit losses on balances outstanding at year end will be immaterial to the financial statements as a whole.

Depreciation - Property and equipment is reported at cost, less accumulated depreciation. Major additions are capitalized, whereas replacements, maintenance, and repairs that do not improve or extend the lives of the respective assets are expensed currently. Depreciation is computed on the straight-line method over the estimated useful lives of the related assets varying between five and eight years.

Prescription Drug Rebates - The Plan retains a pharmacy benefit manager (PBM) which periodically provides rebates to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement dates have been reported as a receivable, with the offset being netted against benefits paid. Prescription drug rebates totaling \$2,688,718 and \$2,630,003 have been netted with benefits paid on the statements of changes in net assets available for benefits and benefit obligations for the years ended April 30, 2025 and 2024, respectively.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Payment of Benefits - Claim payments are recorded when paid to the third-party claim processors. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of net assets available for benefits and benefit obligations.

Stop-Loss Insurance - The Plan has entered into a stop-loss insurance policy in an effort to limit its exposure for self-insured medical and hospital benefits. Claims over a contractual amount (\$475,000) incurred per participant during a one-year period are reimbursed by the insurance company to the Plan. Premiums paid for the years ended April 30, 2025 and 2024 were \$1,532,442 and \$1,306,516, respectively. Stop-loss recoveries totaling \$4,613,855 and \$2,912,457 for the years ended April 30, 2025 and 2024, respectively, have been netted with benefits paid in the accompanying statements of changes in net assets available for benefits and benefit obligations.

Claims Incurred but not Reported - Plan obligations at April 30, 2025 and 2024, for claims incurred by active participants but not reported at those dates are estimated by the Plan's actuary in accordance with accepted actuarial principles and practices that take into consideration prior claims experience and also include analyzing claim lag studies using data provided by the Plan's third-party claims administrator. Such amounts are reported undiscounted as these obligations are typically paid within one year. Any differences in the amounts estimated and actual amounts will be reported in future years.

Operating Leases - In its statements of net assets available for benefits and benefit obligations, the Plan records a right-of-use asset and related lease liability for the rights and obligations associated with operating leases where the Plan is lessee. The leases were initially measured at the present value of total lease payments using a risk-free rate that approximates the remaining term of the leases. The Plan considers the likelihood of exercising renewal or termination clauses (if any) in measuring its right-of-use assets and lease liabilities. A single lease cost is calculated so that the cost of the leases is allocated over the lease terms on straight-line basis.

Related disclosures are not included in the financial statements for leases that are considered not material to the financial statements or consist of month-to-month leases that are not considered enforceable agreements and therefore are eligible for the short-term lease exemption. Additional lease disclosures can be found in Note 13.

New Accounting Pronouncement Adopted - During the year ended April 30, 2025, the Plan adopted the provisions of Accounting Standards Update 2025-05, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets* (the Update). The Update provides (1) all entities with a practical expedient and (2) entities other than public business entities (PBEs) with an

accounting policy election when estimating expected credit losses for current accounts receivable and current contract assets arising from transactions accounted for under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 606, *Revenue from Contracts with Customers*. The Plan adopted the new standard effective May 1, 2024, using the prospective approach.

The Plan has elected to use the practical expedient to assume that current conditions as of the financial statement date do not change for the remaining life of the asset and the accounting policy election to consider subsequent collection activity after year end but before the Plan's financial statements are available to be issued.

NOTE 3. UNINSURED CASH BALANCES

The Federal Deposit Insurance Corporation (FDIC) insurance limit is \$250,000 per institution. Financial instruments that potentially subject the Plan to concentration of credit risk consist principally of cash held in a high-quality financial institution. The balance at times may exceed FDIC insured amounts. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk.

Depreciation expense totaled \$26,497 and \$28,067 for the years ended April 30, 2025 and 2024, respectively, which is included in administrative expenses in the statements of net assets available for benefits and benefit obligations.



NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan uses valuation techniques to measure fair value that are consistent with the market approach and/or income approach, depending on the type of security and the particular circumstance. The market approach uses prices and other relevant information generated by market transactions involving identical or comparable securities. The income approach uses valuation techniques to discount estimated future cash flows to present value.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended April 30, 2025 and 2024.

Certificate of deposit - Valued at cost which approximates fair value.

Money market fund - Valued at cost which approximates fair value.

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

Mutual funds - Valued at the daily closing price reported in the active market in which the funds are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price and therefore, are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. In addition, the inputs and methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

NOTE 6. THIRD PARTY ADMINISTRATIVE SERVICES

The Plan provides administrative services to a related party, the United Teamster Pension Fund "A" (Pension Fund A). The Plan provides all services necessary to administer Pension Fund A in compliance with ERISA and Pension Fund A's rules and regulations. The fees received for providing these services, which were determined by the results of a cost sharing study, were \$488,000 for both the years ended April 30, 2025 and 2024, respectively.



NOTE 6. THIRD PARTY ADMINISTRATIVE SERVICES (CONTINUED)

In addition, the Plan provides administrative services to other unrelated benefit funds. Administrative fees earned by the Plan totaled \$1,084,182 and \$1,188,641 for the years ended April 30, 2025 and 2024, respectively. At April 30, 2025 and 2024, the Plan had (unearned administrative fees) and administrative fee receivables of \$(95,671) and \$157,129, respectively, due to the timing on when payments are received. Administrative fees received by the Plan are netted against administrative expenses on the statements of changes in net assets available for benefits and benefit obligations.

NOTE 7. TAX STATUS

The Plan has received an exemption letter from the Internal Revenue Service (IRS) stating that the trust established under the Plan was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code (IRC). The Trustees believe that the Plan, as amended, is operating in compliance with the applicable requirements of the IRC and, therefore, believe that the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2025 and 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Claims that have been processed and approved for payment at year end and claims incurred but not reported are not considered liabilities under U.S. GAAP and, therefore, are not presented as liabilities or claims paid in the accompanying financial statements but are recorded on the Form 5500 under liabilities.



NOTE 9. PRIORITIES UPON TERMINATION OF THE PLAN

Although they have not expressed any intention to do so, the Trustees, as Plan Sponsor, have the right under the Plan to modify the benefits provided to active employees and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits. No assets of the Plan will be used for purposes other than for the exclusive benefit of plan participants and to pay reasonable administrative expenses.

NOTE 10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and to uncertainties in estimates and assumptions, it is at least reasonably possible that changes in the values of such investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and benefit obligations.

NOTE 11. PARTY-IN-INTEREST TRANSACTIONS

The Plan pays certain administrative and professional fees to various service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

NOTE 12. PARTICIPATION IN MULTIEMPLOYER PLANS

Defined Benefit Pension Plan

The Plan's office employees are covered by a multiemployer defined benefit pension plan. The risks of participating in a multiemployer plan are different from single-employer plans in the following aspects:

- Assets contributed to the multiemployer plan by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to the Plan, the unfunded obligations of the Plan may be borne by the remaining participating employers.
- If an employer chooses to stop participating in this multiemployer plan, the employer may be required to pay an amount, referred to as a withdrawal liability, based on the under-funded status of the Plan.



NOTE 12. PARTICIPATION IN MULTIEMPLOYER PLANS (CONTINUED)

The Plan's participation in this multiemployer plan for the years ended April 30, 2025 and 2024, is outlined in the table below. The "EIN" and "Pension Plan Number" rows provide the Employer Identification Number (EIN) and the three-digit plan number. The most recent Pension Protection Act (PPA) zone status available in 2025 and 2024 is for the multiemployer plan's year ends at December 31, 2025 and 2024, respectively. The zone status is based on information that the Plan received from the multiemployer plan and is certified by the Plan's actuary. Among other factors, plans in the red zone are generally less than 65 percent funded, plans in the yellow zone are less than 80 percent funded, and plans in the green zone are at least 80 percent funded. The FIP/RP Status row indicates whether a funding improvement plan (FIP) or a rehabilitation plan (RP) is either pending or has been implemented. In addition to regular plan contributions, the Plan may be subject to a surcharge if the Plan is in the red zone. The "Surcharge Imposed" row indicates whether a surcharge has been imposed on contributions to the Plan. There have been no significant changes that affect the comparability of 2025 and 2024 contributions. Contributions reported below represent the Plan's proportionate share of the contributions made to this multiemployer plan.

Defined Contribution Benefit Plan

The Plan, on behalf of its office staff, contributes to a multiemployer defined contribution benefit plan. Contributions made by the Plan for the years ended April 30, 2025 and 2024 totaled \$47,250 and \$44,280, respectively.

NOTE 13. OPERATING LEASES AS LESSEE

The Plan currently has an operating lease for premises at 2137 Utica Ave., Brooklyn, NY from a related party, Pension Fund A. The lease expires on July 31, 2027 with a 5 year renewal option commencing on August 1, 2027, and expiring on July 31, 2032. The Plan expects to exercise the renewal option. The Plan also leases office space in Rahway, NJ from a related party, the sponsoring Union. The lease expires on December 1, 2029. In addition, the Plan has a lease for office space from an unrelated party in the Bronx, NY under an operating lease expiring May 31, 2031.



NOTE 13. OPERATING LEASES AS LESSEE (CONTINUED)

Operating lease expense for the three offices totaled \$349,044 and \$354,555 for the years ended April 30, 2025 and 2024, respectively. No amounts were due at April 30, 2025 and 2024. The Plan had no variable or short-term lease expense in the years ended April 30, 2025 and 2024, and does not have any finance leases.


