INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
United Welfare Fund - Welfare Division

Opinion

We have audited the financial statements of the United Welfare Fund - Welfare Division (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the United Welfare Fund - Welfare Division as of April 30, 2025 and 2024, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

NOTES TO FINANCIAL STATEMENTS

APRIL 30, 2025 AND 2024

NOTE 1. PLAN DESCRIPTION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the United Welfare Fund - Welfare Division (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan first became effective September 1956, and is a division of the United Welfare Fund and is a welfare benefit plan established under an Agreement and Declaration of Trust pursuant to collective bargaining agreements between the United Service Workers Union (Union) and various employers in the service industry in the United States. The Union and the various employers agreed to participate in the operation of a trust fund for the purpose of providing health and other benefits to eligible participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investments in coordination with their investment advisors.

Plan Benefits

Benefits are paid by means of a trust and group insurance contracts. The benefits include, but are not limited to, hospitalization, medical prescription, dental, disability, optical, and life insurance.

Actual benefits, including conditions and limitations thereto, are governed by the provisions of the Plan. Continued eligibility is maintained as the employer makes contributions on the behalf of the participant.

Associate Members

The Plan allows limited participation in its benefits to Associate Members of the Union. Associate Members participate pursuant to an Associate Membership Agreement entered into by the Union and Employers which was designed to fully comply with regulations issued by the United States Department of Labor. Continued eligibility is maintained as long as each Associate Member participant remains an Associate Member of the Union and has contributions made on their behalf in an amount specified by the Plan.

Contributions

The Plan is funded by employer contributions. Contribution rates have been established under collective bargaining agreements entered into between the Union and the various employers. Employer and participant contributions are accounted for as exchange transactions.

**NOTE 1. PLAN DESCRIPTION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES
(continued)**

Refunds

The Plan utilizes a pharmacy benefit manger (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid in the accompanying statements of changes in net assets available for benefits for the years ended April 30, 2025 and 2024.

Basis of Accounting and Financial Statement Presentation

The financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for defined benefit health and welfare plans.

Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, benefit claims incurred but not reported (IBNR), claims payable and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as an exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. The Plan's Board of Trustees, in coordination with their investment advisers, determines the Plan's valuation policies.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employers' Contribution Receivable

Contributions receivable represent uncollected contributions due the Plan under the terms of the CBA between the Union and various participating employers. The management believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded at April 30, 2025 and 2024.

Property and Equipment

Property and equipment are carried at cost. Major additions are capitalized while replacements and repairs that do not improve or extend the lives of the respective assets are expensed. Depreciation expense is computed using the straight-line method over the estimated useful lives of 5 to 10 years.

Benefit Obligations

Plan obligations for claims incurred but not reported (IBNR) as of April 30, 2025 and 2024 are estimated by the Plan's benefit consultant and Plan management based on historical claims experience, including medical and prescription drug claims lag reports.

Such estimated benefits are reported in the accompanying statements of benefit obligations.

Leases

The Plan is required to recognize a right-of-use model (ROU) asset and lease liability on the statement of net assets available for benefits for all leases with a term longer than 12 months. ROU assets represents the lessee's right to control the use of the leased asset during the lease. Leases will be classified as finance or operating, with classification affecting the pattern and classification of expense recognition in the statement of activities. Lease liabilities represent the present value of the future lease payments over the expected lease term. The present value of the lease liability is determined using the incremental borrowing rate at the lease inception. Over the lease term, the Plan uses the effective interest rate method to account for the lease liability as lease payments are made and the ROU asset is amortized into expenses in a manner that results in a straight-line expense recognition in the statement of activities. As of April 30, 2025 and 2024, the Plan has determined the leases identified operating leases.

Paycheck Protection Plan (PPP) Loan

On May 12, 2020, the Plan qualified for a loan pursuant to the Paycheck Protection Program, a program implemented by the U.S. Small Business Administration under the Coronavirus Aid, Relief, and Economic Security Act, from a qualified lender (the “PPP Lender”), for an aggregate principal amount of \$459,797. The PPP Loan bore interest at a fixed rate of 1.0% per annum, with the first ten months of interest deferred, had a term of two years, and was unsecured and guaranteed by the U.S. Small Business Administration.

The principal amount of the PPP Loan was subject to forgiveness under the Paycheck Protection Program upon the International's request to the extent that the PPP Loan proceeds were used to pay expenses permitted by the Paycheck Protection Program, including payroll costs, covered rent, and other eligible expenses. On May 28, 2021, the Plan's loan was forgiven. Subsequently, the Plan received a Civil Investigation Demand from the U.S. Attorney's office for the Southern District of New York seeking information in connection with a civil investigation of the Plan's eligibility for and entitlement to forgiveness of the loan. The likelihood of an unfavorable outcome or range of potential loss is uncertain at this time.

Subsequent Events

The Plan has evaluated subsequent events for potential recognition or disclosure through February 11, 2026, the date the financial statements were available to be issued.

NOTE 2. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy as described are as follows:

Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

NOTE 2. INVESTMENTS AND FAIR VALUE MEASUREMENTS (continued)

- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to access the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

United States Government and Government Agency obligations: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Corporate obligations: Valued using pricing models that maximize the use of observable inputs for similar securities, including yields, credit ratings and broker quotes, if available.

Short-term investments: Valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 2. INVESTMENTS AND FAIR VALUE MEASUREMENTS (continued)

For the years ended April 30, 2025 and 2024 there were no transfers in or out of levels 1, 2, or 3.

NOTE 3. RELATED PARTY TRANSACTIONS

The Plan operates in a jointly administered office with the union and related plans. Certain administrative expenses which are common to the Plan and the other related organizations are apportioned between them based upon the estimated benefit received by each organization. Direct charges are made for expenses where totally applicable. Amounts reported as receivable from related organizations or payable to related organizations generally include balances for shared expenses.

The amounts due to related entities were \$170,975 and \$204,761, as of April 30, 2025 and 2024, respectively.

NOTE 3. RELATED PARTY TRANSACTIONS (continued)

The Plan's share of expenses allocated from related entities was \$5,987,146 and \$6,026,453 for the years ended April 30, 2025 and 2024, respectively. The amount of expenses the Plan allocated to related entities was \$2,441,691 and \$2,374,874 for the years ended April 30, 2025 and 2024, respectively.

Plan investments are managed by the custodians, Flagstar, and Comerica. Therefore, transactions of these investments qualify as party-in-interest transactions. These investments and related transactions have been denoted as such on the supplemental Schedules of Assets Held at End of Year and Reportable Transactions.

The transactions identified above qualify as transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 4. LEASE COMMITMENTS

On May 18, 2021, the Plan entered into a lease for office and storage space from GHP 145 Huguenot Delaware, LLC. The Plan moved into the space on June 1, 2022. The terms of the lease, which extend from June 1, 2022 through May 31, 2032, call for an annual base rent plus a proportionate share of increases in real estate taxes over the base.

The Plan has elected to use the incremental borrowing rate as the discount rate for the leases.

NOTE 5. PENSION PLANS

The Plan participates in various pension plans. Contributions made to pension plans are generally based on daily or monthly rates, percentage of salary, or determined by the Plan's actuary. Net contributions and reimbursements to related organizations for pension plan contributions made on behalf of eligible employees included in expenses allocated from related organizations on the Schedules of Administrative Expenses for the years ended April 30, 2025 and 2024, were as follows:

The Plan contributes to the I.A.M. National Pension Fund, National Pension Plan (Pension Fund), a multiemployer defined benefit pension plan, under the terms of the collective-bargaining agreement that cover its union-represented employees. The risks of participating in multiemployer plans are different from single-employer plans in the following aspects:

- Assets contributed to multiemployer plans by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to the plan, the unfunded obligations of the plan may be borne by the remaining participating employers.
- If the Plan chooses to stop participating in the multiemployer plan, it may be required to pay that plan an amount based on the underfunded status of the plan, referred to as a withdrawal liability.

The Plan's participation in the Pension Fund for the annual periods ended April 30, 2025 and 2024 is outlined in the table below. Unless otherwise noted, the most recent Pension Protection Act (PPA) zone status available is for the Pension Fund's year beginning at January 1, 2025 and 2024, respectively. The zone status is based on information that the Plan received from the Pension Fund and is certified by the Pension Fund's actuary. Among other factors, plans in the red zone are generally less than 65% funded, plans in the yellow zone are less than 80% funded, and plans in the green zone are at least 80% funded. The "FIP/RP Status Pending/Implemented" column indicates plans for which a financial improvement plan (FIP) or a rehabilitation plan (RP) is either pending or has been implemented. The last column lists the expiration date(s) of the collective-bargaining agreement(s) to which the plans are subject. There have been no significant changes that affect the comparability of April 30, 2025 and 2024 contributions.

The Plan contributes to the United Service Workers Union Pension Plan, a single employer defined benefit pension plan sponsored by the Union. Contribution expense was \$1,496,016 and \$1,428,750 for the years ended April 30, 2025 and 2024, respectively. As of April 30, 2025 the plan's actuary has determined that the plan was 100% funded.

NOTE 6. TAX STATUS

The Plan (and its related trust) are intended to be exempt from Federal income tax under the provisions of Section 501(c)(5) of the Internal Revenue Code (IRC), as amended and has obtained a favorable determination letter from the Internal Revenue Service (IRS) dated February 1986. The Plan has been amended since receiving the determination letter.

However, the Plan's Trustees and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more likely than not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions.

NOTE 7. PLAN TERMINATION

The Trustees expect and intend to continue the Plan indefinitely but reserve the right to amend or terminate it as provided for by the applicable Trust Agreement and Plan provisions. If the Plan is terminated, Plan assets will be used to pay all expenses under the terms of the Plan in the order of priority specified in the Plan and as otherwise required by law.

NOTE 8. RISKS AND UNCERTAINTIES

Investment Securities

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Claims Estimates

The estimate for health claims incurred but not reported are reported based on certain assumptions pertaining to interest rates, healthcare inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Credit Risk

Financial instruments that subject the Plan to concentrations of credit risk include cash, investments, and employers' contributions. The Plan maintains accounts at high quality financial institutions. While the Plan attempts to limit its financial exposure, its deposit balance may, at times, exceed federally-insured limits. The Plan has not experienced any losses on such accounts, and the Trustees believe the Plan is not exposed to any significant credit risks.
