We have performed audits of the financial statements of the Roofers Local Union #210 Money Purchase Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Roofers Local Union #210 Money Purchase Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Roofers Local Union #210 Money Purchase Pension Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution multi-employer plan which began May 1, 1981 and covers all eligible members of the collective bargaining unit represented by the Roofers Local Union #210. The participating employers have agreed to make contributions to the Plan in accordance with the collective bargaining agreement. The Plan is administered by a Board of Trustees, which consists of two Roofers Union #210 members and two Roofers Union #210 contractors. The Plan trustees have the right under the Plan to modify, suspend, and under certain conditions, discontinue the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants are eligible for the Plan once they have accumulated 500 hours of service.

Contributions by Plan participants are voluntary and can be made at any time, up to 10% of their wages.

Participants direct the investment of their contributions into various investment options offered by the Plan.

The contractors are primarily located in Northwestern Pennsylvania and Southwestern New York. Approximately 93% of contributions came from two contractors for the years ended April 30, 2025 and 2024.

Contributions by employers are determined by the collective bargaining agreements. The contribution rates for the year ended April 30, 2025 are as follows: 1) New York \$3.18/hour; 2) Pennsylvania \$4.19/hour. The contribution rates for the year ended April 30, 2024 are as follows: 1) New York \$2.64/hour; 2) Pennsylvania \$4.09/hour.

For the years ended April 30, 2025 and 2024, the Plan has met the minimum funding requirements.

## **NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

### Participant Accounts

Each participant's account is credited with the contractor contributions and participant contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

All contributions and earnings are vested immediately.

### Payment of Benefits

Retirement benefits are available to any participant reaching age 59½. If a participant leaves the Plan and their account is \$5,000 or less, a lump-sum payment will be made. If greater than \$5,000, their account will be used to purchase an annuity in the name of the participant. If a participant has reached normal retirement age and is still working, they may receive annual payments of 10% of their account balance.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Benefit Payments

Benefits are recorded when paid.

### Subsequent Events

The Plan has evaluated subsequent events through February 15, 2026, which is the date the financial statements were available to be issued.

## NOTE 3 – FINANCIAL DATA CERTIFIED BY THE CUSTODIAN

The following is a summary of the investment information regarding the Plan as of April 30, 2025 and 2024 and for the years then ended, included in the Plan's financial statements and supplemental schedule that was prepared by, or derived from, information prepared by Alerus Financial, N.A. the custodian of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the custodian that such information is complete and accurate.

## NOTE 4 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated June 23, 2015 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Income funds: The guaranteed income fund with an insurance company is not actively traded and significant other observable inputs are not available. Fair value was determined to be approximated by contract value.
