### Note 1: Description of Plan

The following description of Plumbing and Pipefitting Industry Local 219 Annuity Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a multiemployer defined contribution plan covering employees of contributing employers who are subject to the collective bargaining agreement between Local No. 219 of the United Association of Journeymen and Apprentices of the Plumbing and Pipe Fitting Industry of the United States and Canada, AFL-CIO (the “Union”) and The Mechanical Contractors Association of Akron, Ohio, Inc. (the “Association”) and other employers. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA). The Plan’s Board of Trustees is responsible for oversight of the Plan.

The Plan is administered by a third-party administrator. The Board of Trustees, comprised of equal representation from the participating employers and the Union, have overall responsibility for the operation and administration of the Plan. The Board of Trustees, with assistance from professional advisors, determine the appropriateness of the Plan’s investments and monitor investment performance.

#### Contributions

Contributions to the Plan are made by employers based upon hourly contribution rates as agreed upon between the Union and Association pursuant to the plan agreement and the collective bargaining agreement. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover), as defined by the plan agreement. Participants direct the investment of the employer contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants may make elective pre-tax employee contributions to the Plan. The amount of employee contributions a participant may elect to defer is \$2.00 per hour or \$4.00 per hour and may not exceed the limits imposed by the Internal Revenue Code (IRC). Effective June 1, 2025, the amount of employee contributions a participant may elect to defer is \$2.00 per hour, \$4.00 per hour, \$6.00 per hour, or \$8.00 per hour and may not exceed the limits imposed by the Internal Revenue Code (IRC).

#### Participant Accounts

Each participant’s account is credited with the employee and employer contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are vested immediately in their employee and employer contributions plus actual earnings thereon.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or a break in service, a participant may elect to receive benefits. The benefit amount the participant receives vary in payment form and depend upon specific qualifications as outlined in the plan agreement.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Basis of Presentation

The Plan follows authoritative guidance issued by the Financial Accounting Standards Board (FASB), which established the FASB Accounting Standards Codification (ASC) as the single source of authoritative accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Employers' Contributions Receivable

Employers' contributions receivable represent amounts due from employers that were received subsequent to year-end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate a recognition of revenue amounts due but erroneously unreported by employers.

#### Cash

The Plan maintains its cash account at a regional financial institution. The balance, at times, may exceed federally insured limits.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the employers. Expenses that are paid by the employers are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through January 7, 2026, the date the financial statements were available to be issued.

### Note 3: Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at April 30, 2025 and 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company LLC (the custodian of the Plan).

### Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4: Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of units of the fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

**Note 6: Related-Party and Party-in-Interest Transactions**

The Plan’s employer contributions are processed and collected by the Plumbers & Pipefitters Local 219 Combined Funds, Inc. (the “Combined Fund”). For this service, the Plan is charged a monthly fee by the Combined Fund. For the years ended April 30, 2025 and 2024, the Plan was charged \$6,186 and \$6,361, respectively, by the Combined Fund. The Board of Trustees of the Combined Fund has determined that it should operate at a break-even point. Any net income at the Combined Fund’s fiscal year-end is allocated to the Plumbing and Pipefitting Industry Local 219 Pension Fund, Plumbers & Pipefitters Local 219 Health & Welfare Fund, and the Plan. Amounts due to the Combined Fund totaled \$5,991 and \$3,941 at April 30, 2025 and 2024, respectively.

The Plan pays administrative fees to service providers. These transactions are party-in-interest transactions under ERISA.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 8: Tax Status**

The IRS has determined and informed the Plan by a letter dated August 7, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
