As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended April 30, 2025 and 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with the modified cash basis of accounting. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the United Association of Plumbers and Pipefitters Local Union No. 51 Health and Welfare Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. DESCRIPTION OF PLAN

The following description of the United Association of Plumbers and Pipefitters Local Union No. 51 Health and Welfare Plan (the “Plan”) is provided for general information. Participants should refer to the summary plan description for more complete information.

General

The Plan is a defined benefit plan providing health care coverage for all eligible members of the United Association of Plumbers and Pipefitters Local Union No. 51 (the “Union”) working for employers who have a collective bargaining agreement with the Union. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligible Participant

A member with at least 200 hours in a period of 12 consecutive months or less is deemed to be an eligible participant. Continued eligibility requires a minimum of 130 credited hours worked for each month following initial eligibility.

Benefits

The Plan provides health benefits (medical, prescription drug, and dental), life insurance, vision, and accidental death and dismemberment benefits to eligible participants and their covered dependents. Retired participants are entitled to medical benefits if they have attained at least age 62 and were an eligible participant for the 10 consecutive years immediately prior to their date of retirement. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

All contributions are made by employers in accordance with their collective bargaining agreements with the United Association of Plumbers and Pipefitters Local Union No. 51.

Self-Payments

Participants unable to satisfy Initial Participation or Continued Participation eligibility rules may obtain medical and dental coverage under the Plan by self-paying medical and dental premiums.

1. DESCRIPTION OF PLAN (continued)

Reciprocal Agreement

The Plan participates in a regional agreement where contributions for members of participating funds who work outside their local jurisdiction are reciprocated to their local jurisdiction at the rate in effect at the time.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records and financial statements of the Plan are prepared on the modified cash basis of accounting. Consequently, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when the obligation is incurred. The modifications result in the recording of capital assets and prepaid expenses on the statements of net assets available for benefits. Except for prepaid expenses and appreciation (depreciation) in fair value of investments, all transactions are recognized as either revenue or expenses when cash is received or paid.

Valuation of Investments

Investments in marketable securities with readily determinable fair values and all investments in debt securities are reported at their fair values in the statements of net assets available for benefits. Unrealized gains and losses are included in the statements of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures of net assets and increases and decreases in net assets. Accordingly, actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all short-term investments, with an original maturity of three months or less, to be cash equivalents.

Subsequent Events

The Plan has evaluated subsequent events through February 11, 2026 which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended April 30, 2025.

Actuarial Present Value of Accumulated Fund Benefits

The actuarial present value of accumulated fund benefits is determined by an actuary and is calculated based on results from applying actuarial assumptions to adjust the accumulated fund benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawals, or retirement) between the valuation date and the expected date of payment. The significant assumptions used to determine the actuarial present value of accumulated fund benefits as of April 30, 2025 were:

If the assumed medical trend increased by one percentage point, the obligation would increase by \$7,403,000 for April 30, 2025.

3. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated August 20, 1998, that the Plan and related trust are exempt from income tax under Section 501(a) of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan's management and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

3. TAX STATUS (continued)

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of April 30, 2025, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. RELATED-PARTY TRANSACTIONS

As commented in Note 1, the Plan is maintained pursuant to collective bargaining agreements which include other employee benefit plans. The Plan is related to their other benefit plans through common memberships and some common members of the Board of Trustees.

The Plan pays administration fees to the United Association of Plumbers and Pipefitters Local No. 51 Pension Plan (a related organization) of \$4,900 per month plus 2% of total employer contributions received per month.

The Plan is paying rent at a rate of \$34,506 per year to the United Association of Plumbers and Pipefitters Local No. 51 Realty Corporation (a related organization) for use of premises located at 11 Hemingway Drive, East Providence, Rhode Island (see Note 9).

5. RISKS AND UNCERTAINTIES

The Plan maintains cash accounts at a commercial bank in Rhode Island. The accounts are insured by the Federal Deposit Insurance Corporation (FDIC) up to a maximum of \$250,000 for the non-contingent, ascertainable interest of each plan participant.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to the uncertainty inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

8. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quotes prices that are observable for the assets or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

8. FAIR VALUE MEASUREMENTS (continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at April 30, 2025 and 2024.

Mutual funds – are registered with the Securities and Exchange Commission. Mutual funds are required to publish their daily net asset value (NAV) and to transact at that price and are valued at the daily closing price as reported by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present, by level within the fair value hierarchy, the Plan investment assets at fair value, as of April 30, 2025 and 2024. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

9. LEASE OBLIGATIONS

The United Association of Plumbers and Pipefitters Local Union No. 51 Health and Welfare Plan leases office space from the United Association of Plumbers and Pipefitters Local No. 51 Realty Corporation (the “Realty Corporation”) (a related party) under a five-year, non-cancellable operating lease expiring March 31, 2027. Lease payments for each of the years ended April 30, 2025 and 2024 were \$34,506.

10. BENEFIT OBLIGATIONS

The eligibility rules provide for the payment of insurance premiums for a period of time subsequent to year end for those participants who have accumulated a sufficient number of hours. Such rules permit eligible participants insurance coverage during periods of unemployment. These obligations have been presented in separate statements, as required by FASB ASC 965.

11. FUNDING OF BENEFIT OBLIGATIONS

The Plan’s excess of benefit obligations over net assets at April 30, 2025 and 2024 relates primarily to the post-retirement benefit obligations, the funding of which is not covered by the contribution rate provided by the current funding vehicle. It is expected that the deficiency will be funded through future contributions from the Plan’s sponsor and participants.

12. BANKED HOURS’ LIABILITY

Active participants in the Plan must have 130 hours worked in a month to maintain continuing coverage on the Plan. The Plan allows participants to accumulate hours worked in excess of the 130 hours per month needed to maintain continued coverage and bank these hours to maintain coverage in future periods in which the 130 hours required for coverage is not otherwise met. The maximum number of hours a participant can bank is 1,560, which is equivalent to one full year of coverage. Based on the banked hours report and the coverage rates for April 30, 2025, the banked hours’ liability as of April 30, 2025 was approximately \$8,921,407.
