DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Voss Automotive, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan is a profit-sharing and 401(k) plan established by Voss Automotive, Inc. (the "Sponsor") on January 1, 2006. The Plan is a defined contribution plan covering substantially all employees of the Sponsor who are at least 21 years of age and have completed one month of service. Certain employees are generally excluded from the Plan, including union members, non-resident aliens and temporary employees. Employees are eligible for matching contributions upon being enrolled in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code (the "IRC"). The Plan is administered by the Sponsor. Empower Retirement, LLC and Empower Annuity Insurance Company of America ("Empower") serves as recordkeeper and custodian.

Contributions

Employees eligible to participate in the Plan ("participants") may contribute, on a pre-tax basis or after-tax, subject to IRC limitations, which are adjusted annually by the Internal Revenue Service ("IRS"). Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

The Sponsor makes safe harbor matching contributions equal to 100% of elective deferrals up to 6% of compensation, as defined.

Catch-up contributions for participants meeting IRC age requirements are permitted.

Investment options

The Plan's investment assets are held by Empower Annuity Insurance Company of America (the "Custodian"), the custodian of the Plan's investment assets. Under an arrangement with the Custodian and upon enrollment in the Plan, participants direct all contributions in any whole percentage increment to any of the available funds. Participants may change their allocation among the various investment options at any time.

Participant accounts

Each participant's account is credited with (a) the participant's contributions, (b) the Sponsor's matching on behalf of the participant, and (c) the earnings and losses of the participant's investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in its accounts attributable to salary deferrals including after-tax deferrals, and "catch-up contributions," safe harbor matching and rollover contributions.

Payment of benefits

Upon termination of employment, attainment of retirement age, or for reasons of death or disability, participants may withdraw their vested account balance in the form of a lump sum. Participants still employed with the Employers may withdraw all or a portion of their account balance in accordance with the Plan's provisions, including salary deferral sources and earnings, upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. A participant whose vested account balance does not exceed \$1,000 will receive a lump sum distribution of their vested account balance as soon as administratively feasible following termination. Required minimum distributions (RMDs) are made in accordance with IRC §401(a)(9), as amended by subsequent legislation.

#### Notes receivable from participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum term of repayment for a loan is five years, unless it is for the purchase of a principal residence, in which case the maximum term of repayment is ten years. The loans are secured by the balance in the participant's account and bear interest at fixed rates commensurate with prevailing market rates for similar loans, as determined by the plan administrator at the date of origination. Principal and interest are paid ratably through payroll deductions. A participant may only have two loans outstanding at a time. Interest rates ranged from 4.25% to 9.50% on participant loans outstanding at December 31, 2024 and 2023.

#### Administrative expenses

Administrative expenses consist primarily of fees for recordkeeping and plan administrative services. Such expenses are generally paid by the Sponsor. In limited circumstances, and as permitted by the plan document, administrative expenses may be paid from plan assets and allocated to participant accounts on a pro-rata basis.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional disclosures of fair value measurements. Interest is recorded when earned. Dividends are recorded at the ex-dividend date. Net appreciation in fair value of investments includes realized and unrealized gains and losses on those investments.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are treated as deemed distributions in accordance with IRS regulations and the Plan's provisions when repayment terms are not met. Accrued interest is included in the carrying amount until the loan is deemed distributed. At December 31, 2024 and 2023, the Plan did not have any notes receivable that were deemed distributed due to participant loan defaults.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses incurred to maintain the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Indirect investment-related expenses are included in net appreciation/ depreciation of fair value of investments.

#### Subsequent events

The Sponsor has evaluated subsequent events through February 13, 2026, the date the financial statements were available to be issued.

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

#### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

There were no changes in the methodology used during the year ended December 31, 2024.

- Mutual funds and money market fund: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price, and are deemed to be actively traded.
- Self-directed brokerage accounts, if any, are measured at the fair value of the underlying securities which consist mostly of actively traded stocks, bonds and mutual funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. RELATED PARTY TRANSACTIONS

The Sponsor incurs certain costs on behalf of the Plan and also provides recordkeeping and administrative services to the Plan at no cost.

## 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 7. INCOME TAX STATUS

The Plan utilizes a volume submitter plan document sponsored by Empower Retirement, LLC, who was informed by the Internal Revenue Service (“IRS”) by a letter dated November 14, 2022, that the underlying plan is designed and being operated in accordance with applicable sections of the IRC. Though the Plan has not received a determination from the IRS, the Sponsor and the Plan's tax counsel believe that the Plan is designed and being operated in accordance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress and the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 8. PLAN TERMINATION

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.
