Notes to Financial Statements

1. Description of the Plan

The following description of Standard BioTools Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Standard BioTools, Inc. (the Plan Sponsor, the Company, or the Employer), pursuant to Section 401(a) and related provisions on the Internal Revenue Code (IRC), was established August 1, 2000. The Plan was most recently amended effective April 4, 2022. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan covers most employees of the Company who meet certain eligibility requirements. The Plan is subject to the provisions of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments and the IRC.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 2.0) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan adopted certain new optional withdrawal features and "Super Catch-Up" contribution limit of \$11,250 for those turning 60-63 during any given calendar year. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan Administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee services are provided by Fidelity Management Trust Company (the Trustee), and recordkeeping and administrative services are provided by Fidelity Workplace Services, LLC (Fidelity).

Eligibility

All employees, except employees covered by a collective bargaining agreement, leased employees and nonresident aliens who do not receive any earned income from the Employer which constitutes United States source income, are immediately eligible to make elective deferral contributions and receive Employer contributions.

Participant Contributions

Participants may elect to contribute through payroll deductions amounts up to 90% of their pre-tax or after-tax (as Roth contributions) annual compensation, as defined in the Plan. Participants may additionally contribute voluntary, non-deductible, after-tax amounts of up to 15% of their annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified defined benefit or defined contribution plans. Contributions are subject to regulatory limitations.

Employer Contributions

The Company may make Employer discretionary matching contributions. The Company also has the option to make Employer non-elective discretionary contributions. There were no non-elective discretionary contributions in 2024.

In 2023, the Company matched 100% of each eligible participant's contribution, up to 4% of each eligible participant's compensation not to exceed \$3,500 for the Plan year for individual participants.

Effective January 1, 2024, the discretionary match formula is 100% of elective deferrals, not to exceed 3% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Employer contributions, if any, as well as Plan earnings. Participant accounts are charged with Plan losses and an allocation of administrative expenses that are paid by the Plan, unless paid by the Plan Sponsor. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Employer matching and non-elective contributions, plus earnings thereon, is based on years of vesting service, as defined. Vesting in the Employer matching contributions, plus earnings thereon, is vested immediately. Effective January 1, 2024, Employer non-elective contributions, plus earnings thereon, are vested after three years of vesting service. In the event of death, disability or attaining normal retirement age, participants are immediately vested in all Employer contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants (or participant loans or loans) terms are generally five years or less but may exceed five years if the purpose of the loan is to purchase a principal residence. Participants may only have two loans outstanding at a time. Participant loans are secured by the balance in the participant's account and accrue interest at a rate commensurate with prevailing rates at the time of origination. Principal and interest are generally paid ratably through payroll deductions. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Payment of Benefits

Distributions and withdrawals are payable upon retirement, termination, attainment of the age 59½, financial hardship, disability, or death. If a participant's account balance is less than or equal to \$1,000 upon participant's termination of employment, the balance is distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested.

If a participant's account balance is greater than \$1,000 and less than \$5,000 upon participant's termination of employment, the balance is distributed immediately into an individual retirement account (IRA), unless a direct rollover into another qualified benefit plan or a lump-sum cash payment is requested. If the account balance is \$5,000 or greater, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, installment payments, partial withdrawals, a direct rollover into another qualified plan or postpone payment to a later date and remain in the Plan as described in the Plan documents. Hardship withdrawals of at least \$500 from the participant's deferral contribution account are permissible upon immediate and heavy financial need, as defined by the Plan document. Participants may request in-service distributions from their vested account balance at any time after having attained age 59½.

Forfeitures

Forfeitures of non-vested accounts of terminated participants can be used to reduce Employer contributions or to pay administrative expenses. As of December 31, 2024 and 2023, the forfeiture balance held by the Plan was \$55,102 and \$171,879, respectively. During the year ended December 31, 2024, \$242,843 of forfeitures were used to reduce Employer contributions and \$18,750 of forfeitures were used to reduce administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent liabilities. Actual results could differ from these estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contributions Receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Employer, which is the pay date. Contributions from the Employer are recorded in the year they are earned to coincide with the year in which the Employer records the contributions in its general ledger.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest earned on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds - These funds are valued at the daily closing price as reported on the open market. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Account - These accounts comprise common stock, mutual funds, Exchange Traded Funds, and cash and cash equivalents. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

Common/Collective Trust (CCT) - The CCT is a pooled investment vehicle operated by a bank. The Plan's investment in the CCT is valued at NAV as a practical expedient to fair value based on the value reported by the issuer. The CCT's NAV is not a publicly quoted price in an active market and represents the value of the Plan's interests in the overall value of the CCT. The CCT held by the Plan has a daily redemption frequency, a redemption notice period of 12 months, and no unfunded commitments. This is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

6. Tax Status

The Plan has adopted the Fidelity Basic Plan Document No. 17 sponsored by Fidelity Management & Research Company, an affiliate of the Trustee, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the form of the volume submitter plan is appropriate for use by employers for the benefit of its employees. The Plan sponsor believes that the Plan, as amended, is currently designed and is being operated in accordance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. Subsequent Events

The Plan has evaluated subsequent events through February 17, 2026, the date the financial statements were available for issuance.

Effective January 1, 2025, the Company acquired SomaLogic and the Plan was amended to make SomaLogic a participating employer of the Plan. On May 1, 2025, the SomaLogic, Inc. 401(k) Plan was merged into the Plan, which survived the merger.

Effective January 29, 2026, the Plan was amended to remove SomaLogic as a participating employer in line with the Company's divestment of SomaLogic.

Notes to Financial Statements

1. Description of the Plan

The following description of Standard BioTools Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Standard BioTools, Inc. (the Plan Sponsor, the Company, or the Employer), pursuant to Section 401(a) and related provisions on the Internal Revenue Code (IRC), was established August 1, 2000. The Plan was most recently amended effective April 4, 2022. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan covers most employees of the Company who meet certain eligibility requirements. The Plan is subject to the provisions of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments and the IRC.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 2.0) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan adopted certain new optional withdrawal features and "Super Catch-Up" contribution limit of \$11,250 for those turning 60-63 during any given calendar year. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan Administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee services are provided by Fidelity Management Trust Company (the Trustee), and recordkeeping and administrative services are provided by Fidelity Workplace Services, LLC (Fidelity).

Eligibility

All employees, except employees covered by a collective bargaining agreement, leased employees and nonresident aliens who do not receive any earned income from the Employer which constitutes United States source income, are immediately eligible to make elective deferral contributions and receive Employer contributions.

Participant Contributions

Participants may elect to contribute through payroll deductions amounts up to 90% of their pre-tax or after-tax (as Roth contributions) annual compensation, as defined in the Plan. Participants may additionally contribute voluntary, non-deductible, after-tax amounts of up to 15% of their annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified defined benefit or defined contribution plans. Contributions are subject to regulatory limitations.

Employer Contributions

The Company may make Employer discretionary matching contributions. The Company also has the option to make Employer non-elective discretionary contributions. There were no non-elective discretionary contributions in 2024.

In 2023, the Company matched 100% of each eligible participant's contribution, up to 4% of each eligible participant's compensation not to exceed \$3,500 for the Plan year for individual participants.

Effective January 1, 2024, the discretionary match formula is 100% of elective deferrals, not to exceed 3% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Employer contributions, if any, as well as Plan earnings. Participant accounts are charged with Plan losses and an allocation of administrative expenses that are paid by the Plan, unless paid by the Plan Sponsor. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Employer matching and non-elective contributions, plus earnings thereon, is based on years of vesting service, as defined. Vesting in the Employer matching contributions, plus earnings thereon, is vested immediately. Effective January 1, 2024, Employer non-elective contributions, plus earnings thereon, are vested after three years of vesting service. In the event of death, disability or attaining normal retirement age, participants are immediately vested in all Employer contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants (or participant loans or loans) terms are generally five years or less but may exceed five years if the purpose of the loan is to purchase a principal residence. Participants may only have two loans outstanding at a time. Participant loans are secured by the balance in the participant's account and accrue interest at a rate commensurate with prevailing rates at the time of origination. Principal and interest are generally paid ratably through payroll deductions. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Payment of Benefits

Distributions and withdrawals are payable upon retirement, termination, attainment of the age 59½, financial hardship, disability, or death. If a participant's account balance is less than or equal to \$1,000 upon participant's termination of employment, the balance is distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested.

If a participant's account balance is greater than \$1,000 and less than \$5,000 upon participant's termination of employment, the balance is distributed immediately into an individual retirement account (IRA), unless a direct rollover into another qualified benefit plan or a lump-sum cash payment is requested. If the account balance is \$5,000 or greater, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, installment payments, partial withdrawals, a direct rollover into another qualified plan or postpone payment to a later date and remain in the Plan as described in the Plan documents. Hardship withdrawals of at least \$500 from the participant's deferral contribution account are permissible upon immediate and heavy financial need, as defined by the Plan document. Participants may request in-service distributions from their vested account balance at any time after having attained age 59½.

Forfeitures

Forfeitures of non-vested accounts of terminated participants can be used to reduce Employer contributions or to pay administrative expenses. As of December 31, 2024 and 2023, the forfeiture balance held by the Plan was \$55,102 and \$171,879, respectively. During the year ended December 31, 2024, \$242,843 of forfeitures were used to reduce Employer contributions and \$18,750 of forfeitures were used to reduce administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent liabilities. Actual results could differ from these estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contributions Receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Employer, which is the pay date. Contributions from the Employer are recorded in the year they are earned to coincide with the year in which the Employer records the contributions in its general ledger.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest earned on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds - These funds are valued at the daily closing price as reported on the open market. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Account - These accounts comprise common stock, mutual funds, Exchange Traded Funds, and cash and cash equivalents. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

Common/Collective Trust (CCT) - The CCT is a pooled investment vehicle operated by a bank. The Plan's investment in the CCT is valued at NAV as a practical expedient to fair value based on the value reported by the issuer. The CCT's NAV is not a publicly quoted price in an active market and represents the value of the Plan's interests in the overall value of the CCT. The CCT held by the Plan has a daily redemption frequency, a redemption notice period of 12 months, and no unfunded commitments. This is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

6. Tax Status

The Plan has adopted the Fidelity Basic Plan Document No. 17 sponsored by Fidelity Management & Research Company, an affiliate of the Trustee, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the form of the volume submitter plan is appropriate for use by employers for the benefit of its employees. The Plan sponsor believes that the Plan, as amended, is currently designed and is being operated in accordance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. Subsequent Events

The Plan has evaluated subsequent events through February 17, 2026, the date the financial statements were available for issuance.

Effective January 1, 2025, the Company acquired SomaLogic and the Plan was amended to make SomaLogic a participating employer of the Plan. On May 1, 2025, the SomaLogic, Inc. 401(k) Plan was merged into the Plan, which survived the merger.

Effective January 29, 2026, the Plan was amended to remove SomaLogic as a participating employer in line with the Company's divestment of SomaLogic.
