Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the InterCommunity, Inc 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of InterCommunity, Inc 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of Intercommunity, Inc. (the “Company” or the “Employer”). Employees are eligible to participate in the Plan on the first day of each calendar month of the Plan year; there are no age or service requirements to begin participation. To be eligible to receive Employer profit sharing and Employer matching contributions, participants must have attained the age of twenty-one and credited with 1,000 hours of service within the 12-month period that begins on the participant’s hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and all sections of 401(k) of the Internal Revenue Code (“IRC”).

Contributions - Each year, participants may contribute a percentage of their annual pre-tax and after-tax compensation, as defined by the Plan. Participants may make these contributions up to the limits prescribed by the Internal Revenue Service (“IRS”). The Plan also allows for participants who are 50 years old or older to make catch up contributions up to the limits prescribed by the IRS. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Plan provides for an Employer matching contribution. The Employer matching contribution matches 100 percent of the first 3 percent of salary deferrals of eligible compensation for the Plan years ended June 30, 2024. Beginning July 1, 2024 the Plan has elected a safe harbor matching contribution that matches 100 percent of the first 3 percent of salary deferrals. For the year ended June 30, 2025, the Employer also made a non-elective contribution equal to 3 percent of each eligible participant’s qualifying compensation. The Employer may also make discretionary profit-sharing contributions to the Plan, as defined by the Plan, in an amount that it determines each Plan year. Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant's account is credited with the participant’s and Employer’s safe harbor matching and non-elective contributions and an allocation of Plan earnings and charged with an allocation of administrative and investment management expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investment Options - Upon enrollment in the Plan, a participant may direct Employer and employee contributions in various investment options allowed under the Plan.

Vesting - Participants are fully (100%) vested in all employee contributions plus actual earnings thereon. Participants will be fully (100%) vested in the Company’s profit sharing and matching contribution portions of their account made prior to July 1, 2024 upon completion of 3 credit years of service. Participants are immediately (100%) vested in employer Safe Harbor contributions. Upon death or disability, while still an employee, a participant will become fully (100%) vested in the Company’s profit sharing and matching contribution accounts.

Forfeitures - The non-vested Employer contributions forfeited during a plan year can be used to pay plan expenses or offset Employer contributions and are allocated among the accounts of eligible participants. Non-allocated forfeitures at June 30, 2025 and 2024 are \$33,360 and \$29,087, respectively. For the year ended June 30, 2025, \$18,225 in forfeitures used to pay Plan expenses.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer from/(to) the investments fund to/(from) the loan fund. Loan terms range from 1 to 5 years. The loans are secured by the balance in the participant's account and bear interest of one percent above prime. Principal and interest is paid off ratably through periodic payroll deductions.

NOTE 1 – DESCRIPTION OF THE PLAN - (CONTINUED)

Payment of Benefits – Upon termination of service for any reason, participants can elect to receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. On termination, participants with vested account balances greater than \$1,000 but less than \$5,000 are automatically distributed in accordance with the terms of the Plan.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59 ½ in accordance with the provisions specified in the Plan. The Plan also allows for early retirement benefits by participants who have attained the age 55 and 10 years of service,

Allocation of Investment Income - The net earnings or loss of each fund, including capital gains or losses whether or not realized, are allocated to individual participant accounts in that fund based on the ratio that the value of each participant’s account bears to the value of all accounts in that fund as of the valuation date.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan’s valuation policies, utilizing information provided by Capital Bank and Trust Company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Benefit Payments - Benefit payments are recorded when paid.

Plan Expenses - The Plan is sponsored by the Company. Personnel within the Company perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as plan expenses. Administrative expenses of the Plan, including trustee fees, are paid by the Employer. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Use of Estimates - The preparation of the Plan’s financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events - The Plan has evaluated subsequent events through February 13, 2026, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENT

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques use to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure the fair value at June 30, 2025 and 2024.

Level 1 Fair Value Measurements:

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – TAX STATUS

The Plan is a Dataair Employee Benefit Systems, Inc. ("Dataair") prototype plan. The IRS has informed Dataair that the form of the prototype plan is acceptable under Section 401(a) of the IRC. The Plan is designed to constitute a qualified tax-exempt plan under section 401(a) of the IRC. Although the Plan has been amended since Dataair received the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – RELATED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan provides for participant loans. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company (“Capital Bank”). Capital Bank is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 6 – CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank, the Trustee.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options, in any combination, of specified registered investment companies and funds. The underlying investments held by the registered investment companies may include stocks, bonds, fixed income securities and other investment securities. Such investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the Company contribution portion of their account.

NOTE 9 – RECONCILIATION OF PLAN FINANCIAL STATEMENTS TO FORM 5500

The Annual Return/Report of Employee Benefit Plan (“Form 5500”) is prepared on the modified cash basis. Accordingly, certain balances included on Schedule H (Part I and II) of Form 5500 differ from those included in the financial statements.

Getting paper copies

To withdraw your consent with TRPC

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:
