### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the McNeilus Steel, Inc. 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended September 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2025 and 2024, and for the year ended September 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

#### Note 1. Description of the Plan

The following description of the McNeilus Steel, Inc. 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution 401(k) and profit sharing retirement plan covering substantially all employees of McNeilus Steel, Inc. (the Plan Sponsor, Plan Administrator or employer). The Plan Sponsor has appointed Bell Bank to be the trustee, invest and manage the assets of the Plan, and provide administrative services. The Plan Sponsor is responsible for oversight of the Plan. The Plan Trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance. To be eligible to make salary deferral contributions to the Plan, an employee must be age 18 or older and have completed two months of service. To be eligible for employer matching contributions, employees must complete at least one year of service and be at least 18 years old. To be eligible to receive their share of any employer discretionary profit sharing contributions, employees must be age 18 or older, complete one year of service during the plan year, and be employed on the last day of the plan year. Employees will also share in the profit sharing contribution in the year of termination of employment due to death, permanent disability or retirement after normal retirement age, defined as age 62 by the Plan. An eligible employee enters the Plan on the first day of the Plan quarter following satisfaction of the Plan's eligibility requirements. The Plan is intended to satisfy all of the requirements of a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Employees who elect to participate in the Plan may make pretax and Roth 401(k) salary reduction contributions up to the maximum allowed by the Internal Revenue Service (IRS). In addition, those participants who have attained age 50 prior to the end of the plan year are eligible to make additional catch-up contributions, subject to certain IRS and Plan limitations. Participants may also contribute amounts representing rollover distributions from other qualified plans, subject to certain conditions and limitations specified in the Plan. Unless a participant makes an affirmative election, the Plan Sponsor will automatically withhold 4% of eligible compensation and this percentage increases by 1% per year up to a maximum of 10% of eligible compensation. The Plan Sponsor currently makes discretionary matching contributions of 50% of the first 6% of compensation that the participant contributes to the Plan. The Plan Sponsor may also make a discretionary profit sharing contribution in accordance with the provisions of the Plan. For 2025, the Plan Sponsor elected to make a profit sharing contribution equal to 3% of eligible employee compensation. Contributions are subject to certain limitations.

Contributions to the Plan are allocated to the participant's investment accounts in percentages elected by the participant. A participant may elect to change the future amount and/or allocation of contributions and may make a transfer of funds already allocated to a given investment option.

**Participant accounts:** Individual accounts are maintained for each participant of the Plan. Each participant's account is credited or charged with the participant's contributions and an allocation of the Plan Sponsor's contributions, if any, investment results and administrative expenses that are paid by the Plan. Allocations are based on participant contributions, participant compensation or account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Description of the Plan (Continued)

**Vesting:** Participants are immediately vested in their contributions (including rollover contributions) including actual investment results thereon. A participant is 20% vested in their employer contributions including actual investment results thereon after two years of credited service and continues to vest at 20% each year thereafter until becoming 100% vested after six years of credited service. A participant is also 100% vested in their account on the date they reach normal retirement age, meet the eligibility requirements for early retirement, or become permanently disabled, or if they are employed by the Plan Sponsor at the time of their death.

**Notes to participants:** The Plan does not allow participants to borrow from their accounts.

**Payment of benefits:** A participant's benefits are based on the amount in the participant's account and the vesting policy described previously. Upon termination of service, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account, or installment payments. Distributions of benefits upon termination may become automatically payable if the participant's account balance is \$5,000 or less. If a participant's account balance is \$5,000 or less, and no distribution election is made by the participant, the Plan Sponsor may roll the balance into an individual retirement account for the benefit of the participant. If the participant's account balance is over \$5,000, the participant must provide written consent before any distribution can be made. Voluntary withdrawals of a participant's account balance while still employed by the Plan Sponsor are allowed before attaining age 59½ for reasons of financial hardship. Additionally, in-service distributions of a participant's account upon attaining age 59½ are allowed, subject to the provisions of the Plan.

**Forfeited accounts:** Forfeited nonvested accounts totaled approximately \$62,000 and \$42,000 as of September 30, 2025 and 2024, respectively. During the year ended September 30, 2025, forfeited nonvested accounts were used to pay approximately \$99,000 in administrative expenses.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies, utilizing information provided by the Plan's investment advisors and trustee. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions:** Participant contributions and the related Plan Sponsor matching contributions are recognized in the period the participant contributions are withheld from compensation. Plan Sponsor profit sharing contributions are accrued at Plan year-end.

#### Note 2. Significant Accounting Policies (Continued)

**Payment of benefits:** Benefits are recorded when paid.

**Plan administrative expenses:** Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are paid out of the Plan unless paid by the Plan Sponsor. Investment-related expenses are included as a component of net appreciation or depreciation in fair value of investments presented in the statement of changes in net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through February 6, 2026, the date the financial statements were available to be issued.

#### Note 3. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

#### Note 4. Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities have occurred since September 30, 2025, or will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2025 statement of net assets available for benefits.

#### Note 5. Information Certified or Provided by Bell Bank (Trustee)

The following is a summary of the Plan's asset information as of September 30, 2025 and 2024, and for the year ended September 30, 2025, included throughout the Plan's financial statements and ERISA-required supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year), obtained by management and agreed to or derived from information provided by the trustee, Bell Bank. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

#### Note 6. Fair Value Measurements

The Plan holds certain financial instruments that are required to be measured at fair value on a recurring basis. U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the same term of the financial instrument.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's policy is to recognize transfers in and transfers out as of the actual date of the event or change in circumstances that caused the transfer. For the year ended September 30, 2025, there were no transfers between levels.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2025 and 2024.

**Mutual funds:** Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

**Collective trust funds:** The fair market value of the collective trust funds has been established using the net asset value (NAV) provided by the administrator of the fund under the practical expedient approach and therefore is not assigned to a level in the hierarchy table. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The collective trust funds are not subject to restrictions regarding redemptions, and there are no unfunded commitments to the funds. There are also no restrictions on the NAV price or its equivalent.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 7. Tax Status

The Plan has adopted a defined contribution pre-approved plan sponsored by Newport Group, Inc. The pre-approved plan provider has received an opinion letter from the IRS as to the pre-approved plan's qualified status. This opinion letter has been relied upon by the Plan. The Plan has been amended subsequent to the date of the opinion letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate income tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has no uncertain tax positions that require adjustment to or disclosure in the financial statements. Therefore, no provision or liability for income taxes is included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Related-Party Transactions

Certain Plan investments are managed by Bell Bank. Bell Bank is the trustee, as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the trustee, and other service providers are included in administrative expenses.
