To Whom It May Concern:

On behalf of the Plan Sponsor, this letter respectfully requests a waiver of penalties related to the late filing of the above-referenced 2024 Form 5500. The delay resulted from reasonable cause and occurred despite the exercise of ordinary business care and prudence. The failure was inadvertent, arose during a period of corporate transition and plan termination, and was not due to willful neglect.

The sponsoring company was sold in May 2024. As part of the transaction, all employees were terminated at that time, including the Plan Administrator, David Coonan. Following the sale, the retirement plan was formally terminated in August 2024.

It was the Plan Sponsor's understanding that ADP, the plan's third-party administrator and Form 5500 service provider, would prepare and file the final 2024 Form 5500 as part of their standard termination services and associated fees. The company had historically relied on ADP to prepare Form 5500 filings and had no reason to believe this process would change.

After the sale, because the former Plan Administrator was no longer employed and responsibilities were transitioning as part of the ownership sale, an administrative breakdown in communication occurred. ADP's internal records reflected that the former Plan Administrator would file the Form 5500, while the company understood that ADP remained responsible for completing and submitting the filing as part of their Form 5500 service.

The company continued to monitor the plan's status in good faith. On January 23, 2025, the company accessed the plan record and noted that no outstanding compliance actions were indicated. On January 24, 2025, the company contacted ADP's 401(k) services team directly and spoke with a representative who reconfirmed that the previously paid service fees included preparation and filing of the Form 5500. Based on these confirmations, the company reasonably believed the filing obligation was being handled.

The misunderstanding was not discovered until the company received an email notification on January 27, 2026, from the Department of Labor indicating that the Form 5500 had not been submitted. Upon receiving that notice, the company took immediate steps to correct the filing.

The plan had no ongoing operations, all participants had been terminated, and the delay did not result in harm to plan participants or beneficiaries.

Given the company sale, termination of all employees including the Plan Administrator, formal plan termination, documented reliance on the plan's third-party administrator, and prompt corrective action once the issue was identified, the Plan Sponsor believes the circumstances meet the Department of Labor's standard for reasonable cause relief. The Plan Sponsor has a history of compliance and remains committed to fulfilling all ERISA reporting obligations.

We respectfully request that the Department exercise its discretion to waive any late filing penalties associated with this filing. Thank you for your consideration.
