**NOTE 1 DESCRIPTION OF PLAN**

The following description of the ABLE, Inc. 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all common law employees of ABLE, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the sponsor and trustee – ABLE, Inc. (Company). Third party administrators (Bravera Wealth and Horace Mann Life Insurance Company) maintain the records of the participant data and hold the Plan assets.

**Eligibility**

Employees of the Company are generally eligible to make contributions to the Plan immediately.

To be eligible for employer matching contributions, an employee must complete twelve months of service and be deferring into the Plan.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 403(b)) deferrals. Participants may also contribute amounts representing distributions from another qualified retirement plan or special individual retirement arrangements.

Once eligible, the Company contributes a match with each payroll of the lesser of the individual's unused employee benefit money or the employee contribution amount. The individual's unused employee benefit money is calculated after all Company benefits are chosen.

No further deferral or employer contributions are allowed to be made to the Horace Mann Life Insurance Company individual accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, employer contributions and an allocation of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily. Participants may change their investment options in accordance with the rules established by the Plan Administrator.

**Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the market rate at the time of the loan. The term of the loan cannot exceed five years, unless the loan is for a principal residence. Loans for a principal residence can have a term of up to 15 years. Repayment is made outside of payroll and at a schedule agreed to between the provider and the employee.

**Vesting**

Participants are immediately vested in all contributions plus actual earnings thereon.

**Payment of Benefits**

Upon termination of employment, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments. Distributions in the form of an annuity may be made out of funds held by Horace Mann. In-service distributions are allowed upon the attainment of age 59 1/2. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Plan's providers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participants are assessed separate fees for the administration of loans and distributions. Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of June 30, 2025 and 2024.

Custodial Account – Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Sub-accounts of Variable Annuities: Valued at the net asset value (NAV). The NAV, as provided by the provider, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment strategies for the sub-accounts of variable annuities are as follows:

Bond accounts invest in bonds and are designed to provide regular income from interest paid by the bonds they hold.

Growth accounts include investments that invest in companies the account believes have above-average growth potential (stocks of these companies are often called "growth" stocks). Most underlying holdings are in domestic common stocks. The accounts may make limited use of futures and/or options for the purpose of maintaining equity exposure. These accounts may participate in securities lending.

Value accounts primarily hold stocks that are deemed to be undervalued in price and that are likely to pay dividends.

International accounts invest in European, Pacific, and emerging market stock funds. These funds provide the potential for very high growth, but at the same time have high amounts of risk relative to other funds.

Blended accounts invest primarily in a combination of stocks, bonds, and cash-equivalent investments. Over the long-term, they seek growth of both capital and income.

Specialty accounts include investments that invest in commercial properties, commercial real estate developments, real estate loans, and companies with socially responsible business practices.

**NOTE 5 INDIVIDUAL ANNUITY CONTRACTS WITH INSURANCE COMPANY**

Participants with accounts at Horace Mann maintain individual annuity contracts with Horace Mann Life Insurance Company (Horace Mann). Annuity contracts may have a fixed component and/or a variable component. The fixed component is part of Horace Mann's general account. General account assets are used to support the insurance and annuity obligations of Horace Mann. Therefore, the participants must rely on the financial strength and creditworthiness of Horace Mann for satisfaction of the obligation under the contract. The variable portion of the contract is maintained in separate accounts which is insulated from the general creditors of the issuer. The accounts are credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by Horace Mann. The guaranteed minimum rate of interest on the fixed component is based on a formula established by Horace Mann and is between 1.00% and 4.50%. Any additional interest is not guaranteed.

The fixed component of the annuity contracts is considered to be benefit-responsive. These contracts are included in the financial statements at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Upon termination of the contract, the lump sum surrender value of the participant's account shall be equal to the product of the participant's account accumulation value on the surrender date, reduced by the surrender charge applicable on the surrender date and a market value adjustment. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on Horace Mann's ability to meet its financial obligations. Horace Mann's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 6 PLAN AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of ERISA.

**NOTE 7 INCOME TAX STATUS**

The Plan is a volume submitter plan of CCH Incorporated.

The Internal Revenue Service has determined and informed CCH Incorporated by letter dated March 31, 2017 that the Plan is qualified and the trust established under the Plan is tax-exempt, under appropriate sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan continues to be tax-exempt. Therefore, no provision of income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Bravera Wealth and Horace Mann Life Insurance Company are the providers as defined by the Plan and; therefore, qualify as parties-in-interest. Certain Plan investments are custodial accounts that are managed by Bravera Wealth, and annuities that are managed by Horace Mann Life Insurance Company.

Fees paid by the Plan to the providers for the administrative services amounted to \$16,598 and \$16,396 for the years ended June 30, 2025 and 2024, respectively.

**NOTE 9 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through February 10, 2026, which is the date these financial statements were available to be issued.
