**INDEPENDENT AUDITOR'S REPORT**

**Opinion**

We have audited the financial statements of OPCMIA Local 526 Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of OPCMIA Local 526 Welfare Fund as of May 31, 2025 and 2024, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of OPCMIA Local 526 Welfare Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

**NOTE A - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements have been prepared on the accrual basis of accounting.

**Payment of Benefits** - Benefits are recorded when paid.

**Depreciation/Fixed Assets** - Fixed assets are recorded at cost and are depreciated over the estimated useful life of the individual assets utilizing the straight-line method of depreciation.

**Valuation of Investments** - The Plan's investment contract with Empire Annuity Insurance Co. is valued at fair value which approximates contract value. Contract value represents contributions made under the contract, plus interest at the contract rate less withdrawals and expense charges. Upon contract discontinuance, however, a market value or final experience adjustment may be made by Empire. Investments in Mutual Funds are carried at fair value which generally represents reported market value as of the last business day of the year.

**NOTE B - DESCRIPTION OF PLAN**

The Fund provides health, life insurance, and disability benefits covering all employees working under the jurisdiction of the Cement Masons' Union Local 526, who are employed by an employer who is obligated to make contributions on their behalf to the Fund. The Fund provides health benefits (hospital, comprehensive medical, prescription drug, dental, vision, life insurance and disability benefits) for a six month benefit period to any participant whose account balance and self-pay amount are sufficient to cover the cost of benefits. Initial eligibility for new employees is obtained by working under the jurisdiction of the Union for a contributing employer and accumulating a minimum of \$1,000 in their individual member account within 2 work periods. The Fund also provides benefits to retired members if they meet one of the various eligibility requirements. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The foregoing description of the Fund provides only general information. Employees should refer to the Plan's Summary Plan Description booklet for a more complete description of the Plan's provisions. Copies of the Summary Plan Description booklet are available from the Fund Office.

**NOTE C - ADMINISTRATIVE CHARGE**

Expenses common to this Fund and related funds administered out of the same office are paid by OPCMIA Local 526 Combined Funds Inc., and are then allocated to the related funds.

**NOTE D - ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE E - INCOME TAX STATUS**

The Internal Revenue Service has ruled that the Plan and Trust qualify under Section 501(c)(9) of the Internal Revenue Code and are, therefore, not subject to tax under present income tax law.

**NOTE F - SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through January 31, 2026, the day the financial statements were approved and authorized for issue.

**NOTE G – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024:

*Cash Equivalents* - The carrying value of cash equivalents approximates fair value.

*Registered Investment Companies* - Mutual Funds are valued at the reported net asset value of shares held by the plan at year end.

*Insurance Investment Contracts* - Valued at fair value which approximates contract value. Upon contract discontinuance, a market value or final experience adjustment may be assessed.

**NOTE G - FAIR VALUE MEASUREMENTS (cont.)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE I – RISKS AND UNCERTAINTIES**

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE J - PRIORITIES UPON TERMINATION**

It is the intention of the Trustees to continue the Plan indefinitely. If the Plan were to be terminated by the Trustees, the assets of the Trust Fund would be used for the exclusive benefit of eligible employees to provide benefits and pay fund expenses until exhausted.

**NOTE K – BENEFIT OBLIGATIONS**

1. **Amounts Currently Payable To Or For Participants** – The amount reported as amounts currently payable to or for participants represents benefits incurred prior to May 31st and paid in the subsequent year.
2. **Accumulated Eligibility Credits** – Accumulated eligibility credits of participants are estimated by the plan. Such estimated amounts are reported in the Statement of Plan Benefit Obligations at present value, based on a 2.80 % discount rate.
3. **Postretirement Benefit Obligations** – The fund has no postretirement benefit obligations payable.

**NOTE L – RELATED PARTY TRANSACTIONS**

The Plan entered into an agreement to rent office to the OPCMIA Local 526 Combined Funds at a rate of \$ 2,468 per month. The lease is currently a month to month lease and can be terminated by either party upon 30 days written notice.

The Plan entered into an agreement to rent space to the OPCMIA Local 526 Joint Apprentice Education and Training Fund at a rate of \$ 1,484 per month. The lease is currently a month to month lease and can be terminated by either party upon 30 days written notice.
