Independent Auditors' Report

Opinion

We have audited the financial statements of ISEC, Incorporated Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statement of net assets (deficit) available for benefits as of June 30, 2025, the related statement of changes in net assets (deficit) available for benefits for the year then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the ISEC, Incorporated Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions and are available from the plan administrator.

General

The Plan was formed on July 1, 2024. The Plan is a defined contribution plan covering all eligible full-time employees of ISEC, Incorporated. (the “Company”, “Employer”, or “Plan Sponsor”).

The Plan operates as a leveraged employee stock ownership plan and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (“IRC”) of 1986, as amended, and is subject to the applicable provisions of Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Plan committee. The plan administrator has overall responsibility for the operation and administration of the Plan. The Plan committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. TI Trust serves as the trustee for the Plan (“Trustee”).

The Plan has purchased 57,421 shares of the Company common stock (common stock) using the proceeds of note payable from the Company (see Note 5) and holds the common stock in a trust established under the Plan.

The note payable is collateralized by unallocated shares of common stock and is guaranteed by the Company. The Company has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the Plan. Accordingly, the financial statements of the Plan as of June 30, 2025, and for the year then ended, present separately the assets and liabilities and changes therein pertaining to the accounts of participants with rights in allocated common stock (allocated), and common stock not yet allocated to participants (unallocated).

Eligibility

The Plan allows employees to participate in the Plan after they have reached one year of service, twenty-one years of age, and who were employed on the entry date, provided they completed 1,000 hours of service. Plan eligibility does not include leased employees, nonresident aliens, or those covered by a collective bargaining agreement. Participants enter the Plan on January 1st or July 1st following the date they become eligible. For details on eligibility requirements in the initial year (current year) of the Plan, please consult the plan document, as these requirements differ from the ongoing eligibility requirements disclosed above.

Contributions

The Company is obligated to make contributions in cash or shares of Company stock to the Plan which, when aggregated with the Plan’s dividends, capital gains, and interest earnings, equal the amount necessary to enable the Plan to make regularly scheduled payments of principal and interest due on its notes payable. Employee contributions are not permitted.

Contributions (Continued)

The contribution will be allocated to participant accounts based on the ratio of compensation for each eligible participant to the total compensation of all eligible participants for the plan year. Contributions are recorded as a receivable to the Plan until received. No employer contributions were made during the year ended June 30, 2025.

Vesting

Vesting in the Plan is based on year of continuous service. A participant is 100% vested after five years of service. A participant is also 100% vested if they have reached the normal retirement age or if employment was terminated because of death or disability.

Payment of Benefits

Within one year of the close of the plan year for termination of service due to death, disability, or retirement, and if the total value of the account is \$10,000 or less, the Trustee will pay a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the total value of the account exceeds \$10,000, the Trustee will pay annual installments over a period of 5 years, as defined in the plan document.

For termination of service due to other reasons, a participants vested accrued benefit shall commence one year after the close of the plan year that is the fifth plan year following the plan year in which the participant separated from service, as described in the plan document.

Administrative Expenses

Expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Other expenses for administrative actions required specifically with respect to a participant's account may be allocable specifically to the participant.

Voting Rights

Participants may direct the trustee's voting of the common stock allocated to participants' accounts only with respect to certain extraordinary transactions (such as merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of all or substantially all of the assets of the Company). If participants do not provide the trustee with timely written directions as to the manner in which such common stock is to be voted, the trustee may be directed by the Company as to the manner in which to vote.

Put Option

Under federal income tax regulations, the common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right by a participant to demand that the Company buy any shares of the common stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period not to exceed five years. The purpose of the put option is to ensure that the participants have the ability to ultimately obtain cash.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used by the Plan to pay administrative expenses of the Plan. Any forfeitures not used by the Plan will be allocated as an additional employer contribution for the year in which the forfeiture occurred. There were no forfeitures during the year ended June 30, 2025.

Plan Termination

The Company intends to maintain the Plan indefinitely. However, the Company has reserved the right to terminate the Plan in its discretion at any time. If the Plan is terminated, participants' ownership interest in their account balances will become 100% vested and their account balances will be distributed to them in accordance with the terms of the Plan. Upon termination of the Plan and before liquidation of the trust, the Company shall make a special valuation of the trust.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid. The Company has committed to be released shares of 2,940.20, with a fair market value of \$2,224,318, for the year ended June 30, 2025.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of common stock are recorded on year-end fair value basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASU”) Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

ISEC, Incorporated common stock: The fair value of the common stock held by the Plan is reported at fair value based upon an appraisal, prepared by an independent professional appraiser. This appraisal was based upon the income and market valuation approaches. The appraiser took into account historical and projected financial information and weighted average cost of capital.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - NOTE PAYABLE

On June 13, 2025, the Company loaned \$53,114,425 to the Plan to purchase the Company's common stock. The note payable provides for repayment over 20 years and bears interest rate of 4.5%. Unallocated shares are collateral for the note payable.

NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 4 and 5, the Plan invests in ISEC, Incorporated common stock and has indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As described in Note 1, the Company pays certain plan expenses. The Plan also has a number of service providers. Such providers are parties in interest under ERISA. These transactions are covered by an exemption from the prohibited transactions provisions of ERISA and the IRC.

NOTE 7 - TAX STATUS

The Plan has not obtained a tax determination letter from the Internal Revenue Service ("IRS"); However, the Plan committee and administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
