I am writing to explain the late submission of Form 5500 for Perch Real Estate.

I have consistently filed the Form 5500 accurately and on time in every prior year. For the most recent filing, I worked with my financial advisor to ensure that all requirements were met. Based on the guidance I received, I was advised to file the Form 5500 for the 2025 plan year instead of 2024. As a result, I completed and submitted the form one year ahead in conjunction with the cancellation of our 401(k) plan, under the belief that this satisfied all reporting obligations.
