Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Coach USA, Inc. 401(k) and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Coach USA, Inc. 401(k) and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of the Coach USA, Inc. 401(k) and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

General

The Plan was established effective December 31, 1997 and is a defined contribution plan covering all employees identified in the Plan document as full or part-time employees of Coach USA, Inc. (the Company). The Plan is designed to comply with the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

Plan Amendments

Effective January 1, 2023, the Plan was amended to change the vesting schedule for certain union matching and nonelective contributions made after January 1, 2022.

Effective April 20, 2023, the Plan was amended to allow installment payments as a form of distribution.

Eligibility

Substantially all employees (except those subject to collective bargaining agreements which are covered by this Plan) of the Company who are 18 years of age and have completed one month of service are eligible to participate in the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions of up to 75% of eligible compensation. Employee rollover contributions are also permitted. Participant contributions may be made on a pre-tax or Roth basis. Furthermore, voluntary, nondeductible, after-tax employee contributions up to 10% of compensation are also allowed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All newly eligible employees are automatically enrolled into the Plan at 3% of eligible compensation 35 days after their eligibility date unless they affirmatively elect otherwise.

For nonunion employees, the Company makes a matching contribution equal to 50% of employees' salary deferral amounts on the first 6% of employees' compensation. The Company may make a discretionary nonelective contribution on behalf of nonunion employees who are employed on the last day of the Plan year. The Company did not elect to make a discretionary nonelective contribution for the year ended December 31, 2023. For union employees, the Company makes matching or nonelective contributions as defined by each respective collective bargaining agreement.

All contributions are subject to certain limitations imposed by the Plan and the IRC.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Investment Options

Each participant has the option of directing his or her contributions into any of the various investment options offered by the Plan, which were held at Fidelity Management Trust Company (Fidelity).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings and is charged with certain administrative expenses. Plan earnings or losses are applied to a participant's account balance based on the investment experience of the funds held and the number of shares owned in each fund by the participant.

Vesting

Participants are immediately vested in their deferral and rollover contributions plus earnings or losses thereon. Participants vest in Company contributions based on years of continuous service. Except for certain union employees who are subject to different vesting schedules as defined by the Plan document, participants vest in Company contributions at a rate of 20% for each year of continuous service and are 100% vested after five years of continuous service. Participants are also fully vested upon reaching normal retirement age, death, or total disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loans are repayable over a period not to exceed five years, except for loans for the purchase of a principal residence, which may be offered over a period consistent with commercial home loan practices. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The notes currently bear interest at rates ranging from 4.25% to 9.50%. Participants may only have one loan outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. On termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account as a lump sum distribution or a direct rollover to an eligible retirement plan. Effective April 20, 2023, participants may also elect to receive the value of their vested interest in their account in installment payments. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$1,000, the Plan administrator may distribute such amount in a lump sum payment to the participant without consent of the participant. If the participant's balance is between \$1,000 and \$5,000, the Plan administrator may roll the amount into an individual retirement account on behalf of the participant without the consent of the participant.

Payment of Benefits (Continued)

The Plan also provides for in-service withdrawals by participants who have attained the age of 59½ or who have five years of participation in the Plan. In addition, upon financial hardship, a participant is entitled to the value of his or her deferral accounts which is payable immediately in a lump-sum distribution. Furthermore, a participant may also withdraw from vested profit sharing and matching contributions upon financial hardship.

Forfeited Accounts

Forfeitures are first used to pay administrative expenses under the Plan, and to the extent that forfeitures are not used to reduce administrative expenses under the Plan, as directed by the Plan administrator, forfeitures should be applied to reduce Company contributions. Forfeited nonvested discretionary matching and profit sharing accounts totaled \$3,113 and \$682 at December 31, 2023 and 2022, respectively. Forfeited nonvested matching accounts totaling \$92,011 were used to reduce Company contributions and \$544 were used to pay qualified Plan expenses for the year ended December 31, 2023.

Revenue Sharing

The Plan holds assets in a Plan expense account which receives deposits as a result of a revenue sharing arrangement with Fidelity. During 2023, deposits to the account totaled \$9,591, which are included in other income on the statement of changes in net assets available for benefits. Funds in the account are used to pay qualified Plan expenses. No revenue sharing credits were used to pay Plan expenses for the year ended December 31, 2023. As of December 31, 2023 and 2022, the revenue sharing account balance was \$68,470 and \$57,034, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through January 6, 2025, the date the financial statements were available to be issued.

Information presented in the accompanying statements and schedule as of December 31, 2023 and 2022, and for the year ended December 31, 2023 for investments, notes receivable from participants, investment income, and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Fidelity Management Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value (NAV) practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Money Market and Mutual Funds: Money market and mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Common and Collective Trust: The common and collective trust is composed primarily of fully-benefit responsive investment contracts and is valued at the net asset value of the units held of the collective trust. The NAV is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2023 and 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fidelity serves as the trustee and recordkeeper of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Other parties-in-interest include professional service firms who provide services to the Plan. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan.

NOTE 6 TAX STATUS

The Plan has adopted a preapproved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 8 SUBSEQUENT EVENTS

The Company suspended the matching contributions for non-union employees in January 2024.

On June 11, 2024, Coach USA, Inc., filed a voluntary petition under Chapter 11 of the Bankruptcy Code along with stalking horse bids for various parts of the organization. On October 31, 2024, the Plan was assumed by Bus Company Holdings US, LLC as part of a wider acquisition of certain Coach USA, Inc. assets. Coach USA, Inc. converted to a Chapter 7 filing effective December 31, 2024.

In December 2024, the Plan was amended to change the Plan sponsor to Bus Company Holdings US, LLC, to reflect the change in organizational structure as a result of the bankruptcy filing. In connection with this change, the Plan name changed to Bus Company Holdings US, LLC 401(k) and Savings Plan.

As of the report date, there have been no formal decisions made regarding the future of the Plan.
