Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Woodfords Family Services 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in the notes to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters — Supplemental Schedules Required by ERISA

DESCRIPTION OF PLAN

The following description of the Woodfords Family Services 403(b) (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all eligible employees of Woodfords Family Services (“the Agency”). The Plan was established in 2005 to allow participants to set aside a portion of their compensation on a pre-tax basis and to match a portion of such deferrals with employer contributions on a discretionary basis. The Plan was restated January 1, 2009, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - Employees who are regularly scheduled to work at least 20 hours per week are eligible to make elective deferrals beginning on their date of hire. Such employees are eligible to receive employer matching contributions upon completion of two years of service. An individual is considered to have completed a year of service if he/she has been credited with at least 1,000 hours of service during the first twelve months of employment, and also during the Plan year that begins with the first twelve months of employment, without an intervening break in service. Effective July 1, 2019, the Plan was amended to change the eligibility period for the employer match from two years of service to one year.

Contributions - During the period covered by the Plan, participants may make salary reduction contributions up to the maximum annual limits prescribed by law. Participants may modify salary deferral elections on a daily basis. Participant contributions may also consist of rollovers or transfers from other qualified plans provided they meet the requirements of the Plan as determined by the Plan Administrator.

Beginning on July 1, 2009, the Plan initiated a discretionary match (determined annually) calculated as 50% on the first 2% of deferred compensation. Beginning on September 25, 2016, the Plan’s matching contribution was increased from 50% to 100% on the first 2% of deferred compensation. Beginning January 1, 2019, the Plan’s matching contribution was increased from 100% on the first 2% of deferred compensation to the first 4% of deferred compensation. Effective July 1, 2019, the Plan was amended to discontinue the discretionary match and implement a safe harbor match of 100% on the first 4% of deferred compensation. Effective on the first pay period in July of 2023, the Plan increased its match to a safe harbor match of 100% on the first 5% of deferred compensation.

Participant's Accounts - Each participant’s account is credited with the participant’s contributions, the Agency’s matching contribution, and an allocation of Plan earnings based on account balances.

Benefits - A terminating participant with a vested benefit exceeding \$1,000 is entitled to a distribution, as soon as administratively practicable, upon the participant’s election. In addition, involuntary distributions of vested balances less than \$1,000 will be made upon termination. Minimum distributions are required beginning April 1st of the calendar year following the later of the year in which the participant attains age 73 or retires.

In-service distributions to participants who have not separated from service may be made upon obtaining the age of 59½. Distributions are permitted from the Plan upon death or meeting certain disability or hardship qualifications. Roth deferrals are not available for in-service withdrawals. Participant rollover distributions may be distributed upon request of the employee.

DESCRIPTION OF PLAN, CONTINUED

Vesting - Participants are 100% vested in their own contributions. Matching contributions begin upon completion of one year of service and are 100% vested.

Notes Receivable From Participants - The Plan permits loans of not less than \$1,000 to participants. Effective by a Plan amendment, participants may have multiple loans outstanding at any time. Loans will only be granted upon the occurrence of a financial hardship or specified financial need. Up to 50% of a participant's vested account balance may be borrowed, not to exceed \$50,000, with quarterly principal and interest repayments required. Interest rates on such loans shall equal the Moody's Corporate Bond Yield Average as published for the calendar month ending two months before the date on which the new loan interest rate is effective. Home loans are to be repaid over a period of 20 years; all other loans have a repayment term of no greater than 5 years.

Forfeitures - Portions of employer contributions in which a participant is not fully vested at the time of termination or withdrawal from the Plan are considered forfeited and are used first to pay reasonable Plan expenses and then to apply to employer matching contributions. There were \$309 and \$298 in forfeited non-vested accounts for the years ended June 30, 2025 and 2024, respectively.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted the United States of America.

Operating Expenses - All expenses of maintaining the Plan are paid by Woodfords Family Services, the plan sponsor.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's personnel committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See "Fair Value Measurements" footnote for discussion of such measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold during the year as well as held at year end.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. All outstanding notes receivable are considered fully collectible, thus an allowance for credit losses is not considered necessary at June 30, 2025 and 2024.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through February 17, 2026, which is the date the financial statements were available to be issued.

On October 1, 2025, the amount of service fees charged to the Plan by the Custodian was amended. The contract will assess an Annual Asset-Based Service fee of 0.75% and calculate it across all funds on a quarterly basis.

INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified by Voya Retirement Insurance and Annuity Company, the custodian of the Plan, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$9,748,535 and \$8,071,523 as of June 30, 2025 and 2024, respectively.
- b. Investment income as shown in the accompanying statements of changes in net assets available for benefits consisting of \$1,206,404 and \$1,076,010 in net appreciation in fair value of investments, \$1,079 and \$2,198 in interest and dividend income from investments at contract value, and \$1,236 and \$18 in interest on notes receivables from participants for the years ended June 30, 2025 and 2024, respectively.

FAIR VALUE MEASUREMENTS

FASB ASC 820-10 *Fair Value Measurement and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Accordingly, the three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs include quoted prices for similar or identical assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at June 30, 2025 and 2024.

FAIR VALUE MEASUREMENTS, CONTINUED

In accordance with FASB ASC 820-10 *Fair Value Measurement and Disclosures*, investments for which fair value is measured using the net asset value per share as a practical expedient are not categorized within the fair value hierarchy below. The Plan had no assets measured using the net asset value per share as a practical expedient at June 30, 2025 and 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

GUARANTEED INVESTMENT CONTRACT

The Plan's portfolio includes traditional investment contracts that meet the criteria for fully benefit-responsive. Traditional investment contracts held by the Plan are guaranteed investment contracts, whereby the contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The average yield and crediting interest rate for the contracts was approximately 4% for 2025 and 3% for 2024. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3%.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement to be included in the financial statements, because this is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan. The Plan administrator believes that contract value approximates fair value for these investment contracts. A crediting rate is established for amounts invested in the investment accounts and participants may ordinarily direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees.

GUARANTEED INVESTMENT CONTRACT, CONTINUED

Certain events may limit the ability of the Plan to transact at contract value with the contract issuer, including: 1) termination of the contracts by the Plan; 2) Plan termination; and 3) Plan sponsor events that would affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer or the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle for an amount that differs from contract value. Examples of possible events include: 1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code 2) termination of the contracts 3) Plan termination or 4) a material breach of contract by the Plan.

PARTY-IN-INTEREST

Voya Retirement Insurance and Annuity Company is the Custodian of the Plan. The Custodian holds and manages the Plan's assets and makes distributions in accordance with the instructions of the Agency. Some of these investments are shares of funds managed by the Custodian. For the year ended June 30, 2025 and 2024, there were fees of \$77,539 and \$61,480, respectively, paid by the Plan for the investment management services. In addition, certain distributions made by the Custodian are in the form of notes receivable to the Plan's participants. These distributions are also considered to be party-in-interest transactions.

PLAN TERMINATION

While the Agency has not expressed any intent to terminate the Plan, it is able to do so at any time subject to the provisions of ERISA. In such an event, net assets of the Plan are to be distributed to participants by the Plan's Custodian.

TAX EXEMPT STATUS

A 403(b) plan, also known as a tax-sheltered annuity (TSA) plan, is a retirement plan for employees of certain public schools, tax-exempt organizations, and ministries. Such plans are exempt from federal income taxes.

The Internal Revenue Service has announced its intention to establish a determination letter program for 403(b) plans, although as of the date of this report no such program has yet been implemented. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and/or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Form 5500 is prepared on the cash basis, which is a different method of accounting than is used to prepare the financial statements.
