I am submitting this letter to request reasonable cause relief for the late filing of Form 5500 for the NovaMac Inc. 401(k) Plan (Plan No. 297636) for the 2024 plan year.

The failure to file on time was not due to willful neglect. In 2024, I suffered a sudden heart attack that required emergency, life-saving quadruple bypass surgery, followed by an extended and medically intensive recovery period. During this time, I was unable to manage business operations or attend to administrative obligations, including the Form 5500 filing.

As soon as I became aware of the missed filing, I took immediate steps to correct the issue and ensure compliance going forward.

I respectfully request that the Department of Labor accept this explanation as reasonable cause for the delay and waive any associated penalties.
