## Notes to Financial Statements

- 1. Description of the Plan** The following description of the The Ginn Group, Inc. 401(k) Profit Sharing & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of The Ginn Group, Inc. (the "Company") who are at least 21 years old, except for nonresident aliens. Employees may enter the Plan on the first day of the quarter coinciding with or the next following quarter the eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for discretionary matching contributions. During 2024, the Company contributed 50 percent of the first six percent of compensation that a participant contributed to the Plan. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in all contributions, plus actual earnings thereon.

**Payment of benefits:** Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installment, and partial payments.

### 2. Significant accounting policies

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Investment consulting fees are also charged to participants based on account balances.

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Cash:** For purposes of financial statement presentation, the Plan considers all highly liquid debt instruments with initial maturities of ninety days or less to be cash equivalents. The Plan maintains cash balances at a financial institution that can exceed the FDIC insured deposit limit of \$250,000 per financial institution. At December 31, 2024 and 2023, the Plan's cash balances did not exceed the FDIC limit. The Plan has not experienced any losses through the date when the financial statements were available to be issued.

**Contributions:** Participant contributions and the related Company discretionary matching contributions, if any, are recognized in the period the participant contribution is withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through February 12, 2026, which is the date the financial statements were available to be issued.

- 3. Certified information** Certain information related to investments and cash disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the insurance company of the Plan.
- 4. Fair value measurements** Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the units of pooled separate accounts is based on the net asset value (“NAV”) on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the insurance company based on the fair value of the underlying assets in the account, less the liabilities.

All investments of the Plan are measured using net asset value as the practical expedient to estimate fair value and therefore, are not subject to the fair value hierarchy. The investments of the Plan are classified into different risk categories. The investment objective of the conservative accounts is to seek a high level of current income with some consideration given to growth of capital. Income accounts seek to maximize total return consisting of current income and capital appreciation. Growth and aggressive growth accounts seek long term growth of capital. Target risk accounts seek the highest potential returns within defined risk parameters. Target date accounts seek high return through the portfolio's target retirement date.

Investments in most pooled separate accounts can be redeemed immediately at the current net asset value to meet participant-initiated withdrawals. John Hancock Life Insurance Company (U.S.A.) may delay participant-initiated withdrawals from the John Hancock Stable Value Fund for up to thirty days if immediate withdrawal would have an adverse impact on the fund. Up to twelve months advance written notice may be required prior to sponsor redemption of the John Hancock Stable Value Fund, determined by John Hancock Life Insurance Company (U.S.A.). There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

- 5. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 6. Plan termination** In 2024, the Company experienced a reduction in workforce that resulted in a partial plan termination as defined by Internal Revenue Service guidelines. The Plan provides for immediate vesting in all contributions, therefore all affected participants were fully vested in their balances as of the partial plan termination date. See Note 9 for information regarding the Plan's termination in 2025.
- 7. Tax status** The Plan is a pre-approved plan of Retirement Plan Administrators, LLC which received an opinion letter on November 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 8. Party-in-interest transactions** Certain Plan investments are managed by affiliates of John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the insurance company and recordkeeper as defined by the Plan. Administrative fees paid to the investment advisors and the recordkeeper amounted to approximately \$54,000 for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.
- 9. Subsequent event** In August 2025, the Company elected to terminate the Plan effective August 15, 2025. All contributions ceased effective with the Plan termination. The Plan provides for immediate vesting in all contributions, therefore all participants were fully vested in their balances as of August 15, 2025. The final participant accounts and Plan assets were distributed in December 2025.


