## NOTES TO FINANCIAL STATEMENTS

September 30, 2025 and 2024

### 1. Description of Plan

The following description of the Granite Edvance 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was established by Granite State Management & Resources (GSMR) and was restated January 1, 2009. On April 1, 2020, the operations of GSMR were merged into New Hampshire Higher Education Loan Corporation, now known as Granite Edvance Corporation (the Company or the Plan Sponsor). Upon merger, the Company changed the name of the Plan from the Granite State Management & Resources 403(b) Retirement Plan to the New Hampshire Higher Education Loan Corporation 403(b) Retirement Plan. On November 1, 2023, the name of the Plan changed to the Granite Edvance 403(b) Retirement Plan. The Plan is a defined contribution plan qualified under Section 403(b) of the United States Internal Revenue Code (the Code) covering eligible employees of the Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required.

#### Eligibility and Participation

Employees become eligible to participate in the Plan on their date of hire if they are expected to work at least 20 hours per week.

The SECURE 2.0 Act expanded eligibility for certain long-term part-time (LTPT) employees. Effective October 1, 2024, part-time employees who have completed at least 500 hours of service in the three most recent consecutive years are eligible to participate in the Plan. Effective October 1, 2025, the requirement is being reduced from three to the two most recent consecutive years.

#### Contributions

Eligible employees may elect to contribute up to 100% of their individual eligible compensation, on a pretax basis, pursuant to the Code Section 403(b) and subject to the maximum amount allowable under United States federal income tax regulations. Participants who are at least age 50 by the end of the Plan year may also make a catch-up contribution of up to \$7,500 in 2025 and 2024. Effective January 1, 2025, participants who are between age 60 and 63 are permitted to make additional catch-up contributions up to the greater of \$10,000 or 50% more than the normal age 50 catch-up limit.

### 1. Description of Plan (Continued)

The Company matches 100% of eligible employees' elective deferrals, not to exceed 3%, on a per payroll period basis. Employees become eligible to participate in the employer match on the anniversary date that such employee has completed six months of service and is at least twenty-one years of age. In addition, each year, the Company may make a discretionary contribution to the Plan which is determined by the Board of Trustees of the Company on an annual basis. In 2025 and 2024, the Board authorized discretionary contributions totaling 2% of total eligible compensation for the year, subject to Internal Revenue Service (IRS) limitations, of all participants eligible to receive an allocation. All discretionary contributions are allocated to participants uniformly based upon relative compensation. Discretionary contributions are only allocated to eligible employees who have fulfilled the minimum hours worked (greater than 20 hours per week), completed two years of service (each consisting of 1,000 hours of service measured over a 12-month period) and are at least twenty-one years of age.

Rollover contributions are subject to conditions stated in the Plan and in appropriate sections of the Code.

Participants elect to have their employee elective deferral and their respective employer contributions invested in various money market and mutual funds included in the Plan, as well as a stable value collective trust fund, each of which have different investment objectives. Participants may change investment options at any time during the Plan year.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions on their behalf. Participant accounts can fluctuate based on the market value of the particular mutual, money market, and stable value collective trust funds in which the participant invests, and earnings or losses thereon. Expenses are deducted from each participant's account, and expenses are dependent on the mutual, money market, and stable value collective trust funds selected by each participant.

#### Benefits

Upon death, retirement, disability, or termination of employment for any other reason, the participant is entitled to receive the vested amount of his or her account. Participants are permitted to make hardship withdrawals from their account, as defined in the Plan document. Participants may also withdraw any part of their rollover contributions in the Plan, at any time and at any age. In addition, participants who have attained the age of 59 ½ may elect to withdraw all or part of their vested account balance from the Plan without penalty. The Plan allows the Plan Administrator to automatically distribute to terminated participants their entire vested balance which does not exceed \$1,000. The Plan allows the Plan Administrator to automatically distribute to terminated participants their entire vested balance which does not exceed \$5,000 in the form of an automatic rollover into an individual retirement account. Effective December 4, 2024, the automatic cash out limit for terminated participants increased to \$7,000.

#### Vesting

Participants are immediately vested in their contributions, all employer contributions, rollover accounts and any earnings thereon.

### 1. **Description of Plan (Continued)**

#### *Notes Receivable from Participants*

Loans may be granted to participants in accordance with provisions outlined in the Plan document. In no event shall the total of any such loan to any participant be less than \$1,000 or exceed the lesser of (a) fifty percent of the participant's vested interest in his or her account, or (b) \$50,000. A participant may have only two loans outstanding at any given time. No loan shall be for a term exceeding five years, unless the loan proceeds are used to acquire a primary residence, in which case the term of the loan shall not exceed fifteen years. The loans are secured by up to 50% of the vested balance of the participant's account. Principal and interest are to be repaid on at least a quarterly basis by the participant. Participant loans bear interest at the Prime rate, in effect at the date the loan is granted, plus 1%. The interest rate on all loans outstanding at September 30, 2025 ranged from 4.25% to 9.50% with various maturities through September 2030.

#### *Administrative Expenses*

Substantially all fees for managing the Plan and administrative fees are paid directly by the Company. Certain fees incurred by the Plan, related to investment management services, are included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan are for participant requested services.

### 2. **Summary of Significant Accounting Policies**

The accounting and reporting policies of the Plan conform with accounting principles generally accepted in the United States of America. The following describes more significant policies:

#### *Basis of Accounting*

The financial statements of the Plan have been prepared on the accrual basis.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, as described in Note 4. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses related to investments are reported as net appreciation in fair value of investments.

#### *Notes Receivable From Participants*

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis, unless amounts are immaterial. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2025 or 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### Benefit Payments

Benefit payments are recorded upon distribution.

#### Contributions

Contributions from participants are recorded in the period in which payroll deductions are made. Employer matching contributions, as well as discretionary contributions, are recorded in the same period as the corresponding participant contributions.

#### Management Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements, the reported amounts of changes in net assets available for benefits during the reporting period and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investments, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Subsequent Events

Events occurring after the statements of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through January 26, 2026, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Charles Schwab Trust Bank, the Plan's custodian, as of and for the years ended September 30, 2025 and 2024, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the custodian, as of and for the years ended September 30, 2025 and 2024, stating that the information provided to the Plan Administrator by the custodian is complete and accurate. Such certified Plan information includes investments, notes receivable from participants, net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, investment transactions and notes receivable transactions.

### 4. Fair Value Measurements

The Plan has adopted the framework for measuring fair value under generally accepted accounting principles.

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at September 30, 2025 and 2024.

*Mutual and money market funds* – Valued at the closing price reported in the active exchange market in which the security is traded.

*Stable value collective trust fund* – A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units in the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Party-in-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the Plan's record keeper, USI Consulting Group, expenses paid to the Plan's third-party administrators out of Plan assets, and notes receivable from participants are considered party-in-interest transactions. Total third-party administrative and recordkeeper expenses of \$8,665 and \$9,418 were paid out of Plan assets for the years ended September 30, 2025 and 2024, respectively.

### 6. Reconciliation of Financial Statements to Form 5500

Notes receivable from participants are reflected as a receivable on the statements of net assets available for benefits which differs from the Form 5500 presentation. On the Form 5500, notes receivable from participants are classified as investments under the caption "participant loans."

### 7. Tax Status

The Plan has adopted a volume submitter 403(b) plan document sponsored by USI Consulting Group. The volume submitter plan provider has received an opinion letter from the IRS, dated March 31, 2017, as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

7. **Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA.
