### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Elliott Electric Supply, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). In their report dated July 29, 2024, they indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). ## Elliott Electric Supply, Inc. 401(k) Plan Notes to the Financial Statements

### Note A: DESCRIPTION OF PLAN

The following description of Elliott Electric Supply, Inc. ("Company") 401(k) Plan ("Plan") provides only general information. For a more complete description of the Plan's provisions, refer to the Plan agreement.

#### General

The Plan is a defined contribution plan, covering all full-time employees of the Company who have completed six months of service and have reached age twenty. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Some administrative functions are preformed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Principal Trust Company, the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the retirement committee and provides certain recordkeeping services. Principal acts as third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

#### Contributions and Forfeitures

Each year, the Company may contribute to the profit sharing portion of the Plan an amount determined by management.

Additionally, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes a discretionary matching contribution of 50% of the first 6% that a participant contributes to the Plan. The Company shall set such percentage prior to the end of the plan year. Contributions are subject to certain limitations.

Profit sharing contributions and forfeitures are allocated pro rata based on compensation, as defined by the Plan.

The amount of unallocated forfeitures at December 31, 2024 and 2023 was \$354, and \$43, respectively. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions are to be allocated to participants as of the last day of the Plan year in which such forfeitures are determined.

### **Note A: DESCRIPTION OF PLAN (Continued)**

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on compensation and account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the company contributions portion of their accounts plus earnings thereon is based on years of credited service. A participant is 100 percent vested after six years of credited service.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. The participant may request a distribution at the time of termination, or he or she may elect to leave the account invested in the Plan until a later date if his or her account value exceeds \$5,000. If the value is over \$1,000 but less than or equal to \$5,000 and no distribution instructions have been received from the participant, the Company may issue a cash distribution to the participant. If the value is less than or equal to \$1,000, the Company may transfer such amount into an individual retirement account (IRA). Current Plan rules require that the required minimum distributions to participants must generally begin no later than the April first following the year in which the participant reaches age 73.

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

#### **Investment Options**

Participants direct the investment of both their contributions and the employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, various pooled separate accounts and a stable value fund as investment options for participants. Participants may change their investment options daily.

### **Note B: SUMMARY OF ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in all material respects.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

## **Elliott Electric Supply, Inc. 401(k) Plan Notes to the Financial Statements (Continued)**

### **Note B: SUMMARY OF ACCOUNTING POLICIES (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are calculated on a specific identification basis. Unrealized appreciation and depreciation of investments are reported on an identified cost basis. Realized and unrealized gains and losses are reported as part of net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

#### **Excess Contributions Payable**

Excess Contributions Payable to participants for the year ended December 31, 2024 and 2023 amounted to \$1,232,913 and \$603,097, respectively. These contributions are in excess of amounts allowed by the IRS and are recorded as a payable, with a corresponding reduction to 2024 and 2023 contributions. The Plan distributed the 2024 and 2023 excess contributions prior to April 15, 2025 and 2024, respectively.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Operating Expenses**

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees paid to third party administrators are included in administrative expenses and allocated to participant's accounts. Distribution fees are charged directly to the participant's accounts.

#### **Risk and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **Subsequent Events**

Management has evaluated subsequent events through February 13, 2026, the date that the financial statements were available to be issued and determined there were no events that occurred that require disclosure.

### Note C: FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurements authoritative literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels as follows:

- Level 1 - quoted prices in active markets of identical assets
- Level 2 - other significant observable inputs either directly or indirectly (including quoted prices for similar securities, interest rates, yield curves, credit risk, etc.)
- Level 3 - significant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled Separate Accounts** - Accounts are valued at a calculated unit value that is based on the observable net asset value (NAV) of the underlying mutual funds. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

**Mutual Funds** - Valued at the daily closing price as reported by the fund. Mutual funds held (registered investment company) by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Investment Trust Fund** - A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value which is based on contract value. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 1 day notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits at December 31, 2024 and 2023.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### Note E: TAX STATUS

The Internal Revenue Service has issued an opinion and informed Principal Life Insurance Company Non-Standard Pre-Approved Profit-Sharing Plan with CODA by letter dated June 30, 2020, that this Prototype Plan is acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### Note F: ADMINISTRATION OF PLAN ASSETS

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee (or the Company) receives compensation from the Plan. The Company also pays a portion of the Plan's administrative expenses.

### Note G: INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

### **Note I: PARTY-IN-INTEREST**

The Plan invests in a common/collective trust fund and pooled separate accounts managed by Principal Financial Group, an affiliate of the Trustee. As such, transactions related to these investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

The Trustee of the Plan (Principal Trust Company) charges the Plan an administrative fee. The Trustee also charges transaction fees to participants in the Plan for such services as distributions, hardship withdrawals and qualified domestic relations orders. The total fees that the Plan paid to the Trustee for the year ending December 31, 2024 amounted to \$226,024.
