Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of the Myers Industries, Inc., the Plan's sponsor, determined in October 2023 to terminate the Plan with an effective date of March 31, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan is presenting the financial statements to the liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

The Pension Agreement between Akro-Mils, Incorporated and USWA Local Union No. 1761-02

1 Description of Plan

The following description of The Pension Agreement between Akro-Mils, Incorporated and USWA Local Union No. 1761-02 provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which was restated January 1, 2006, is a defined benefit plan covering all bargaining unit employees covered by the contract between Akro-Mils, a division of Myers Industries, Inc. ("Company") and the United Steel Workers of America ("USWA") Local Union No. 1761-02 ("Union") who meet the service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

As of December 31, 2009, the Plan merged with a related pension plan (The Buckhorn, Inc. Pension Plan for Dawson Springs Employees Defined Benefit Retirement Plan). Benefit obligations remained unchanged as a result of the merger.

In 2007, Buckhorn closed the facility at which all of the participants of the Plan were employed. All participants affected by the closure accrued benefits through their termination date and are fully vested in their total accrued benefits.

In 2005, Akro-Mils closed the facility at which all of the participants of the Plan were employed. All participants affected by the closure accrued benefits through their termination date and are fully vested in their total accrued benefits.

In October 2023, the Compensation and Management Development Committee of the Board of Directors approved the Plan for termination with an effective date of March 31, 2024 to fund the remaining payments to retirees through an annuity contract. Participants were notified and the Plan was terminated effective March 31, 2024, subject to regulatory approval. In addition, the Plan was amended and restated effective March 31, 2024 to include all prior amendments and restatements; update provisions for regulatory requirements; and termination of the Plan.

The plan was amended as of February 20, 2025 to update the policy for lump sum payments. In April 2025, the Plan funded the annuity contract to pay remaining retiree benefits and Plan assets were reduced to zero in May 2025.

Eligibility:

An employee becomes eligible to participate in the Plan after they have completed a probationary period of 60 calendar days with the Company. There are no age requirements to participate in the Plan. Since the closure of the Akro-Mils and Buckhorn facilities, no new participants are eligible to participate in the Plan.

2 Summary of Significant Accounting Policies

Funding Policy:

Contributions to provide benefits under the Plan are made solely by the Company. The Company's funding policy is to make cash contributions to the Plan in amounts computed by the Plan's actuary using the unit credit cost method. This method and the actuarial assumptions referred to in Note 5 have been designed to provide sufficient funds to pay benefits as they become payable under the Plan. The Company met the minimum funding requirements of ERISA in 2025 and 2024.

Basis of Accounting:

The Plan's transactions are reported on the liquidation basis of accounting. There have been no changes to the fair values for the changes to liquidation basis of accounting in the current year.

Investments:

Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Actuarial Present Value of Accumulated Plan Benefits:

Accumulated Plan benefits represent future periodic payments for services employees have rendered. Accumulated Plan benefits include benefits expected to be paid to:

- a) Retired or terminated employees or their beneficiaries.
- b) Beneficiaries of employees who have died.

Administrative Fees:

Administrative expenses represent Trustee and actuarial fees charged to the Plan. Certain other administrative functions are being performed or paid by the Company on behalf of the Plan.

2 Summary of Significant Accounting Policies, Continued

Payment of Benefits:

Benefit payments to participants are recorded when paid.

Plan Termination:

The Company reserves the right to terminate the Plan subject to the provisions of ERISA. The Plan has been terminated in 2024, and each affected participant became fully vested in their accrued benefit and the net assets of the Plan will be allocated for payment of Plan benefits to the participant in an order of priority determined in accordance with ERISA, applicable regulations thereunder and the Plan document.

The Pension Benefit Guaranty Corporation ("PBGC") insures certain benefits under the Plan if the Plan terminates. Generally, PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor pensions. However, PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan termination, subject to a statutory ceiling on the amount of an individual's monthly benefit.

When the Plan terminates, its net assets generally will not be available on a pro-rata basis to provide participants' benefits. Whether a particular participant's accumulated Plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and PBGC guaranty while other benefits may not be provided for at all. See Note 1 for annuitizing the Plan.

Risks and Uncertainties:

The Plan's investment includes investments in mutual funds and pooled separate accounts with varying degrees of risk, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Plan contributions and the actuarial present value of accumulated Plan benefits are prepared based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through February 2, 2026, which is the date the financial statements were available to be issued.

3 Tax Status

On August 22, 2024, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of May 31, 2025, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and December 31, 2024.

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices and are classified as Level 1.

Pooled Separate Accounts:

The fair values of the pooled separate accounts are based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. These fall into the Level 2 category of the valuation hierarchy. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments of the plan for these funds. The pooled separate accounts invest in various investment strategies as defined by the underlying mutual funds of the investments.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of May 31, 2025 and December 31, 2024. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

5 Accumulated Plan Benefits

The Plan's actuary, Principal, estimates the actuarial present value of accumulated Plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.
