Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Durham City Transit Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1—Description of the Plan

The following description of the Durham City Transit Company (the “Company”) 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan sponsored by the Company, a subsidiary of First Transit, Inc.

Employees of the Company covered under the collective bargaining agreement, who have attained the age of 21, have completed at least six months of employment and are not highly compensated, are eligible to participate. An employee may participate in the Plan on the first day of the month following satisfaction of the Plan’s eligibility requirements.

Effective August 1, 2021, the Plan was amended to reflect a change in Trustee and Recordkeeper from Ascensus Trust Company to Principal Trust Company.

Contributions – Each year, participants may contribute up to 100% of annual compensation, subject to legal limitations, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Company matches contributions equal to 10% of up to 3% of the participant’s eligible compensation. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations. Effective September 8, 2021, the employer-matching contributions were increased to 25% of the first 3% of employee deferral on eligible earnings.

Participant Accounts – Each participant’s account is credited with the participant’s salary deferral contribution and Company-matching contributions, as well as allocations of Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested immediately in their contributions and the Company-matching contributions plus actual earnings thereon and are entitled to receive the full value of their accounts upon termination of employment with the Company.

Investment Options – Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of various investment options. Participants may change their investment allocations and contributions at any time.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance under the Plan. Participants are allowed a maximum of two loans outstanding from the Plan at one time. Loan amounts must be repaid over a period not to exceed five years from the date of issuance unless the loan was obtained for the purpose of purchasing a primary residence. Principal and interest is paid ratably through bi-weekly payroll deductions. Should a participant terminate employment, the outstanding loan principal, plus accrued interest, shall become due immediately. Interest is calculated using the prime rate published in the Wall Street Journal plus 2.00%. The interest rate for the notes receivable at December 31, 2021 ranged from 5.25% to 7.50%. The loans are secured by the vested balance in the participant’s account. Loans mature through August 2026.

Note 1—Description of the Plan (continued)

Payment of Benefits – Upon termination of service due to death, disability, or normal retirement, participants with account balances of \$5,000 or greater may elect to receive a lump sum, partial payments, installment payments, or annuity contracts (other than life annuity). Participants with account balances under \$5,000 may only receive a lump-sum payment. Participants may also take distributions prior to termination of employment if the participant has attained age 59½. Distributions for hardships are allowed from the participant's balance upon meeting the financial burden statutory requirements. For amounts withdrawn under financial hardship prior to age 59½, certain income tax penalties may apply.

Transfers Out of the Plan – During the year ended December 31, 2021, \$4,943 was transferred out of the Plan into another Durham City Transit Company retirement plan.

Transfer From Prior Trustee – During the year ended December 31, 2021 \$668 was transferred from Prior Trustee.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, Ascensus Trust Company and Principal Trust Company, the "Trustees" of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2021 or 2020. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The Company pays substantially all administrative expenses and investment management fees incurred by the Plan. Administrative expenses include professional fees related to the preparation of the Plan's tax returns, audit fees, and attorney fees. See Note 7 for details of expenses paid out of Plan assets to related parties.

Note 3—Information certified by the Plan's Trustee (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustees of the Plan have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2021 and 2020.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2021.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and schedule of assets (held at end of year).

Note 4—Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this standard are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4—Fair value measurements (continued)

There have been no changes in the methodologies used to value the investments at December 31, 2021 or 2020. Following is a description of the valuation methodologies used for assets measured at fair value:

Collective Investment Trusts – The collective investment trusts are presented at fair value based on the fair value of the underlying investments or discounted cash flow methodology, depending on the underlying investment type. These investments include fixed interest insurance investment contracts, money market funds, mortgage-backed securities, bonds, and other fixed income securities. These funds are required to publish their daily net asset value and transact at that price. The collective investment trusts held by the Plan are deemed to be actively traded.

Money Market Funds – These investments are generally short-term money market funds valued using \$1 for the unit value. The Trustee reports the market and quotes the prices, on a daily basis, that are available to market participants. The investments are valued at amortized cost, which approximates fair value. These are considered Level 2 investments because the inputs used to determine fair value are not quoted prices in an active market.

Mutual Funds – Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are thus considered Level 1 investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Note 5—Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6—Tax status

The Plan uses a prototype plan document sponsored by Principal Trust Company and received an opinion letter from the IRS dated June 30, 2020, which states the prototype document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. The Plan itself has not received a determination letter from the IRS. However, the Plan's administrator and Plan's third party administrator believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2021 and 2020, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Party-in-interest transactions

Principal Trust is the recordkeeper as defined by the Plan and, therefore, qualifies as a party-in-interest. Fees deducted from Plan assets were \$5,638 for the year ended December 31, 2021 for recordkeeping fees. The Plan also pays various indirect fees to various brokers and dealers for maintenance of investment funds. The indirect fees are identified on the Form 5500, Schedule C.

Notes receivables from participants qualify as party-in-interest transactions.

Note 8—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participant account balances are currently 100% vested.

Note 9—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statement of net assets available for benefits date of December 31, 2021 through February 15, 2023, which is the date these financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure.
