- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Marion Body Works, Inc. Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Marion Body Works, Inc. Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is effective January 1, 2022. It is an amendment and restatement of a pre-existing plan which was originally adopted effective January 1, 1986. It is a defined contribution plan covering all employees of Marion Body Works, Inc. (the "Company") except part-time, temporary, seasonal, leased employees, and non-union employees who are classified as Labor Grade 1-10. An employee becomes eligible to participate in the Plan immediately upon completion of three consecutive months of employment with the Company. If an employee does not complete three consecutive months of employment, they are subject to a one-year service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective April 18, 2024, the Plan's recordkeeper was changed from Newport Group, Inc. to Ascensus, LLC and the Plan's Trustee was changed from Newport Trust Company, LLC ("Newport") to Ascensus Trust Company ("Ascensus").

Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

Contributions

Participants are allowed to contribute, on either a pretax or aftertax basis, 100% of annual compensation as defined in the plan document, up to the annual maximum allowed by the Internal Revenue Service (IRS). The Plan also allows Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to roll over distributions from other qualified retirement plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan.

The Company makes a matching contribution to eligible non-union participants equal to 50% of their contributions up to 6% of their pretax annual compensation, plus a discretionary nonelective contribution as determined by the Company. For participants whose employment is governed by a collective bargaining agreement (union employees), the Company makes a matching contribution of up to \$.50 per hour if an employee contributes \$.50 per hour, plus a nonelective contribution equal to \$.50 per hour of service pursuant to the collective bargaining agreement.

Note 1: Description of Plan (Continued)

Contributions (Continued)

Company matching contributions were \$348,892 for the year ended December 31, 2024. Rollovers are not matched. Nonelective contributions to union employees were \$245,317 for the year ended December 31, 2024. There were no discretionary nonelective contributions to non-union employees for the year ended December 31, 2024.

Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, Company nonelective contributions to union employees, and allocations of the Company's discretionary nonelective contribution to non-union employees and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' accounts maintained under the Plan are fully vested, regardless of a participant's years of service.

Notes Receivable From Participants

The Plan does not allow participants to borrow from their fund accounts.

Payment of Benefits

Upon severance of employment due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals or installments (which are only permitted for participants or beneficiaries who must receive required minimum distributions), if the account balance exceeds \$7,000. If the participant's vested account balance does not exceed \$7,000, it may only be distributed as a lump-sum. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Notes to Financial Statements

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan pays administrative expenses, including fees related to the processing of distributions. Administrative expenses are allocated proportionately to plan participants based on their respective account balances and distribution fees are charged directly to the respective participant's account. Investment-related expense are also allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There has been a change in the methodology used for the Large Cap Growth Fund III Class R1 Fund, Mid Cap Value Fund, and the Mid Cap Growth Fund II Class R1 as of December 31, 2024, due to a change in information provided by the fund issuers. The Large Cap Growth Fund III Class R1, Mid Cap Value Fund, and the Mid Cap Growth Fund II Class R1 are now included in the common/collective trust funds in the following disclosure, but were previously included in mutual funds. There was no change to the level in which these investments are presented in the table below. There have been no changes in the methodologies used as of December 31, 2023.

Interest-bearing cash (money market fund): Valued at net asset value (NAV).

Mutual funds and common/collective trust funds: Valued at the net asset value (NAV) of shares held by the Plan at year-end. The funds held by the Plan are registered with the U.S. Securities and Exchange Commission and are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded on an open market.

Morley Capital Stable Value Fund CL 3: Valued at fair value by using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end.

Note 4: Information Prepared and Certified by the Trustees

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus as of December 31, 2024, and for the period from April 18, 2024 to December 31, 2024, and Newport as of December 31, 2023, and for the period from January 1, 2024 to April 17, 2024, the Trustees of the Plan.

Note 5: Party-in-Interest Transactions

During 2024, the Plan paid investment advisory and management fees to Strategic Wealth Partners and Charles Schwab Bank. These transactions qualify as party-in-interest transactions.

The Plan also paid administrative fees to Newport Group, Inc. and Ascensus, LLC, the recordkeepers, which constitutes party-in-interest transactions.

Note 6: Plan Termination

Although it has not expressed the intention to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS opinion letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
