## **BROWN & ROOT INDUSTRIAL SERVICES 401(K) PLAN**

### **NOTES TO FINANCIAL STATEMENTS**

#### **1. Description of Plan**

The following description of the Brown & Root Industrial Services 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of Brown & Root Industrial Service, Inc. and its designated participating organization BRIS Engineering (collectively referred to as the Sponsor or the Employer) who are not covered by a collective bargaining agreement as well as certain other provisions covered in the Plan document. Eligible participants are immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The KBR Investment Committee is responsible for overseeing the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The trustee and recordkeeper of the Plan is Vanguard Fiduciary Trust Company.

**Contributions:** Participants may elect to defer up to 75% of eligible compensation on a pre-tax basis or after-tax (Roth) basis, as defined in the Plan document. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. In no event may participant pre-tax and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans.

For each pay period, the Employer shall contribute a safe harbor matching contribution in the amount of 100% of the first 3% plus 50% of the next 2% of employee contributions not to exceed 4% of the participant's eligible compensation. The Employer may also make a discretionary non-elective contribution. For the year ended December 31, 2024, there were no such contributions. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

**Participant Accounts:** Each participant's account is credited with the participant's and the Employer's matching contribution as well as allocations of the Employer's discretionary contribution and Plan earnings (losses). Participants are charged with an allocation of administrative expenses that are charged to the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions and Employer safe harbor matching contributions plus actual earnings thereon. Participants are vested in the Employer discretionary contributions after 3 years of credited service as further described in the Plan document.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 – 5 years, except for loans used for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.25% to 9.50% on outstanding loans at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when incurred.

#### **1. Description of Plan** (continued)

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, joint and survivor or life annuity, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

Forfeitures: At December 31, 2024 and 2023, forfeited accounts totaled \$75,212 and \$71,430, respectively. These accounts are used to pay Plan expenses. During the year ended December 31, 2024, \$212 were used to pay Plan expenses.

#### **2. Summary of Significant Accounting Policies**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The Plan's interest in master trust investment income includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net investment income.

#### **3. Interest in the Master Trusts**

Certain assets of the Plan are combined with the assets of certain other benefit plans of affiliated companies in the Kellogg Brown and Root Master Trust and the Kellogg Brown and Root Employee Benefit Master Trust. The Plan holds a divided interest in the Master Trusts and the interests are passed on to participant account balances. The assets in the master trusts are segregated into funds in which the plans may participate. The Plan is allocated its proportional share of master trusts income and expenses based on the specific assets held by Plan participants. The combination of plans' assets is only for investment purposes and the plans continue to operate separately under their current plan documents, as amended.

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Stable value investments:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. As of December 31, 2024 and 2023, there are no unfunded commitments. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts* - The investments underlying the common/collective trust fund investments generally include shares of equity and fixed income securities whose values are determined on the basis of quoted prices in an active market. The Plan's common/collective trust fund investments are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Participant transactions (purchases and sales) may occur daily. As of December 31, 2024 and 2023, there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Income Tax Status**

The Plan is a qualified cash or deferred arrangement established under Section 401(k) of the Internal Revenue Code and is exempt from income taxes under Section 401(a) of the Internal Revenue Code (IRC). The IRS has determined and informed the Employer by a letter dated June 26, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the tax determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Employer contributions.

#### **7. Related Party and Party in Interest Transactions**

The Plan's investments are composed of securities within a master trust managed by Vanguard Fiduciary Trust Company. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. The Plan paid administrative fees to Vanguard which totaled \$425,506 for the year ended December 31, 2024, and are included in the statement of changes in net assets available for benefits.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024, may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **9. Information Prepared and Certified by the Qualified Institution**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard Fiduciary Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### **10. Mutual Fund Fees**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### **12. Filing Requirement**

The Plan's financial statements for the year ended December 31, 2024, were not completed by the extended Form 5500 filing deadline of October 15, 2025. Management was unable to finalize certain information necessary for the completion of the audit and the related financial statements by the filing deadline. As a result, the Form 5500 filing and the required audited financial statements were submitted after the extended due date.

#### **13. Subsequent Events**

Effective 1/1/2025, the Plan ceased participation in the Kellogg Brown and Root Master Trust and Kellogg Brown and Root Employee Benefit Master Trust. As a result, all Plan assets previously held within the master trust were transferred to individually held investment accounts established exclusively for participants of the Brown and Root Industrial Services 401(k) Plan, in accordance with the Plan's provisions. These accounts are maintained solely for the benefit of this Plan and do not include assets of any other related entities. After this date, the Plan no longer reports an interest in the master trust, and all investments are held and reported directly by the Plan. Plan has evaluated subsequent events through February 16, 2026, the date that the financial statements were available to be issued, and determined no other subsequent events requiring disclosure.
