Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the W-S Industrial Services, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was established effective November 1, 1998, and restated effective January 1, 2022. The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was available to all employees of W-S Industrial Services, Inc., W-S Mechanical Group, LLC, W-S Specialty Services, LLC, H2O Underpressure, LLC, and FSIS (collectively, the “Company”) who were 21 years of age and had completed one year of service in which the employee provided at least 1,000 hours of service.

Plan Termination - On October 15, 2025, the W-S Industrial Services, inc. 401(k) Plan was terminated as a result of the prior acquisition of the Company by Groome Industrial Service Group. Upon termination, participants became fully vested in their account balances. Plan assets were transferred in accordance with the provisions of the Plan and the requirements of the Internal Revenue Code. All participant account balances were transferred to the Groome Industrial Service Group 401(k) Plan (an existing plan sponsored by Groome Industrial Services Group) by October 15, 2025.

Plan Administration – One retired officers of the Company served as the plan trustees until termination. The Company contracted with Nationwide Financial Services, and its subsidiaries, to hold the Plan’s assets and execute investment transactions. Benefit Plans, Inc. had been contracted as a third-party administrator. The Plan contracted with Iron Fiduciary to serve as the Investment Manager for the Plan.

Contributions – The Plan allowed participants to contribute an amount up to IRC limitations of their annual compensation through compensation deferrals. Participants attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed the investment of their contributions into various investments options offered by the Plan. The Company made safe harbor matchings contribution to each eligible participant’s account in an amount equal to 100% of elective contributions up to 3% of eligible compensation, as defined by the Plan, plus 50% of elective contributions over 3% up to 5% of eligible compensation. The Plan also allowed for discretionary profit sharing contributions and employer matches at the option of the Company and are invested as directed by the participant. There were no contributions made in 2025.

Participant Accounts – Each participant’s account was credited with the participant’s and Company matching contributions and allocations of (a) the Company’s discretionary contribution and (b) plan earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of Benefits – The payment of benefits can be made upon reaching age 59 ½, death, disability, hardship, or termination of employment. The Plan required distribution payments of \$5,000 or less to be rolled over to an individual retirement account designated by the plan administrator, if the participant did not elect otherwise. For vested account balances exceeding \$5,000, the participant or beneficiary may elect to receive either a lump sum, partial payments, or installment payments.

Forfeited accounts –No forfeitures were available or used for the period from January 1, 2025 to October 15, 2025.

2. Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates –The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and Note 5 for discussion of the investment contract.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Third party administrative charges for benefit distributions are paid by participants.

Payment of Benefits – Benefits are recorded when paid.

Subsequent Events – Management evaluated subsequent events through December 22, 2025, the date the financial statements were available to be issued, and determined that no events require adjustment to or disclosure in the accompanying financial statements.

4. Fair Value Measurements

6. Party-in-interest Transactions

The Plan included various investments managed by Nationwide Financial Services, and its subsidiaries. Nationwide Financial Services and its subsidiaries served as the custodian of the Plan and, therefore, these transactions qualified as party-in-interest transactions.

7. Tax Status

The Company adopted the Benefit Plans, Inc. non-standardized defined contribution pre-approved plan on January 1, 2022. On June 30, 2020, the Internal Revenue Service stated the prototype document adopted by the Company, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan. The plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.
