The following description of the ORBA Employees' Retirement Savings Plan (Plan) is provided for general informational purposes only. The Plan is sponsored by Ostrow Reisin Berk & Abrams, Ltd. (Company). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of the Company who have completed six months of service and are age 21 or older, with the exception of employees represented under a collective bargaining agreement, leased employees, and non-resident aliens. Eligible employees may participate in the Plan on the first day of the month following their fulfillment of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Upon satisfying eligibility requirements, employees are automatically enrolled in the Plan and contribute 5% of compensation unless an alternate election is made. The deferral percentage of auto-enrolled participants will increase by 1% annually (on July 1) until a deferral rate of 15% is reached. Participants may make pre-tax or Roth contributions not to exceed 90% of annual compensation, subject to certain limits defined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may make discretionary non-elective contributions. To be eligible for Company contributions, a participant must earn at least 1,000 hours of service and be employed on the last day of the Plan year. The hours of service and last day requirements will be waived in the event of death, disability, or retirement.

Non-elective contributions are allocated as defined in the Plan agreement. For the year ended May 31, 2025, the Company authorized \$1,026,538 of profit-sharing contributions which were funded in November 2025.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a self-directed brokerage account as investment options for participants.

Participant Accounts: Each participant's account is credited with the participant's contributions, any Company contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants vest over a 6-year graded vesting schedule: 1 year-0%; 2 years-20%; 3 years-40%; 4 years-60%; 5 years-80%; 6 years-100%.

Note 1. Description of Plan (cont.)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator at the inception of each loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum or annuity payments equal to the value of the participant's vested interest in his or her account. In addition, in-service withdrawals are allowed after participants reach age 59 ½ or in cases of financial hardship. Participants may also initiate in-service withdrawals of Company contributions after the participant has at least 60 months of participation.

The Plan has the ability to make automatic distributions without participant consent for terminated participants that fail to affirmatively elect a distribution and have a vested account balance under \$5,000.

Forfeited Accounts: At May 31, 2025 and 2024, forfeited nonvested accounts totaled \$35,205 and \$34,882, respectively. These accounts are used to pay Plan expenses or to reduce future Company contributions. During the year ended May 31, 2025, forfeited nonvested accounts of \$55,170 were used to reduce Company contributions.

Note 2. Summary of Accounting Policies

Basis of Accounting: The financial statements as of and for the year ended December 31, 2025 have been prepared on the liquidation basis of accounting as termination of the Plan is expected in the first half of 2026 (see Note 9). The financial statements as of December 31, 2024 were prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants are recorded in the year they are withheld from compensation.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Note 2. Summary of Accounting Policies (cont.)

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and self-directed brokerage accounts are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments.

Note 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 3. Fair Value Measurement (cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage: Accounts consist of common stock, mutual funds, certificates of deposit, and money market funds, which are valued at fair value based on quoted market prices.

Money market funds: Valued at the cost, which approximates fair value.

Note 4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at May 31, 2025 and 2024, and net appreciation in fair value of investments, interest, and dividends, and interest income on notes receivable from participants for the year ended May 31, 2025, was obtained by management and agreed to or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 5. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, transactions between the Plan and Fidelity qualify as exempt party-in-interest transactions. Administrative expenses of \$1,488 were paid to Fidelity for the year ended May 31, 2025.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Subsequent Event – Plan Termination

On November 1, 2025, substantially all the Company's assets were acquired by Citrin Cooperman. Termination of the Plan is expected in the first half of 2026, at which time all participants will become 100% vested, and the Plan's net assets are expected to be fully distributed to participants.

The Plan has evaluated subsequent events through February 16, 2026, the date the financial statements were issued.
