## REPORT OF INDEPENDENT AUDITORS

To the Board of Trustees of the

### Opinion

We have audited the accompanying financial statements of General Teamsters and Employers Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the General Teamsters and Employers Trust Fund (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- A. *General:*** The Plan is a multi-employer welfare plan formed under a collective bargaining agreement between various Teamsters Local Unions and Contributing Employers. The Plan was established on June 1, 1952 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
- B. *Contributions and Benefits:*** The Plan provides hospital and medical benefits to retired and active participants, vision care, dental, prescription drug benefits, group life and weekly disability benefits to active participants. These benefits are either paid by the Plan (self-funded) or are paid by insurance or health carriers for the insurance portion of the benefits. The Plan has a "stop-loss" policy with an insurance carrier which insures all large individual claims in excess of \$175,000 (deductible portion of claim paid by the Plan).

The plan agreement requires that all participating employers make monthly contributions to the plan for each eligible employee who is a full-time active or under certain eligibility rules, may be a non-bargaining employee. If an employee or dependent loses coverage under the Plan as a result of a qualifying event, coverage may be continued for a limited period by making monthly payments to the Trust Fund. The contribution rate varies depending upon the benefits provided.

- C. *Plan Amendments and Terminations:*** The Plan's board of trustees as Sponsor has the right under the Plan to modify the benefits provided to the participants and the contribution rates paid by the participating employers. The Plan may be terminated under the provisions of the Trust agreement subject to conditions set forth in ERISA.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

- A. *Accounting Method:*** The financial statements of the Plan are prepared on an accrual basis, recognizing revenue when earned or otherwise available and benefits and expenses are recognized when incurred.
- B. *Use of Estimates:*** The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- C. *Stop-Loss Coverage & Reimbursements:*** The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop-loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. During the years ended May 31, 2025 and 2024, the Plan did not receive any stop loss refunds. Reimbursements by the insurance company for large claims filed under the stop-loss policy are recorded in the financial statements when the reimbursement has been received.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES - Continued**

**D. *Claims Payable:*** Claims Payable and Provision for Incurred but not Reported Claims are shown in the Statements of Plan's Benefit Obligations on Page 6.

Claims payable represents actual claims which were processed and approved but not paid as of May 31, 2025. In addition, a provision is also made for claims incurred but not processed and claims incurred but not reported as of May 31, 2025. This provision is estimated by the Plan's consultants and are based on approximately 3 months of claims paid for indemnity medical claims, (based on lag reports through June 2025), actual amount for prescription drugs (\$10,405, approximately 46% of an average month), one month for the vision plan, and two weeks of disability claims. Additionally, the estimated amounts for indemnity medical, vision and disability can also reflect the estimated impact of the departure of employers with a significant number of Actives.

**E. *Premiums Payable:*** Premiums payable represents amounts due to the insurance and other health plans under the contracts for the insured benefits.

**F. *Valuation of Investments:*** The Plan's investments are stated at fair value. The Plan has investments in various U.S. Government Investments and time certificates of deposit which are held until maturity date. Interest is accrued at May 31, 2025 and is included as interest income in the accompanying financial statements.

**G. *Postretirement Benefits:*** The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to May 31, 2025. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected data of payment.

Generally accepted accounting principles require that the multiemployer plans disclose these post-retirement benefits as required by FASB ASC 965 prepared by the American Institute of Certified Public Accountants.

Such information is disclosed on the Statements of Plan's Benefit Obligations and the Statements of Changes in Plan's Benefit Obligations on Pages 6 and 7 of these financial statements.

Assumptions used to estimate Accumulated Plan Benefit Obligations as of May 31, 2025 and 2024.

1. For measurement purposes, the following health care trend rates were assumed:
  - i. Self-funded medical – 6.00% decreasing annually to an ultimate rate of 4.00%
  - ii. HMO Medical – 6.00% decreasing annually to an ultimate rate of 4.00%
  - iii. Self-funded prescription drug – 6.00% decreasing annually to an ultimate rate of 4.00%
  - iv. UnitedHealthCare AARP Part D prescription drug plan – 6.00% decreasing annually to an ultimate rate of 4.00%
  
2. Other significant assumptions used in the valuation as of May 31, 2025 and 2024:  
Discount rate: 5.75% per annum (5.50% in 2024)

**Mortality, Turnover, and Disability:** Rates are from the January 1, 2024 actuarial valuation of the Western Conference of Teamsters Pension Plan. In particular, the mortality tables are modified versions of the Pri-2012 Healthy and Disabled tables with Scale MP-2021 generational projection applied from a base year of 2012. The turnover rates are from a 30-year select and ultimate table.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

**H. Subsequent Events.** Management has evaluated subsequent events for the Plan through December 2, 2025, the date the financial statements were available to be issued.

**NOTE 3 - BENEFIT OBLIGATIONS**

The Plan's deficiencies of net assets available for benefits over benefit obligations of \$3,620,385 and \$3,628,157 at May 31, 2025 and 2024, respectively, relate primarily to the postretirement benefit obligations, the funding of which has not been covered by the contribution rates provided by the bargaining agreements. The calculation and reporting of the post retirement benefit obligations does not imply that there is any legal liability to provide the benefits valued, nor is there any implications that the Plan is required to implement a funding policy to satisfy the projected expense.

The weighted-average health care cost-trend rate assumption (See Note 2G) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the accumulated postretirement benefit obligations by \$1,189,300 to 8,886,800 for the year ended May 31, 2025 and by \$1,243,100 to 9,297,200 for the year ended May 31, 2024.

**NOTE 5 - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities on active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for investment measured at fair value:

**U.S. Government Debt Securities:**

Level 1 investments consist of U.S. Treasury notes valued based on quoted prices in an active market. Level 2 investments consist of government debt securities valued based on prices available for comparable securities with similar yields, duration and credit quality.

**Certificates of Deposit:**

Valued at fair value earning a fixed rate of interest of 3.05%.

**NOTE 6 - EMPLOYER PAYROLL AUDIT PROGRAM**

Employer remittance reports are accepted as submitted, without examination or verification of employer's payroll records. As part of the internal control procedures set up to ensure the employers are complying with the Collective Bargaining Agreement, employer payroll audit program has been established. The Board of Trustees do an annual review of all employers and if necessary, may select employers for audit to ensure employer remittance reports are properly and timely remitted in accordance with the rates established by the Collective Bargaining Agreement.

**NOTE 7 - MEDICAL CLAIMS AUDIT PROGRAM**

As part of the internal control procedures, medical claims audit program has been established to ensure medical claims are properly processed.

**NOTE 8 - TAX STATUS**

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code, and accordingly, the Trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan Sponsor believes that the Plan continues to qualify and to operate as designed.

**NOTE 10 - ADMINISTRATION OF PLAN**

The Plan paid a total of \$186,992 and \$187,087 for the years ended May 31, 2025 and 2024 for administrative fees to third party administrators.

**NOTE 11 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 12 - TERMINATION OF THE PLAN**

Although it has not expressed any intention to do so, the Trust has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Trust or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 13 - PARTIES IN INTEREST**

The Plan has contracted for administrative and claims services with Benefit Programs Administration. The Plan paid fees for these services. The Plan also contracts with investment managers, consultants, attorneys, actuaries, auditors, and others to provide services to the plan. These are all considered to be parties in interest. None of the transactions between the Plan and these parties in interest were considered to be prohibited transactions under ERISA.
