## INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator and Participants

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Vari Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

The following description of the Vari Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all full-time, non-union employees of Vari Corporation (the "Company") and any affiliate who has adopted the Plan and has completed a year of service. Entry dates are the first day of the month following the employees' eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

##### **Contributions**

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan, either as pre-tax (traditional 401(k)) or post-tax (Roth 401(k)) or a combination of the two, up to the maximum allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. New employees of Pottstown Engineered Products, Inc. (PEP), an affiliate of the Company, hired after July 1, 2024 are automatically enrolled at a contribution rate of 3%. The Company may make a discretionary profit sharing contribution and a discretionary qualified nonelective contribution to eligible participants. For the years ended December 31, 2024 and 2023, the Company contributed a discretionary profit sharing contribution equal to 2% of the participant's eligible annual wages plus 2% of wages in excess of the taxable wage base. There were no discretionary qualified nonelective contributions made for the Plan years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's discretionary profit sharing contributions, and the Company's discretionary qualified nonelective contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions and discretionary qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate as determined by the plan administrator. Principal and interest are paid ratably through weekly payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installment payments, or lump-sum amount upon termination of employment upon request. If a participant's account is less than \$5,000 at termination, the participant's vested balance may be distributed to an Individual Retirement Account (IRA). If a participant's account is less than \$1,000 at termination, the participant's vested interest may be paid without a withdrawal request or consent of the participant. Hardship distributions are permitted from a participant's fully vested elective deferral account, qualified nonelective contribution accounts, and rollover account. In-service distributions are also permitted for participants upon reaching the age of 65 from all accounts.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,590 and \$2,107, respectively. These accounts may be used to restore forfeitures, reduce Company contributions (or reallocate as Company contributions), or to pay plan expenses. Forfeited amounts totaling \$1,515 were used to reduce the December 31, 2024 employer discretionary profit sharing contribution.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

---

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive guaranteed investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and insurance company. See Note 3 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Investment Concentration**

The Plan holds certain investments that represent 10% or more of the Plan's total investments at December 31:

**Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Company's discretionary profit sharing and qualified nonelective contributions are recorded in the year in which participant compensation is earned.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

##### **Reclassifications**

Certain items have been reclassified in the prior year financial statements to conform to the current year presentation. These changes had no impact on net income.

##### **Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through February 17, 2026, the date the financial statements were available to be issued.

#### NOTE 3 - FAIR VALUE MEASUREMENTS

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Nationwide Trust Company, FSB and Nationwide Life Insurance Company. Nationwide Trust Company, FSB is the custodian as defined by the Plan, and therefore these transactions qualified as party-in-interest transactions. All other transactions which may be considered related-party or parties-in-interest transactions relate to normal plan management, administrative services, and related payment of fees.

#### NOTE 5 - PLAN TERMINATION

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer discretionary profit sharing contribution accounts.

#### NOTE 6 - TAX STATUS

---

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by CCH Incorporated DBA FTWilliam Com. The non-standardized pre-approved profit sharing plan received an opinion letter from the IRS dated June 30, 2020, that the non-standardized pre-approved profit sharing plan was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 7 - RISKS AND UNCERTAINTIES

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 8 - CERTIFIED INVESTMENTS

---

Certain information in the accompanying financial statements and ERISA-required supplemental schedules held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Nationwide Trust Company, FSB (the custodian of the Plan). The contract value of the group annuity contract as of December 31, 2024 and 2023 and interest for the year ended December 31, 2024 was certified by Nationwide Life Insurance Company.

#### NOTE 9 - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

---

The Plan holds a fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company totaling \$769,840 and \$1,071,753 for December 31, 2024 and 2023, respectively. The guaranteed investment contract is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.95%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 9 - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY - CONTINUED**

---

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 10 - PROHIBITED TRANSACTIONS**

---

During the year ended December 31, 2021, the Company failed to remit timely to the Plan's custodian certain employee contributions and loan repayments totaling \$8,166. Delays in remitting payments to the custodian were due to administrative errors. The contribution was made in February 2022. However, the Company will need to calculate lost investment earnings and make those contributions due to the delay. The lost investment earnings related to these delays are not considered to be material to the financial statements.
