Dear Sir or Madam:

I am writing on behalf of Roxbury Tenants of Harvard to formally acknowledge that the organization is filing its Form 5500 annual returns for the 2023 and 2024 plan years after the applicable deadlines. We recognize and understand the importance of timely and accurate regulatory filings, and we sincerely regret this lapse. The delayed filings were the result of unforeseen turnover within both the HR and Finance departments, which disrupted internal processes leading to a breakdown in our compliance calendar.

Roxbury Tenants of Harvard is a 501(c)(3) nonprofit organization dedicated to providing affordable housing to underserved communities throughout Boston. We fully understand that our nonprofit status does not exempt us from ERISA or Department of Labor filing requirements, and we take our fiduciary and compliance responsibilities very seriously.

Upon identifying that these Form 5500-SF filings were missing late last month, the organization acted promptly and proactively. Rather than waiting for regulatory inquiry, we voluntarily corrected the issue by preparing and submitting the delinquent filings under the Department of Labor's Delinquent Filer Voluntary Compliance Program.

In addition, Roxbury Tenants of Harvard has retained the services of an independent fiduciary to assist with plan oversight, compliance monitoring, the preparation and timely filing of future Form 5500 returns. This engagement reflects our commitment to strengthening internal controls and ensuring that similar issues do not occur in the future.

We respectfully request the Department's consideration and leniency with respect to these late filings in light of the corrective actions taken, our voluntary participation in the DFVCP, and our demonstrated commitment to compliance going forward. We are confident that the steps now in place will prevent a recurrence of this issue.
