INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of Crest Industries, LLC Employee Benefit Plan

Opinion

We have audited the financial statements of Crest Industries, LLC Employee Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (modified cash basis) of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Crest Industries, LLC Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

General: The Plan provides medical coverage in the form of health benefits and covers substantially all full-time employees of Crest Industries, LLC, and its wholly-owned subsidiaries (the Employer and Sponsor). Health and prescription benefits are self-insured and an organ transplant benefit is fully insured. The claims for self-insured benefits are processed by the Plan's third-party claims administrators under administrative services only (ASO) arrangements. The Plan Sponsor pays claims directly to or on behalf of participants. Payments are processed by the health claims administrator using the Plan's funds. The pharmacy benefits manager may make refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. These refunds are provided as a credit against the claims paid. Despite the Plan's utilization of third-party claims administrators, ultimate responsibility for payments to providers and participants is retained by the Plan Sponsor.

The Administrative Benefits Committee of Crest Industries, LLC oversees the governance of the Plan. The Plan is subject to the regulations and requirements of the Employee Retirement Income Security Act of 1974, as amended (ERISA). In the regular course of doing business, the Plan is subject to review by various governmental agencies such as the Department of Labor (DOL) and the Internal Revenue Service (IRS). The Plan includes a voluntary employees' beneficiary association (VEBA) trust. The trust holds the contributions made by the Plan Sponsor and participants as well as distributes payments to health care providers and the pharmacy benefits manager for participant claims.

Benefits: The Plan provides health benefits (medical, hospital, surgical, major medical, and prescription) to full-time employees of the Sponsor who meet eligibility requirements and to their spouses and covered dependents. All full-time employees are eligible to apply for coverage. Retired employees are entitled to similar health benefits provided they retire from the Plan sponsor in accordance with the Sponsor's retirement policies.

Current health claims of eligible active and retired participants and their spouses and covered dependents are provided under a self-funded arrangement. The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Insurance premiums for stop loss coverage and third-party claims administrator fees are paid by the Plan.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Medical and pharmaceutical premiums under COBRA are funded entirely by the former employees.

Contributions: Participants make contributions to the Plan based on premiums determined by the Sponsor and third-party administrator. For the period of January 1, 2024 through December 31, 2024, the employee monthly rates were \$50, \$439, \$399, and \$631 for employee only, employee and spouse, employee and children, and family coverage, respectively. The Sponsor monthly rates were \$774, \$835, \$829, and \$865 for employee only, employee and spouse, employee and children, and family coverage, respectively; however, participating retirees are required to fund 100% of their estimated premiums as determined annually by the Sponsor. Any deficiency of the Plan's net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

1. DESCRIPTION OF PLAN (continued)

Plan Termination: Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided, to discontinue its contributions or to terminate the Plan subject to provisions set forth in ERISA. Were the Plan to terminate, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Employer or be used for purposes other than for the exclusive benefit of the Plan's participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles (GAAP). The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the U.S. Department of Labor. Under the modified cash basis, investments are carried at fair value, the same as under GAAP, but receivables and payables owed at year end and not yet remitted to the Plan are not recorded as assets and liabilities of the Plan. Under GAAP, these receivables and payables would be considered to be assets and liabilities of the Plan.

Plan Benefits Obligations: For disclosure purposes, Plan benefit obligations include claims payable, and an estimate of claims incurred but not yet reported. Plan obligations for health claims incurred but not yet reported were estimated by analyzing the claims paid subsequent to year end which relate to prior years. Based on the low historical participation rates of retired employees and other factors, the Plan administrator does not believe that the benefit obligation associated with retired employees is material to the financial statements. Therefore, no postretirement benefit obligation is presented in these financial statements. The Plan estimates that a one-percentage point increase in the health cost trend rate will not have a significant effect on the Plan's benefit obligations.

The Plan believes these claims will be paid during the following fiscal year. Thus, the cost of such claims would be approximately equal to the present value; and, therefore, these claims were not discounted.

Use of Estimates: The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations and changes therein, claims payable, claims incurred but not reported, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Payment of Benefits: Premiums paid for stop-loss insurance and fully insured benefits (organ transplant policy) by the Plan are recorded as insurance premiums when paid in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims administrator. Refunds from the pharmacy benefit manager are recognized as a reduction of claims paid when such funds are received.

Plan Expenses: Insurance Management Services (IMS) and Prime Therapeutics are the claims administrators for the Plan. The majority of the Plan's administrative expenses are related to IMS and Prime Therapeutics and are paid by the Plan. Expenses paid by the sponsor are excluded from these modified cash basis financial statements.

Cash: The Plan maintains its cash balances in an account with a bank. The balance in this account may at times exceed the insurance coverage provided by the Federal Deposit Insurance Corporation. Plan management periodically evaluates the financial condition of the bank holding its assets and believes such assets do not pose a financial risk to the Plan.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

3. FAIR VALUE MEASUREMENTS (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- (a) Cash and cash equivalents (interest-bearing cash) are reported at cost, which approximates fair value.
- (b) Money market funds: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are mutual funds invested in highly liquid, near-term instruments and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2024, approximately \$1,520,000 was recovered from the stop loss insurance company, which was netted against claims paid. For the year ended December 31, 2024, the Plan paid stop loss premiums of \$1,118,009.

6. INCOME TAXES

The VEBA Trust established under the Plan holds a significant portion of the Plan's assets and is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the VEBA trust's net investment income is exempt from income taxes. The Plan administrator has obtained a favorable determination letter from the IRS dated December 13, 1982, which indicates the VEBA trust is designed in accordance with applicable sections of the IRC. The VEBA trust has been amended since the application for the determination letter was filed. However, the Plan's management believes that the VEBA trust is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

As described in Note 1, the Plan has contractual arrangements with service providers. These transactions are party-in-interest transactions which are exempt from the prohibited transactions rules of ERISA. The Sponsor pays certain expenses of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions are performed by employees of the Sponsor at no cost to the Plan. These transactions are not, however, considered prohibited transactions under 408(b) of the ERISA regulations.

NOTES TO FINANCIAL STATEMENTS

8. RISK AND UNCERTAINTIES

The Plan's benefit obligations represent an estimate based on certain assumptions, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions would be material to the financial statements.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024, may not necessarily be indicative of amounts that could be realized in a current market exchange.

9. FILING REQUIREMENT

The Plan's financial statements for the year ended December 31, 2024, were not completed by the extended Form 5500 filing deadline of October 15, 2025. Management was unable to finalize certain information necessary for the completion of the audit and the related financial statements by the filing deadline. As a result, the Form 5500 filing and the required audited financial statements were submitted after the extended due date.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through the date that the financial statements were available to be issued, February 11, 2026, and determined that no additional disclosures were necessary.
