### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Bair Foundation Employees' Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards (GAAS) will always detect a material misstatement when it exists. The

risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule of Assets (Held at End of Year) as of June 30, 2025 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Plan Description

The following description of The Bair Foundation (Foundation) Employees' Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Foundation consists of seven affiliated entities: Christian Family Services Management Corporation, The Bair Foundation, The Bair Foundation of Pennsylvania, The Bair Foundation of Texas, The Bair Foundation of Virginia, Harbor Properties, and StaffServe. The sole member of the Foundation is Christian Family Services Management Corporation; however, control over the Foundation does not rest with the sole corporate member.

The Plan is a defined contribution plan covering all full-time employees of the Foundation, as defined in the Plan. Employees who receive retirement benefits under a collective bargaining agreement are generally excluded. The Plan is administered by the Foundation and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions and Eligibility

The Plan is funded by participant contributions, discretionary employer contributions, and employer matching contributions. Participants may make voluntary contributions from their compensation upon hire, as defined in the Plan agreement and subject to Internal Revenue Service (IRS) limits. Participants who are at least age 50 by the end of the Plan year are eligible to make catch-up contributions, subject to IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Discretionary employer contributions are determined annually by the Foundation's Board of Directors and are made to accounts of participants that have completed 1,000 hours of service. The employer makes matching contributions equal to 100% of participant elective deferrals up to 5% of the participant's compensation after the participant has completed 1,000 hours of service. A discretionary contribution was not made as of June 30, 2025 and 2024.

Participants' voluntary contributions and employer's matching contributions are designated under a qualified deferred arrangement as allowed by Section 401(k) of the Internal Revenue Code.

### Participant Accounts

Participants direct the investment of their contributions and the Foundation's contribution into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions and allocations of the Foundation's contributions and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants in the Plan are vested immediately in their voluntary contributions made to the Plan and actual earnings. Vesting in employer contributions is based on the years of service as follows:

### Benefit Payments

Upon termination of service, a participant may elect to receive their vested benefits paid as a lump-sum amount, annuity, or installments equal to the account balance. Account balances of \$1,000 or less are paid as a lump-sum. Vested account balances greater than \$1,000 but less than or equal to \$5,000 may be rolled into an individual retirement account, provided the participant does not timely elect another form of distribution.

### Forfeitures

Participant account balances which are not 100 percent vested upon termination of service are forfeited. Forfeitures may be used to reduce Plan expenses. During 2025 and 2024, plan expenses were reduced by \$20,966 and \$34,686, respectively, from forfeited non-vested accounts. The total amount of forfeited accounts was \$0 as of June 30, 2025 and 2024.

### Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

## **2. Summary of Significant Accounting Policies**

### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The cost of investments sold, distributed, or forfeited is determined using the specific identification method. Investment purchases and sales are accounted for on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

### Investment Management Fees and Administrative Expenses

Certain costs of administering the Plan are paid by the Plan sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation of

fair value of investments. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expense.

### Notes Receivable from Participants

The Plan was amended on April 1, 2025 to permit participants to borrow up to 50% of their vested account balance up to \$50,000. Loans cannot be less than \$1,000. A participant may only have one outstanding loan at any given time. Notes receivable are to be repaid quarterly under a level amortization schedule. Notes receivable are secured by the balance in the participant's account and bear a reasonable rate of interest of 8.5% during the Plan year ended June 30, 2025.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. The Plan distributed the 2025 and 2024 excess contributions prior to September 30, 2025 and September 30, 2024, respectively.

### Benefit Payments

Benefit payments are recorded when paid. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of June 30, 2025 and 2024.

### Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

## **3. Investments Certified by the Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2025 and 2024, and net appreciation (depreciation) in fair value of investments and dividends and interest for the years ended June 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (Matrix), the custodian of the Plan.

Fair values for Level 2 investments are determined by reference to quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all.

The asset's or liability's fair value measurement level within the fair value hierarchy above is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Money market funds and mutual funds:* Valued at the daily closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of the future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Related Party Transactions and Party-in-Interest Transactions**

Recordkeeping and administrative services for the Plan are performed by CUNA Mutual. Custodial services are performed by Matrix Trust Company. As transaction fees and other fees are paid to these entities, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan amounted to \$15,055 and \$26,441 for the years ended June 30, 2025 and 2024, respectively. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments.

### **6. Plan Termination**

Although the Foundation has not expressed any intent to do so, it reserves the right to amend, modify, suspend, or terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become fully vested in their accounts.

### 7. Income Tax Status

The Plan is a Non-standardized Pre-approved plan. The Pre-approved plan received an opinion letter from the Internal Revenue Service on June 30, 2020 that stated that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Further, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

### 8. Reconciliation of Financial Statements to Form 5500

The custodian of the Plan uses the cash basis of accounting to prepare the Form 5500. Therefore, the Form 5500 does not reflect employer contributions receivable or payable at year-end. The following is a reconciliation of net assets available for benefits per the financial statements at June 30, 2025 and 2024 to the Form 5500:
