Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of International School of Denver, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of International School of Denver, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan effective September 1, 2016 covering all employees of the International School of Denver, Inc. (the "School") who have completed 1,000 hours of service in a 12-month period and are age 21 or older, except for union employees, leased employees, nonresident employees, and employees of an affiliate employer that does not adopt the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The School is the sponsor of the Plan. The trustees of the Plan are officers of the School. Charles Schwab Trust Bank (the "Custodian") functions as custodian of the Plan, and WESPAC provides record-keeping services to the Plan. The Custodian holds all assets of the Plan in accordance with the provisions of the agreement and service provider contract with the School. The School determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

The Plan provides for pretax employee salary deferral contributions up to a maximum of 100 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows for after-tax employee salary deferral contributions. The Plan also allows for catch-up contributions to be made for participants over age 50. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The School may also make annual discretionary matching or discretionary nonelective contributions to the Plan, as approved by the board of directors of the School. For the year ended June 30, 2025, the School approved discretionary nonelective contributions to all eligible participants equal to 1 percent of eligible compensation and no discretionary matching contributions. The discretionary nonelective contribution is deposited subsequent to year end.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the School's discretionary matching or nonelective contributions and plan earnings and charged with plan losses and an allocation of administrative expenses. Allocations are based on participants' eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the School's discretionary matching and nonelective contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the School 100 percent after three years of service. Participant balances become fully vested upon death, disability, or termination of the Plan.

Benefit Payments

On termination of service due to termination of employment, death, disability, or retirement, a participant's (or the participant's beneficiary in the case of death) account balance may be distributed in a lump sum.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future school contributions or to pay administrative expenses of the Plan. At June 30, 2025 and 2024, forfeited account balances totaled \$64,638 and \$25,586, respectively.

The Plan used approximately \$26,124 for the year ended June 30, 2025 to pay plan expenses.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by the Custodian or its affiliates. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The money market account is valued at fair value based on its outstanding balance. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the School.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 5, 2026, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Custodian holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

Note 4 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
