Opinion

Note 1. Description of Plan

The following description of The Mallory Group Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of The Mallory Group Incorporated and its subsidiaries Mallory Alexander Logistics, L.L.C. and Mallory Distribution Centers, LLC (collectively, the "Company") age 20.5 or older. The Company's Benefit Plan Committee and the Plan Administrator control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective August 1, 2021, the Plan was considered frozen. All contributions ceased or were suspended.

Effective November 3, 2025, the Plan merged its assets into The Mallory Group 401(k) Savings Plan. See Note 4 for discussion of plan merger and associated transfer of assets.

Contributions

The Company may contribute a discretionary amount that is approved by the Company's Board of Directors. No profit-sharing contributions were made to the Plan for the year ended July 31, 2025, or for the period August 1 to November 30, 2025.

Investment Options

The discretionary profit-sharing amounts are invested in non-participant directed mutual funds and other investments.

Participant Accounts

Each participant's account is credited/charged with their allocation of the Company's contributions, Plan earnings/losses, and administrative expenses pursuant to provisions of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in the Company's contribution plus actual earnings/losses.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

At July 31, 2025, and November 30, 2025, there were no forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts, changes therein and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized and unrealized gains and losses.

Redemptions are recorded as receivables when the transaction has been initiated and the amount is fixed, which generally occurs on the last day of a fiscal quarter.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by the Plan, as provided by the Plan Agreement. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (participant distributions) are charged directly to the participant's account.

Subsequent Events

The Plan has evaluated the effect subsequent events would have on the financial statements through January 27, 2026, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value at July 31, 2025 and November 30, 2025.

Money Market Funds

Money market funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Plan Merger

Effective November 1, 2025, the Plan was merged and its assets were transferred into The Mallory Group 401(k) Savings Plan. As a result, the accompanying financial statements include a short period presentation for August 1 to November 30, 2025. All assets, totaling \$2,031,976, were transferred in accordance with applicable regulatory and fiduciary requirements.

Note 5. Restorative Payment

On January 28, 2025, the Plan received a restorative payment of \$100,000, which was allocated to its participants. This payment resulted from corrective action taken to remedy a breach in fiduciary duty related to a former investor relationship.

Note 6. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the trustee by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2025, and November 30, 2025, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
