## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Wardlaw Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering employees of Wardlaw Claims Services, LLC (the Plan Sponsor), WCS Services, LLC, and Wardlaw Consulting Services, Inc. (the Companies), who have attained age eighteen and completed six months of service. The Companies' employees are eligible to participate in the Plan on the first day of the first month and seventh month of the Plan year following the completion of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

**CONTRIBUTIONS**

Participants may elect to contribute up to 100% of compensation as defined by the Plan, subject to certain maximum limitations imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified plans (rollovers). Participants are also permitted to make Roth 401(k) deferrals. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies may make a discretionary matching contribution. In addition, the Companies may also make a discretionary profit sharing contribution. During the year ended December 31, 2024, no matching or profit-sharing contributions were made.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions, the Companies' matching contributions and an allocation of the Companies' profit sharing contributions. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' matching and profit sharing portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Full vesting also occurs at normal retirement age (65), disability, death, or plan termination.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, normal retirement age, and other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Hardship distributions are not permitted. In-service distributions are permitted from vested accounts based on certain plan provisions. Participants can elect to receive their distributions either in cash or as a direct rollover to another tax-qualified plan.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**FORFEITED ACCOUNTS**

Forfeitures may be used to pay administrative fees or reduce employer contributions. Forfeited non-vested accounts totaled \$-0- at December 31, 2024 and 2023. There were no new forfeitures and no forfeitures were used to pay Plan expenses or reduce employer match during the year ended December 31, 2024.

**PLAN ADMINISTRATION**

The management of the Plan Sponsor appoints the Plan Administrator and Plan Trustees. The Plan Administrator is an employee of the Plan Sponsor. The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. Certain administrative duties, such as Form 5500 preparation and compliance testing, were performed by Resource Benefits Administrators, the third-party Plan administrator and recordkeeper.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**USE OF ESTIMATES**

The preparation of financial statements in accordance with GAAP requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net investment appreciation.

**PLAN MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS**

Plan Management has evaluated subsequent events through February 18, 2026, which is the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. NAV is used as a practical expedient to estimate fair value. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Capital Bank and Trust Company and all investment options are provided by American Funds. Capital Bank and Trust Company is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7 - TAX STATUS**

The Plan Sponsor has adopted a volume submitter plan which received a favorable opinion letter from the Internal Revenue Service (IRS) that the form of the plan is acceptable under Section 401(a) of the IRC. The Plan Sponsor and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the Plan year ending December 31, 2024, employee contributions totaling \$33,530 were not remitted to the Plan on a timely basis. The Plan Sponsor will make corrective contributions as soon as the amounts are determined following the Department of Labor guidelines for late deposits.
