To Whom It May Concern:

I am writing in response to IRS Notice CP283 dated February 16, 2026, assessing a penalty of \$22,500 for late filing of Form 5500 for the above-referenced retirement plan.

We respectfully request full abatement of this penalty based on reasonable cause.

Automatic Claims Processing, Inc. has sponsored its 401(k) plan since 2018 and has consistently filed all prior Form 5500 returns timely through our third-party administrator, ADP Retirement Services. We have maintained a clean compliance history with no prior late filings.

For the plan year ending December 31, 2024, ADP timely filed Form 5558 on our behalf, extending the Form 5500 due date to October 15, 2025. The Form 5500 was prepared within the extended filing period and made available in the ADP Plan Sponsor portal for review and electronic submission.

The return was reviewed by our office and approved for electronic submission during the extended filing cycle. Based on our established compliance process and prior years' experience, we believed the filing had been completed in accordance with the extended deadline.



On January 13, 2026, we became aware that the filing status reflected as incomplete within the portal. Upon learning this, we immediately finalized the submission and ensured transmission through the EFAST2 system without delay.

At no time did we intentionally fail to file the return. The return was prepared within the extended timeframe, reviewed, and approved in good faith. We were unaware that the system status reflected incomplete until January 13, 2026.

At all times:

- The retirement plan remained fully operational
- Employee contributions were timely deposited
- Participant accounts were properly maintained
- Required disclosures were provided
- No participant harm occurred
- There was no attempt to avoid reporting obligations

We exercised ordinary business care and prudence by engaging a national retirement plan administrator, filing a timely extension, and following our established annual compliance procedures. This situation arose despite our consistent history of timely filings since 2018.

Given:

- Timely filing of Form 5558 extension
- Timely preparation of the Form 5500 within the extended period
- Review and approval in good faith
- Immediate corrective action once informed of incomplete status
- Our unblemished compliance history
- No harm to plan participants or the government

We respectfully request full abatement of the penalty under the reasonable cause provisions of IRC §6652(e) / §6692.

We appreciate your consideration and are prepared to provide any additional documentation necessary to resolve this matter.
