## NOTES TO FINANCIAL STATEMENTS

### Bardons & Oliver, Inc. Employee Stock Ownership Plan and Trust

#### 1 Description of Plan

The following description of Bardons & Oliver, Inc. Employee Stock Ownership Plan and Trust (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### *General:*

Bardons & Oliver, Inc. (“Company”) established the Bardons & Oliver, Inc. Employee Stock Ownership Plan and Trust effective for the Plan year beginning December 1, 1996. The Plan is designed to comply with Section 4975 (e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered by a Trustee appointed by the Company's Board of Directors. The Plan was restated December 1, 2021 to comply with current regulations. Participants will be required to have 12 months of service prior to becoming a participant.

The Plan Sponsor (Bardons & Oliver, Inc.) was sold on June 21, 2024 and the Plan was terminated effective September 30, 2025.

On the first day of the Plan year following a Plan participant's settlement date, the Plan shall transfer, over a five-year period, an amount equal to the fair value of the Employer Stock credited to the participant's account into the Stable Value fund, in accordance with the following schedule:

First	20%
Second	25%
Third	33%
Fourth	50%
Fifth	100%

The Plan allows participants to transfer an amount equal to 25% of the value of their account's share of Plan Sponsor Stock to their account in the Bardons & Oliver 401(k) Plan within 90 days of the end of each Plan year, beginning on the first Plan year in which the participant reaches age 55 or older and has at least 10 years of participation in the Plan, and ending six years after reaching such age and service requirements. Participants will be allowed to transfer an amount equal to 50% of the value of their account's share of Plan Sponsor Stock to their account in the Bardons & Oliver 401(k) Plan within 90 days of the end of Plan year six years after reaching at least age 55 and 10 years of participation in the Plan.

##### *Eligibility Requirements:*

An employee becomes a participant on December 1 or June 1, whichever comes first after completion of one year of service. The Plan excludes any employee covered by a union retirement plan to which the Company contributes.

## NOTES TO FINANCIAL STATEMENTS

### Bardons & Oliver, Inc. Employee Stock Ownership Plan and Trust

#### 1 Description of Plan, Continued

##### *Plan Termination:*

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the Plan will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Trustee will pay all liabilities and expenses of the Plan.

##### *Contributions:*

The Plan is funded by contributions made by the Company, either in cash or in shares, or partly in each, or in the form of other property. The Company's Board of Directors has discretion as to the amount of contributions to be made. Eligible employees must be employed on the last day of the Plan Year in order to receive a contribution.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

##### *Participants' Account:*

Contributions made by the Company are allocated among the participants according to their compensation.

##### *Vesting:*

Vesting in the participant's account balance is based on years of service up to the date of termination of employment. The vesting schedule is as follows:

#### 2 Summary of Significant Accounting Policies

##### *Treatment of Forfeitures:*

The nonvested portion of a terminated participant's account under the Plan shall constitute a forfeiture. Forfeitures are reallocated to the accounts of those persons who, as of the last day of the later of the Plan Year, in which the single sum payment occurs, or the Plan Year following the Plan year in which the Participant's settlement date occurs, are eligible to participate in Company contributions, and are allocated in the same manner as contributions to the Plan.

#### **2 Summary of Significant Accounting Policies, Continued**

Forfeited non-vested accounts which were reallocated totaled \$0 and \$4 as of November 30, 2024 and 2023, respectively.

##### ***Distributions:***

A participant, upon normal retirement, may elect to receive an amount equal to the value of the vested interest in his or her account in a series of installments. Unless the participant elects otherwise, distributions shall be made in equal annual installments over a five-year period. In the event of death, the participant's beneficiary may elect to receive an amount equal to the value of the vested interest in the participant's account in either a lump-sum amount or in a series of installments over the normal life expectancy of the participant's beneficiary.

A participant, who terminates employment prior to normal retirement, will receive a lump-sum distribution if the account balance is less than \$1,000. Participant balances greater than \$1,000 are distributed in accordance with IRS guidelines.

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Investment Valuation and Income Recognition:***

The Plan's investments are stated at fair value. Investments in employer stock are valued by an independent appraiser. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis.

##### ***Payment of Benefits:***

Benefits are accrued when the requirements for payment have been met.

At November 30, 2024 there were \$15,188 of assets allocable to participants who had separated from the Company.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

## 2 Summary of Significant Accounting Policies, Continued

### *Risks and Uncertainties:*

The Plan's investment include an investment in employer stock with varying degrees of risk, such as overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for Plan benefits.

### *Subsequent Events:*

Management evaluates subsequent events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through February 2, 2026, which is the date the financial statements were available to be issued.

## 3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets
- \* Quoted prices for identical or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability

#### 4 Administration of Plan Assets

Company contributions are held and managed by Mills, Potoczak and Company, the Trustee effective December 6, 2017, which invests cash received, interest and dividend income and makes distributions to the participants. Prior to that date, Wilmington trust administered the Plan assets.

#### 5 Party-in-Interest Transactions

Bardons & Oliver Inc. stock is held by the ESOP and is a party-in-interest to the Plan. In addition, the Plan has a number of service providers and these providers qualify as parties in interest under ERISA.

#### 6 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of November 30, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.
