## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Trustees of  
Des Moines Christian School 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Des Moines Christian School 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Des Moines Christian School 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in the Note B to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Des Moines Christian School 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Des Moines Christian School 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefit due or which may become due to such participants.

Accordingly, the objective of an ERISA 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Des Moines Christian School 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of Des Moines Christian School (the Organization) who are twenty-one years of age, except those employees that are bus drivers or substitute teachers. Newly eligible employees may enter the Plan on the first of the month after they become eligible. Employees may change their participation in the Plan on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions** - Each year, participants may contribute up to 100 percent of their compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective May 10, 2022, the Plan adopted a stated tier match at 100% of the first 3% of elective deferrals and then 50% of the next 1% of elective deferrals. Effective July 1, 2023, the Plan changed to a safe harbor match. The Organization's safe harbor match is 100% of participant contributions up to 4% of a participant's compensation. The Organization's stated tier match and safe harbor contributions are invested as directed by the participant. Contributions are subject to certain IRS limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and the Organization's stated tier contributions and the Organization's safe harbor matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their contributions and the Organization's safe harbor matching contributions plus actual earnings thereon. Vesting in the Organization's employer match contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of service.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account, reduced by any outstanding loan balance, if any. Only one loan per participant can be outstanding at a time, and loans must be paid in five years, unless extended. The loans are secured by the balance in the participant's account. The loan interest rate, determined by the third-party administrator, is commensurate with local prevailing rates. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. There are no unpaid distributions that have been requested as of June 30, 2024 and 2023.

Forfeited Accounts - At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$2,231 and \$-0-, respectively. These accounts will be used to pay administrative expenses or to reduce future employer contributions. During the fiscal years ended June 30, 2024 and 2023, employer contributions were reduced by \$12,320 and \$3,744, respectively, from forfeited non-vested accounts. In addition, administrative expenses totaling \$193 and \$115 were paid from forfeited non-vested accounts during the fiscal years ended June 30, 2024 and 2023, respectively.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

New Accounting Pronouncements - Accounting Standards Update (ASU) 2016-13, *Financial Instruments - Credit Losses*, as amended, was required to be adopted by the Plan as of July 1, 2023. The standard impacts accounting and disclosure requirements for certain financial assets. The adoption of ASU 2016-13 did not have a significant impact on the Plan's financial statements.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Certified Investments - Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held, net appreciation in fair value of investments, and interest and dividends was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Global Investor Trust Company, the custodians of the Plan.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023. Delinquent participant loans, if any, are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through February 4, 2025, the date the financial statements were available to be issued.

**NOTE C - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standard Board Accounting Standards Codification (FASB ASC) 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There were no assets measured at Level 1, 2, or 3 as of June 30, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at net asset value as a practical expedient. There have been no changes in the methodologies used at June 30, 2024 and 2023.

- Pooled separate accounts: Pooled separate accounts are investments in pooled mutual fund accounts. The value of the pooled separate accounts is based on net asset value (NAV), which is not publicly quoted. The NAV is used as a practical expedient to estimate fair value.

- Stable value fund: The stable value fund, is stated at fair value, which is contract value, as the stable value collective trust fund’s underlying investment contracts are fully benefit-responsive. Contract value of the stable value fund is the value at which participants ordinarily transact and is the sum of participant and Organization contributions, plus accrued interest thereon less withdrawals. As a practical expedient, the fair value of participation units in the stable value fund is based upon the NAV of such fund as reported in the audited financial statements of the stable value fund. NAV is determined to be contract value, the value at which participants ordinarily transact. In accordance with generally accepted accounting principles (GAAP), investments measured at NAV as a practical expedient have not been classified in the fair value hierarchy. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

In accordance with GAAP, investments measured at NAV as a practical expedient have not been classified in the fair value hierarchy.

Fair Value of Investments that Calculate NAV - The following table summarizes investments for which fair value is based on NAV per share as a practical expedient as of June 30, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**NOTE D - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Life Insurance Company and Principal Global Investors Trust Company (Principal). Principal is the record keeper and custodian for the Plan. The Plan also engages an investment advisor, Benefit Source, for investment advisory services. Transactions with all of these entities qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for administration and advisory services were \$40,108 and \$33,275 for the years ended June 30, 2024 and 2023, respectively, are include in administrative expenses. The Organization pays directly any other fees related to the Plan's operations.

Principal provides certain administrative services to the Plan pursuant to a Service and Expense Agreement between the Organization and Principal. Principal receives revenue from investment managers or sub-advisors for services Principal provides to the funds. This revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE F - TAX STATUS**

The Plan has adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the Internal Revenue Services, dated June 30, 2020, as to the prototype plan's qualified status under the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and management believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE H - AMOUNTS OWED TO FORMER PARTICIPANTS**

At June 30, 2024 and 2023, there was \$2,887 and \$-0-, respectively, due to participants who had withdrawn from the Plan.

**NOTE I - NONEXEMPT TRANSACTIONS**

Title I of ERISA requires all employee contributions to be submitted to the Plan as soon as administratively possible, but no later than the 15th business day of the month the compensation was withheld. Failure to remit employee contributions to the Plan on a timely basis is considered a nonexempt transaction with a party-in-interest. As a result of administrative oversight, contributions withheld from employees on one separate payroll during the year ended June 30, 2023, were not remitted to the Plan timely. The late remittances totaled \$19,755 in 2023. Due to the late remittances, lost earnings are required to be contributed by the Organization. As a result of administrative oversight, contributions withheld from employees on one separate payroll during the year ended June 30, 2024, were not remitted to the Plan timely. The late remittances totaled \$21,314 in 2024. The lost earnings for the 2023 late remittances was \$42.69 and was remitted to the Plan during June 2023. The lost earnings for the 2024 late remittances was \$69.84 and was remitted to the Plan during August 2023.

**NOTE J - PLAN AMENDMENTS**

The Plan has been operationally amended for the Setting Every Community Up for Retirement Enhancement Act (SECURE Act). The formal amendments will be completed by the end of the 2025 Plan year. The SECURE Act allows employees who work at least 500 hours in three consecutive years eligibility status to participate in the Plan; however, employer contributions for such employees are not required. These employees may be eligible to enter in Plan year 2024. In addition, effective January 1, 2021, the SECURE Act increases the required minimum distribution age to 72 and will allow qualified birth and adoption withdrawals.

On September 1, 2022, the Plan was amended to allow in-plan Roth rollover contributions.

On December 29, 2022, the SECURE Act 2.0 was enacted into law. As of June 30, 2024, no formal amendments have been adopted by the Plan. The Plan is required to formally amend the Plan Document by December 31, 2026, but must operate within the provisions within the effective date of each new provision. Effective January 1, 2023, the SECURE Act 2.0 increased the required minimum distribution age to 73. For the 2025 plan year and forward, long-term part-time (LTPT) employees who have two consecutive years with greater than 500 hours and less than 1,000 hours in each year (2023 - 2024 plan years) and are at least age 21 are eligible to make deferral contributions to the Plan beginning on January 1, 2025. Plans may exclude LTPT employees from eligibility for employer contributions.

On July 1, 2023, the Plan was amended to a 401(k) Safe Harbor Plan. As a result of the amendment, the match formula was changed to be 100% of elective deferrals up to 4% of compensation and is immediately 100% vested upon contribution. The definition of compensation changed to be W-2 wages, less reimbursement for fringe benefits, moving expenses and welfare benefits.
