Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Medicine-On-Time, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of February 13, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through February 13, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of February 13, 2024 and December 31, 2023, and the period from January 1, 2024 through February 13, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the Medicine-On-Time, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility

The Plan was established on May 1, 2016, as a defined contribution plan. The Plan has since been amended and restated throughout the years, to comply with certain tax legislation. The Plan is available to eligible employees of Medicine-On-Time, LLC, and related affiliates, Clinical Support Services, Inc. and Star MTM, LLC (collectively, the Company, Employer or Plan Sponsor). Eligible employees may enter the Plan on the first day of the month coinciding with or next following date after completing the service requirement of three (3) months of credited service and have reached age twenty-one (21), as defined in the Plan document. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Company is the Plan Administrator. Minnesota Life Insurance Company (Securian, the Custodian) serves as the Plan's Custodian. The Custodian holds the Plan's investment assets, executes investment transactions and provides recordkeeping services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan merger

On January 1, 2024, the Plan Sponsor executed an adoption agreement with ProCare LTC 401(k) Profit Sharing Plan and Trust (successor plan). As of February 13, 2024, all participant accounts and the Plan's assets totaling \$3,695,460 were transferred to the successor plan. The financial statements reflect activity in the Plan through the date of transfer, February 13, 2024.

Contributions

Participants may voluntarily contribute up to 100% of their annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans (rollover). Participants may make Roth 401(k) elective deferrals in accordance with the Plan's provisions.

The Plan includes an auto enrollment provision whereby all newly hired employees are automatically enrolled in the Plan after meeting the Plan's service requirement unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

Through February 13, 2024, the Employer at its sole discretion may make matching contributions using a computation determined by the Employer as a percentage of a participant's eligible annual elective deferrals to the Plan and flexible matching contributions. For the period ended February 13, 2024, there were no Employer discretionary matching contributions or flexible matching contributions made to the Plan.

Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of: (a) the Employer's contributions (if any), and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Note 1 – Description of Plan, Continued

Vesting

Participants are immediately vested in their individual contributions plus actual earnings or losses thereon. Vesting in the Employer's contributions, if any, plus earnings or losses thereon, is based on years of continuous service. Participants who become eligible, and are enrolled in the Plan, will receive vesting credit for years of service based on the elapsed time method, as defined. A participant is 100% vested after three (3) years of credited service in accordance with a graded vesting schedule. Participant accounts become 100% vested upon death, disability, reaching normal retirement age (65), or upon termination of the Plan.

Forfeitures

Forfeited nonvested accounts may be used to offset certain Plan administrative expenses or reduce future Employer contributions. For the period January 1, 2024 through February 13, 2024, forfeitures totaling \$1,460 were used to offset certain Plan administrative expenses. Forfeited nonvested accounts totaling \$23,836 were transferred to the successor plan. At February 13, 2024 and December 31, 2023, available unallocated forfeited nonvested accounts totaled \$0 and \$23,310, respectively.

Notes receivable from participants

Plan participants may borrow from their accounts between \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one to five years unless the loan is used to acquire the principal residence of the participant. Loans are secured by the vested account balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid through regular payroll deductions and remitted to the Custodian. Any delinquent notes receivable from participants are recorded as distributions.

Payment of benefits

Upon termination of service due to disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution or substantially equal annual or more frequent installments over a period not to exceed the joint life expectancy of the participant or the participant's beneficiary. Upon termination of service due to death, the participant's beneficiary will become entitled to receive the participant's vest account balance, in a lump sum payment.

Plan administration

The Company is the Plan Administrator and, as such, control and manages the operations of the Plan. The Plan's assets were held by Securian who administered the Plan's investments on behalf of the participants. Participant and Employer contributions are held by the Custodian who invests cash received, interest and dividend income, and makes distributions to participants (subject to the direction of the participants). Fees from covered service providers of the Plan are in compliance with Department of Labor's regulations regarding ERISA Section 408(b)(2).

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Note 2 – Summary of Significant Accounting Policies, Continued

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's advisor and the Plan's Custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. No allowance for credit losses has been recorded as of February 13, 2024 and December 31, 2023.

Payment of benefits

The Plan records benefits when paid.

Administrative expenses

The Plan has classified certain administrative expenses as an expense rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the Plan are paid by the Plan Sponsor and are not reflected in these financial statements. Certain expenses paid by the Plan consist of recordkeeping, custodian, and third-party administrator fees. Certain participant directed transactions such as loan processing fees are charged directly to participants' accounts.

Uncertain tax positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at February 13, 2024, that it would be unable to substantiate.

Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Minnesota Life Insurance Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and notes receivable from participants shown on the statements of net assets available for benefits as of February 13, 2024 and December 31, 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period January 1, 2024 through February 13, 2024; and
- Investment information included in the Schedule H, 4i – Schedule of Assets (held at end of period) as of February 13, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at February 13, 2024 and December 31, 2023. During the period January 1, 2024 through February 13, 2024, there were no transfers of financial instruments into or out of Level 3.

Note 4 – Fair Value Measurements, Continued

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled separate accounts – valued at net asset value (NAV) based upon the units of such pooled separate accounts held by the Plan at year/period-end multiplied by the respective unit value. The unit values of the pooled separate accounts are based upon significant observable inputs but are not based upon quoted market prices in an active market and are therefore considered Level 2 investments within the fair value hierarchy.

The preceding method described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Fully Benefit-Responsive Investment Contract

For the period from January 1, 2024 through February 13, 2024, and as of December 31, 2023, the Plan had a fully benefit-responsive investment contract (FBRIC) issued by Minnesota Life Insurance Company (Securian). Securian maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Securian is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The FBRIC did not permit Securian to terminate the agreement prior to the scheduled maturity date.

Upon the merger (Note 1) with the ProCare LTC 401(k) Profit Sharing Plan and Trust, the FBRIC with Securian was terminated and was transacted at contract value.

Note 6 – Refunds Payable for Excess Contributions

During 2023, the Plan received contributions from participants in excess Plan and IRS limitations totaling \$18,229. Such amounts were refunded to participants during 2024, with a liability recorded and corresponding reduction in contributions recorded in the year the excess contribution is received.

Note 7 – Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. The Plan investments were issued, maintained and/or managed by Minnesota Life Insurance Company, the Custodian. Therefore, transactions with Securian are considered party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Fees incurred for the Plan for investment management services are included in net appreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.

Note 8 – Tax Status

The Plan uses a non-standardized pre-approved profit sharing/money purchase plan with CODA plan document sponsored by Minnesota Life Insurance Company, which received an opinion letter from the IRS, dated June 30, 2020, which states that the non-standardized pre-approved profit sharing/money purchase plan with CODA plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan's management and the Plan's tax counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 10 – Plan Merger

On November 27, 2023, the Plan Sponsor approved a plan of merger and executed an adoption agreement with ProCare LTC 401(k) Profit Sharing Plan and Trust (successor plan). Plan management notified Securian prior to the merger date as to its termination of its contract with Securian. On February 13, 2024, the Plan transferred all the Plan's assets and participant accounts into the successor plan.

Note 11 – Delinquent Employee Deferral Transmittals

During 2023, the Plan Sponsor was untimely in remitting certain participant contributions and loan repayments to the Plan totaling \$1,163. Late remittances of participant contributions constitute a prohibited transaction under ERISA section 406, regardless of materiality. As of the date of this report, the Plan Sponsor has not corrected these prohibited transactions for lost earnings.
