To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Radiology Associates, P.C. Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the 2024 audit of Radiology Associates, P.C. Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion on the 2024 Financial Statements

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Radiology Associates, P.C. Employee Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Radiology Associates, P.C. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Radiology Associates, P.C. Employee Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Radiology Associates, P.C. Employee Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether it was in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

The supplemental schedules, as listed in the table of contents, as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Employee Savings Plan, which comprises the statement of net assets available for benefits as of December 31, 2023, and the related notes to the financial statement in accordance with accounting principles generally accepted in the United States of America. 1. Plan Description

The following description of Radiology Associates, P.C. Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2022. The Plan's Trustees oversee the governance of the Plan.

General

The Plan is a defined contribution plan covering all employees of Radiology Associates, P.C. (the Employer), except for employees covered by a collective bargaining agreement, students working to fulfill an educational requirement, non-resident aliens, leased employees, and per diem employees, who are excluded as defined by the Plan. Employees who have completed one hour of service within 12 months and are at least 18 years of age are eligible for participation in the Plan and enter on the first day of the month. Additionally, employees become eligible for Employer contributions on January 1 or July 1 coincident with or next following the date they attain age 18 and complete one year of service with 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute pre-tax or after-tax (Roth) deferrals of compensation up to the limits provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year may make additional "catch-up" contributions. The Plan also allows for employees to make rollover contributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

The Employer makes Safe Harbor matching contributions on each participant's elective contributions equal to 100 percent of the first 3 percent of deferrals and 50 percent of the following 2 percent of eligible compensation contributed as deferrals, up to 5 percent of deferrals. During the year ended December 31, 2024, the Employer made a Safe Harbor matching contribution of \$416,943.

The Employer may make discretionary profit-sharing contributions allocated on an employee-by-employee basis in amounts determined by the Employer. Participants must be employed on the last day of the year to share in an allocation of Employer profit sharing contributions, except in instances of death, disability, or retirement. For 2024, the Employer made a profit-sharing contribution of 5 percent of each participant's eligible compensation. During the year ended December 31, 2024, the Employer made a profit-sharing contribution of \$801,581.

The Employer may also make discretionary matching contributions. No such contributions were made in 2024.

1. Plan Description, continued

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Employer's contributions, (b) the Plan's investment earnings or losses, and (c) certain Plan administration costs not paid by the Employer. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investments of their accounts between several investment alternatives available through the custodian, John Hancock Life Insurance Company, or self-directed brokerage accounts.

Vesting and Forfeitures

Participants are immediately vested in their elective deferral contributions and Safe Harbor contributions plus actual earnings thereon. Vesting in the discretionary Employer contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after four years of credited service on a graded vesting schedule of 25 percent per year. Unvested portions of account balances for participants who leave employment are forfeited. The Employer may elect to use all or a portion of forfeitures to pay Employer contributions and/or plan expenses. Total amounts forfeited during 2024 was \$27,361. During 2024, \$16,097 forfeitures were used to offset Employer contributions. Available forfeited unvested accounts at December 31, 2024 and 2023 totaled \$21,772 and \$10,508, respectively.

Payment of Benefits

In the event of termination of service, death, disability, or retirement, a participant (or their designated beneficiaries) may elect to receive all or a portion of their vested account balance. In-service distributions are available upon reaching the age of 59 ½ from all accounts. Hardship withdrawals are permitted from pre-tax deferral amounts on account of an immediate and heavy financial need of the participant, subject to the Plan's rules governing hardship withdrawals. Benefit payments are to be made in the form of a lump-sum equal to the vested balance of the participant's account. Partial or installment distributions are permitted for minimum required distributions.

Participant Loans

The Plan does not permit participants to take a loan from their account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions

Participant and employer contributions are recorded in the year in which participant contributions are withheld and underlying compensation is paid.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Expenses of maintaining the Plan are generally paid by the Employer and are therefore excluded from these financial statements. Certain custodial and recordkeeping fees or other related professional fees may be paid from Plan assets. Investment related expenses are included in net change in fair value of investments or as a deduction from investment income.

3. Information Certified by Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly John Hancock Life Insurance Company, acting as the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the year ended December 31, 2024:

4. Guaranteed Interest Accounts

The Plan has a guaranteed interest contract with a term of three years with John Hancock Life Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value, as reported to the Plan by John Hancock Life Insurance Company.

The guaranteed investment contract is not considered to be fully benefit-responsive and should accordingly be recorded at fair value. There are no reserves against fair value for credit risk of the contract issuer or otherwise. There is no minimum interest crediting rate stipulated in the contract. Interest rates are reviewed on a monthly basis for resetting.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer contributions.

6. Tax Status

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by Hershner Hunter LLP. The Internal Revenue Service (IRS) has informed the sponsor by an opinion letter dated November 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

Self-directed brokerage accounts: Comprised of cash equivalents, registered investments companies, and common stock. Valued at the closing prices on the active market on which the individual investments are traded.

Guaranteed interest accounts: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Risks and Uncertainties

The Plan provides for various investment options that have different investment strategies. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Related Party Transactions

Certain Plan investments are managed John Hancock Life Insurance Company (John Hancock), the custodian of the Plan, and therefore these transactions qualify as party-in-interest transactions. Administration fees paid directly to John Hancock for the year ended December 31, 2024, totaled \$34,421. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

10. Non-Exempt Transactions

For the year ended December 31, 2024, participant contributions totaling \$1,446, were not remitted to the Plan within the appropriate time period by the Employers. These transactions constitute prohibited transactions as defined by ERISA. The Employers are taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest.

11. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
